REPLY TO PRELIMINARY OBJECTION

That preliminary objections No.1 to 7 are denied being incorrect and misleading ones.

REPLY TO OBJECTION ON FACTS

That as Para No. 1 to 4 is admitted that the same is pertained to records hence needs no reply.

REPLY TO GROUNDS

1. That Para No. 1 needs no reply.
2. That Para No. 2 is denied for being incorrect and misleading one. The Appellant cannot even imagine misguiding this honourable tribunal. In fact the Salary Slip of the appellant before and after the regularisation is having one and the same wages type. (Copy of the pay slip for the year 2017 is annexed).

3. That Para No. 3 is correct to the extent that initially the appellant was appointed as driver (BP2-04) on contract basis as regular BP2 project employee and his service record & service book is maintained while rest of the Para is denied for being incorrect and misleading one. It is hereby worthy to mention that as per service rules and regulations the service record & service book of the appellant being a regular BP2 project employee prepared and kept maintained while the service record & service book of a project employee on fixed pay doesn't use to be prepared and maintained. Furthermore a project employee receives each year a 5% annual increase in his fixed monthly pay while the appellant being a regular BP2 project employee has received an annual increment on the basis of his BP2 once the incumbent government announce the same in the annual budget and when the incumbent government has not announce any annual increment in any annual budget then the appellant has not received the same in his BP2 for the said fiscal year.

4. That in reply to Para No. 4 it is submitted that the stance taken by the appellant in respect of office order No. FD (SOSR-1) 12-72014 dated Peshawar dated February 2014 and Finance Division Office Memorandum No. 7(9)R-12012 dated 31 May 2012 is correct while the stance of replying respondents is denied for being incorrect and misleading one. It is worthy to mention that the respondents have already

EXTENDED THE PROTECTION OF PAY, PENSION AND

SENIORITY to one **MR. SARNIAZ KHAN S/O MUNAIR KHAN** who was initially appointed as Naib Qasid in (BP2-01) on 29-07-1986 purely on temporary basis in the provincial Coordinated Cell for **WOMEN PROJECT** NWFP, P&D Department and then on 03-10-1996 appointed as Driver in (BP2-04) in the FAJA Section P&D Department vide office order No. 20(G) P&DD-387186 to 3-1096 (Details about Mr. Sarniaz Khan Appointments, Documents of His Salary, Service Record & Service Book, Seniority List, Pension and protection of pay extension are annexed).

2. That Para No. 2 is correct. It is worthy to mention that the respondent have extended the protection of pay, pension and seniority since 18-02-2006 on regularisation to one Mr. Jamshed Ali Khan now been retired and receiving his pension and to one Mr. Abid Noor who is still in service. (Copy of Notifications are annexed).

6. That in reply to Para No. 6 it is appreciated that the replying respondents have correctly admitted the stance of the appellant.

7. That Para No. 7 is denied for being incorrect and misleading one. As per service rules and regulation an employee cannot be demoted unless and until he is convicted for any misconduct etc. The appellant has been mistakenly demoted to deprive him of his seniority which is against the law and norms of justice. As already mentioned in the preceding paras that the respondents have already extended the protection of pay, pension and


seniority to one of their non gazetted temporary employee / Driver of the project and two Gazetted temporary employees of the project in accordance to law while in derogation of law and norms of justice have deprived the replying appellant of the same which said injustice needs to be cured in favour of the appellant.

8. That Para No.8 and 9 needs no reply.

It is therefore humbly prayed that considering the appeal of the appellant and the instant rejoinder the Office Order No. AC(B&A)P&DD/SNE OF FATA / 2022/115 Peshawar dated 16-10-2023 be set aside and the pay protection since the initial appointment be extended / granted to the appellant. Any other relief which this honourable tribunal deems just, fit and appropriate in the circumstance may also be granted in favour of the appellant.
