PRELIMINARY OBJECTIONS

- 1. That the appellant has no cause of action.
- 2. That the appellant has got no locus standi to file service appeal.
- 3. That the appellant has not come to this Honorable Court with clean hands rather than the instant appeal is mainly based on malafide intentions just to put pressure on the respondent department for illegal reinstatement.

ON FACTS

- 1- Correct. Para 1: Pertains to the record, requires no comments.
- 2- Incorrect. The appellant has just joined his duty, and after that, he has been absent from his duty since the date of appointment.
- 3- Incorrect. According to the report of the Assistant District Education Officer (Secondary), the appellant did not perform his duty regularly.
- 4- Show cause notice was issued to the appellant, but the reply was not satisfactory. Respondent No.3 constituted an inquiry committee against the appellant to find out the factual position of the case. The inquiry report is attached as **Annex "A".** According to the inquiry committee report, the appellant was called and given a chance for self-defense. A questionnaire was also served upon him. In his statement, he affirmed that he is a student of M-Phil, while government servants are not allowed to take admission as regular students without permission/NOC or leave, according to the Government Servants Conduct Rules 1987.
- A. Government servants should not, under any circumstances, be allowed to attend any classes or courses during office hours.

- B. Absence without leave, even for a single day, is misconduct and makes a civil servant liable to disciplinary action (No. S.RII (S&GAD) S(29)186 Vol:B dated 7 August 1993). After the recommendation of the inquiry committee, the appellant was once again called for a personal hearing, but he failed to attend.
- 5- Incorrect. The removal order from service was sent to his home address through the post office.
- 6- Incorrect. The appellant submitted a departmental appeal through the Directorate of Elementary & Secondary, and it was received by this office on September 14, 2023. A copy of the letter is attached as Annex "B".
- 7- The appellant has no cause of action to file instant appeal.

ON GROUNDS:

- A. Incorrect, the respondent is bound by rules and policy.
- B. Incorrect, proper inquiry was conducted and also called for personal hearing. (copies of inquiry report and the appellant statement are attached as Annex "C"
- C. As replied above.
- **D.** Incorrect, after fulfilling all the codal formalities the appellant was removed from his service.
- **E.** Incorrect, as replied in facts.
- **F.** Incorrect the penalty is commensurate with the misconduct.
- G. Legal. However, the respondent also seek leave of this Honorable Court to submit additional grounds, record & case law at the time of arguments on the date fixed in the titled case.

PRAYER

In view of the above made submission it is requested that this Tribunal may very graciously be pleased to dismiss the instant service appeal with cost in favor of the Respondent Department.

Facts Findings:

We the committee members called the concerned C.IVs to DEO office Khalf and gave them a chance for self-defense and served a questionnaire upon them. Their statements recorded according to their replies. Both C.IVs affirm that we are students of BS and M.Phil.

Mehran ud Din enrolled in BS on 2/9/2019. His degree will be completed in 2023 (Annex-1) while Imad ud Din is student of M.Phill and his course work started in 28/9/2020 and deny from dual job of Village Secretary.

Both of them affirmed that we are students of BS and M.Phill and we do not informed our Department nor taken departmental permission in this regard.

It is pertinent to mention that this act of C.IVs is dishonesty, fraud and illegal practice. Government servants are not allowed to take admission as regular students without taking permission/NOC or leave.

According to Government Servants Conduct Rules 1987;

- a. Government servants should not under any circumstances be allowed to attend any classes or courses during office hours.
- b. Absence without leave even for a single day is misconduct and makes civil servant liable to disciplinary action. No. S.R II (S&GAD) 5 (29)186 Vol B dated 7 August 1993.

Recommendations;

In the light of above facts findings both C.IVs are guilty of misconduct and absenteeism without prier departmental permission/ NOC/leave. So action may be taken against them under E&D Rules 2011, Rul. 4. (b) iii.
