#### **PRELIMINARY OBJECTIONS**

- 1 That the appellant has got no cause of action/locus standi to file instant appeal before this Honorable Tribunal.
- 2 That the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article 212 of the constitution of Islamic Republic of Pakistan 1973.
  - 3 That the appellant has concealed material facts from the ambit of this Honorable Tribunal in the titled appeal.
  - 4 That the appellant has not come to this Honorable Tribunal with clean hands.
  - 5 That the appeal in hand is based on mala fide intentions for gaining illegal service benefits from the Department for the grant of promotion to the post of STT in BS-16 TC in violation of the rules & Policy.
  - 6 That the appeal in hand is barred by law and limitation.
  - 7 That the appeal in hand is bad for mis-joinder and non-joinder of the necessary parties.
  - 8 That the appeal is not maintainable & even incompetent in the eyes of Law, Rules & Policy.
  - 9 That the Notification dated 12-06-2023 is legally competent & liable to be maintained in favor of the Department of being the result of due process of Law, Rules in vogue.
  - 10 That the appellant is not entitled for the grant of promotion w.e.f 20-02-2013 & has correctly promoted to the post of STT in BPS-16 vide Notification dated 12-06-2023 as per Law, Rules & Policy.

#### **ON FACTS**

- 1) That Para 1 is correct to the extent of the Notification No. (B&A)/1-18/E&SE/2012 dated 11-07-2012, whereby, the Govt: of KP has awarded up gradation at a ratio of 1/3rd of the total posts to different teaching cadres including the TT in BPS-15 to STT in BPS-16 w.e.f 01-07-2012 attached as Annex-A.
- 2) That Para-2 is incorrect & mis-leading on the grounds as per available record in the custody of the DEO (M) Bajour there were 73 sanctioned/vacant posts of TT (M) in BPS-15 & on the strength of which promotions were made in BPS-16 against the STT (M) post in BPS-16 on regular basis w.e.f 20-02-2013 by excluding the appellant due to the saturation of the sanctioned quota of 73 vacant post in District Bajour.
- 3) That Para 3 is correct.
- 4) That Para-4 is correct to the extent of the award of promotion to the TTs against the STTs in BPS-16 in view of the recommendation of the DPC meeting held on dated 17-03-2014 by the Department under the Law notified vide Notification dated 23-04-2014.
- 5) That Para-5 is incorrect & mis-leading on the grounds that there were 73 vacant posts of STT (M) in BPS-16 during the period of 2017 in District Bajour, whereupon, 73 TTs in BPS-15 were promoted to the post of STTs in BPS-16 vide Notification dated 10-02-2017 w.e.f 20-02-2013, wherein, the appellant was not promoted to the said post due to the observance & saturation of the total sanctioned 73 posts of STT in BPS-16 in District Bajour, therefore, in view of the letter dated 03-10-2014, the promotion order of the appellant dated 23-04-2014 was held in abeyance along with recovery of an amount drawn under the up graded pay mentioned in Para-2 of the Directorate of E&SE order dated 16-10-2014.

(Copies of the letter dated 03-10-2014 & Notification dated 10-02-2017 are Annex-B & C)

- 6) That Para 6 is pertains to the record of the SAFRON Division Govt; of Pakistan which is a Federal Body, whereas, the issue in question as agitated by the appellant before this Honorable Tribunal is a Provincial subject.
- 7) That Para-7 is correct that vide Notification dated 10-02-2017, whereby, 73 TTs in BPS-15 were promoted/up graded in BPS-16 against the STT (M) BPS-16 post on regular basis w.e.f 20-02-2013 by excluding the appellant in view of the saturation of the total 73 sanctioned posts in District Bajour.
- 8) That Para 8 is incorrect on the grounds that the appellant is not an aggrieved person within the meaning of Section 4 Khyber

Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973, as the act of the Department with regard to the Notifications dated 10-02-2017 & 12-06-2023 is within legal parameter as well as in view of the DPC recommendation.

- 9) That Para-9 is correct regarding processing the cases of TTs for their up gradation against the STT in BPS-16 posts for placing them before the DPC which was processed accordingly & resultantly vide Notification dated 12-06-2023, the appellant along with other TTs were up graded to the post of STTs in BPS-16 under the Rules already attached for ready reference.
- 10)That Para-10 is also correct to the extent of the Notification dated 12-06-2023, the appellant along with other TTs were up graded to the post of STTs in BPS-16 under the Rules already attached for ready reference.
- 11)That Para-11 is correct to the extent of filing an appeal dated 27-09-2023 against the Notification dated 12-06-2023 which is badly time barred under the relevant provision of Law, hence rejected vide order dated 27-09-2023 under the Rules by the Department.
- 12) That Para-12 is correct to the extent of rejection of Departmental Appeal dated 27-07-2023 vide order dated 29-07-2023 on merits of the case.
- 13) That Para-13 is incorrect as the appellant has got no cause of action to approach this Honorable tribunal in the titled appeal, hence the appeal in hand is liable to be dismissed on the following grounds inter alia:

#### ON GROUNDS

- A. <u>Incorrect & not admitted</u>. The appellant is not entitled for the grant of up gradation in BPS-16 against the STT (M) w.e.f 20-02-2013 & has correctly been up graded w.e.f 12-06-2023 by the Department in view of the available sanctioned posts of STT in District Bajour.
- B. <u>Incorrect & not admitted</u>. Strongly denied. The appellant has been treated as per Law & Rules by the Respondent Department in the titled appeal, wherein, he could not made out his case for up gradation as STT in view of the fore made submissions by the Department in the present reply.
- C. <u>Incorrect & not admitted</u>, the act of the Department with regard to the Notification dated 12-06-2023 is in accordance with the provision of Articles-4 & 25 of the constitution of 1973.

- D. <u>Incorrect & not admitted</u>, the act of the Respondents cannot be declared against the law on any ground whatsoever but require straight away rejection of Service Appeal in favor of the Department.
- E. <u>Incorrect & not admitted</u>, the plea of the appellant regarding up gradation w.e.f 20-02-2013 instead of 12-06-2023 as STT in BPS-16 is illegal, however, the Respondent Department is also seek leave of this honorable Tribunal to submit additional record, grounds & case law at the time of arguments.

#### PRAYER.

In view of the above made submissions, it is requested that this Tribunal may very graciously be pleased to dismiss the titled appeal in favor of the Respondent Department in the interest of justice.
