**JOINT PARA-WISE COMMENTS ON BEHALF OF RESPONDENT NO. 1 To 3.**

**Respectfully Sheweth: -**

**Preliminary Objections: -**

1. That the Appellant does not fall within the definition of an aggrieved person and has no locus standi to file the appeal in hand.
2. That the Appellant has got no cause of action to file the instant case.
3. That the Appellant is estopped by his own conduct to file the instant appeal.
4. That filing of this appeal is futile exercise and wastage of precious time of this Honorable Service Tribunal, liable to be dismissed forthwith.
5. That the instant appeal is barred by law and not maintainable.
6. That the appeal in hand is a time barred case by 12 years.
7. That the instant appeal is not maintainable in its present form.
8. That the instant appeal is bad for non-joinder and mis-joinder of necessary parties.
9. That the appellant has concealed material facts in the instant appeal.

**On Facts: -**

1. Para No.01 Pertains to record, no comments required.
2. Para No.02 Pertains to record, no comments required.
3. Para No.03 Pertains to record, no comments required.
4. Para No. 04 is correct to the extent that the appellant was regularized under the NWFP Regularization of Services Act 2009, w.e.f 31-12-2012, Notification of regularization dated 31-12-2012, is at (Annex-A), however the other regularized employees filed Service Appeal in the Hon'ble Khyber Pakhtunkhwa Service Tribunal Peshawar with the prayers that "to treat the Appellant as Regular from



6)

1<sup>st</sup> January, 2009 and to Release him the salary from 1<sup>st</sup> January, 2009 till the issuance of the Notification dated 31-12-2012, and accordingly determination of his seniority".

But the same was dismissed by the Hon'ble Tribunal that the appellant is regularized with immediate effect from 31-12-2012, under the NWFP Regularization of Services Act 2009, does not mean to be regularized from the date of Regularization Act as came into force on 24-10-2009. The seniority of all regularized employees including the appellant is determined as per the NWFP Regularization of Services Act 2009, under section 4 and sub section (2) clearly shows that in case of two or more than two employee in the same cadre the employee older in age shall rank senior to the younger one. Thus the seniority of appellant is fixed specifically according to prescribed rules mentioned in the NWFP Regularization of Services Act 2009 and law. (**Copy of Seniority list of Lecturer BPS-17 is enclosed as Annex-B.**)

**5. Para No.05 Pertains to record, no comments required.**

The Appellant is not an aggrieved person and has been rightly placed in the seniority list, in accordance with law. The Appellant bereft of any cause, legal grounds and standing before this Hon'able Tribunal, the whole premise of the Appellant's case is based on contradictions and falsifications.

**GROUND:-**

**A-** It is incorrect and misconceived. As the appellant was regularized under the NWFP Regularization of Services Act 2009 with immediate effect from 31-12-2012, as the appellant services are regularized under Regularization Act 2009, with immediate effect from 31-12-2012, means he will be placed in the Seniority list w.e.f 31-12-2012, according to his age. (**Already annexed-A).**

**B-** It is correct to the extent that the appellant was initially selected for a period of one year on contract basis which may be timely extended. Later on the appellant filed Writ petition in the Peshawar High Court, Peshawar and services of all the employees were regularized under the NWFP Regularization of Services Act 2009 with immediate effect from 31-12-2012. Seniority is always determined from the date of regular appointment as per regularization of Services Act 2009, or under seniority rules 17 (b).

**C-** The appellant and other selectee were initially selected for fixed period totally on contract basis. Contract services are never being counted as regular service. The advertisement clearly shows that all the selectee is engaged on contract basis. The plea of the appellant is baseless and has no right to be considered from the date of initial selection i.e contract basis.

The service of the appellant was regularized under the NWFP Regularization of Services Act 2009 with immediate effect from 31-12-2012, and he is placed in the seniority list according to the regularization Act.

- D- Already explained in detail in Para No.04 on facts.
- E- It is correct that the respondent No.03 has followed the order of the Peshawar High Court, Peshawar for implementation and the appellant services was regularized under the NWFP Regularization of Services Act 2009 with immediate effect from 31-12-2012. The order dated 08-03-2012 does not mean that the services of appellant will be regularize from the order dated, as the Court directed that the appellant will be regularize under the Regularization of Service Act, 2009.
- F- It is correct to the extent that plea of the appellant has already been resolved by placing him at his right position in the Seniority list from date of his regularization.
- G- Already explained in detail in Para E on Grounds.
- H- It is incorrect. The appellant was treated in accordance with law and rules, and has given right place in the seniority list. Proper committee was constituted to resolve the appeal and grievances of all the concerns in light of the established rules and law. The said seniority-list has rightly been issued keeping in view findings of the inquiry report and the laws on the said matter.
- I- It is incorrect. The Appellant has not been subjected to any ulterior motives, but instead the appellant has been treated in accordance with rules and law.
- J- It is incorrect. Every civil servant is properly placed in the Seniority list according to his seniority position; the same has been followed by the respondent No.03 and has been given right place to the appellant in seniority list. The appellant is treated in accordance with rules and law.

The respondents may also assist this hon'able court with additional grounds at the time of argument.

**Prayer:**

In view of the above submissions, it is humbly prayed that the Service Appeal in hand may graciously be dismissed with costs.





Terms and conditions of their Regular Appointment will be as under:-

- They will get pay at the minimum of DPS-17 including usual allowances as admissible under the rules. They will also be entitled to annual increments as per existing policy.
- They shall be governed by the Khyber Pakhtunkhwa, Civil Servants Act, 1973, all the laws applicable to the Civil Servants and rules made there-under.
- They shall for all intents and purposes, be Civil Servants except for purpose of pension & gratuity. In lieu of pension and gratuity, they shall be entitled to receive such amount as would be contributed by them towards Contributory Provident Fund(CPF) alongwith the contributions made by Government to their account in the said fund in the prescribed manner.
- Their employments in the department are purely temporary and their services are liable to be terminated without assigning any reason, at thirty(30)-days notice or on the payment of 30-days salary in lieu thereof. In case they wish to resign at any time, 30-days notice will be necessary or in lieu thereof 30-days pay will be forfeited.
- They shall, initially, be on probation for a period of two years extendable upto 3-years.
- Their seniority shall be determined in accordance with relevant rules but subject to section-4 of the Khyber Pakhtunkhwa Employees (Regularization of Services) Act, 2009.

### THE NORTH-WEST FRONTIER PROVINCE EMPLOYEES (REGULARIZATION OF SERVICES) ACT, 2009.

#### NOTIFICATION

Dated Peshawar the 24<sup>th</sup> October, 2009.

K.A.PA/NWFP/Bills/2009/38472.—The North-West Frontier Province Employees (Regularization of Services) Bill, 2009 having been passed by the Provincial Assembly of North-West Frontier Province on 15<sup>th</sup> October, 2009 and assented to by the Governor of the North-West Frontier Province on 20<sup>th</sup> October, 2009 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

#### THE NORTH-WEST FRONTIER PROVINCE EMPLOYEES (REGULARIZATION OF SERVICES) ACT, 2009 (N.W.F.P. ACT NO. XVI OF 2009)

*(First published after having received the assent of the Governor of the*

~~North-West Frontier Province~~ in the Gazette of the N.W.F.P. (Extraordinary).

Dated the 24<sup>th</sup> October, 2009).

#### AN ACT

*to provide for the regularization of the services of certain employees appointed on adhoc or contract basis.*

Preamble. --- WHEREAS it is expedient to provide for the regularization of the services of certain employees appointed on adhoc or contract basis, in the public interest, for the purposes hereinafter appearing:

It is hereby enacted as follows:-

1. **Short title and commencement.** --- (1) This Act may be called the North-West Frontier Province Employees (Regularization of Services) Act, 2009.

(2) It shall come into force at once and shall be deemed to have been taken effect at the promulgation of the Ordinance.

2. **Definitions.** --- (1) In this Act, unless the context otherwise requires,-

(a) "Commission" means the North-West Frontier Province Public Service Commission;

(aa) "contract appointment" means appointment of a duly qualified person made otherwise than in accordance with the prescribed method of recruitment;

(b) "employee" means an adhoc or a contract employee appointed by Government on adhoc or contract basis or second shift/night shift but does not include the employees for project post or appointed on work charge basis or who are paid out of contingencies;

(c) "Government" means the Government of the North-West Frontier Province;

- (d) "Government Department" means any department constituted under rule 3 of the North-West Frontier Province Government Rules of Business, 1985;
- (e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and
- (f) "post" means a post under Government or in connection with the affairs of Government to be filled in on the recommendation of the Commission.
- (2) The expressions "ad hoc appointment" and "civil servant" shall have the same meanings as respectively assigned to them in the North-West Frontier Province Civil Servants Act, 1973 (N.W.F.P. Act No. XVIII of 1973).

3. Regularization of services of certain employees.—All employees including recommendees of the High Court appointed on contract or ad hoc basis and holding that post on 31<sup>st</sup> December, 2008 or till the commencement of this Act shall be deemed to have been validly appointed on regular basis having the same qualification and experience for a regular post:

Provided that the service promotion quota of all service cadres shall not be affected.

4. Determination of seniority.—(1) The employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

(2) The seniority *inter se* of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officialion in such service or cadre:

Provided that if the date of continuous officialion in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

4A. Overriding effect.—Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of inconsistency to this Act shall cease to have effect.

5. Repeal.—The North-West Frontier Province Employees (Regularization of Services) Ordinance, 2009 (N.W.F.P. Ordinance No. VII of 2009) is hereby repealed.




