

MINUTES OF THE SSRC MEETING HELD ON 03/01/2017 UNDER THE
CHAIRMANSHIP OF SECRETARY AGRICULTURE

2. A

A meeting of the SSRC was held under the chairmanship of Secretary Agriculture, Livestock & Cooperatives Department in the committee room on 03/01/2017 at 11.00 AM to discuss the observation raised by the Public Service Commission on the minutes of the previous SSRC meeting for amendments/additions in the existing service Rules of Livestock & Dairy Development (Extension), Livestock & Dairy Development (Research) and Fisheries departments (ANNEX-I, II, III). All the members of the committee attended the meeting (list of participants attached) except representative of Law department, who absented himself on the plea that their representative may be exempted from the committee. The observations were considered one by one. Necessary changes as pointed out by the Public Service Commission have been made in the proposed service rules of the above departments i.e Livestock & Dairy Development (Extension) (APPENDIX-I), Livestock & Dairy Development (Research) (APPENDIX-II); and Fisheries departments (APPENDIX-III) wherever deemed appropriate. Clarification to the certain points is as follows:

As per circular letter of the Establishment department, Senior Management Course was required for promotion to the posts in BS-20 was discussed and the DS (R-II) Establishment department suggested incorporation of the Senior Management Course as mandatory for promotion to BS-20 in both the Livestock & Dairy Development (Extension & Research) wings. The matter was discussed at length and the chair disagreed with the contention of the Establishment department for undertaking SMC being technical officers and decided that technical/ professional officers are exempted. However as per observations of the Public Service Commission, the method of appointment against the BS-20 posts was decided to be "on the basis of seniority cum fitness".

vii. **Senior Veterinary Assistant/Female Livestock Supervisor.**


Previously the Female Livestock Supervisor were initially recruited in BPS-11 against the ADB funded project and the same posts were converted to the regular budget side and the incumbents were regularized against these posts under the Regularization Act, 2009, while the Senior Veterinary Assistant were in BPS-09. In wake of grant of service structure to the Para-veterinary Staff of the department, the post of Senior Veterinary Assistant was upgraded to BPS-11, so the Senior Veterinary Assistant and Female Livestock Supervisor were merged as the females have no separate cadre and they will be recruited as Veterinary Assistant (BS-09) as per Rules of Government of Khyber Pakhtunkhwa.


viii. Previously there was no lower tier of the post of Laboratory Technician, so it was to be filled by direct recruitment but now posts of Laboratory Assistants have been created to feed the higher pay scale post of Laboratory Technician, therefore the same has to be filled in by promotion of the Laboratory Assistants.


