para-wise comments are as under:

Preliminary Objections: -

- 1. The appellant has neither cause of action nor locus standi to file the instant appeal hence the same being outright untenable is liable to be dismissed.
- 2. That the appellant has been guilty of concealment of material facts, hence the appeal in hand cannot further be proceeded.
- 3. That appeal in hand is also incompetent on account of non-joinder of necessary parties who are likely to be affected in case the prayer of the appellant is granted.

ON FACTS:

- 1. Para No. 1 is admitted and correct.
- 2. Para No. 2 is correct as per the then seniority list issued accordingly.
- 3. Para No. 3 is correct.
- 4. Para No. is correct.



- Para No. 5 is denied as the promotions were granted to the officials after considering service record and special reference to the principle of "seniority-cum-fitness basis" and vide meeting minutes it is clearly mentioned that "Mr. Imtiaz Hussain Junior Clerk (BPS-11) appearing on Serial No. 02 of working paper has been considered for promotion to the post of Senior Clerk (BPS-14). On recourse to the principle of Seniority cum fitness, he was not found suitable and fit for promotion". (Copy of meeting minutes are annexure "A").
- 6. Para No 6 is denied as the appellant was deferred due to ACR of 2019 containing adverse remarks regarding the appellant and the same was communicated to the appellant vide this office letter No. 991/DSJ/ Kurram dated 21/07/2020 clearly depicting the remarks of the reporting officer duly agreed upon by the countersigning officer. (Copy of letter is Annexure "B").

Para No. 7 is correct to the extent that an ACR of the appellant was misplaced and an inquiry was conducted. The Superintendent was issued warning after conducting proper inquiry. However, the claim of the appellant regarding lost ACR being satisfactory is fictious as no proof of the claim is available. It is correct that the appellant was awarded appreciation certificates later on after his performance improved.

8. Para No 8 is incorrect as the adverse remarks in ACR of 2019 could not be ignored.

- 9. Para No.9 is correct to the extent that in ACR, 2021 of Mr. Gul Zaman, the reporting officer considered him as not fit for promotion, however, no adverse remarks were reported.
- 10. Para No. 10 is correct as the same is pending before the DPC and will be decided when the DPC is constituted for next promotion in due course of time as provided under rules ibid.
- 11. No comments.

GROUNDS:

- a) The impugned order is neither arbitrary, discriminatory and perverse nor against the law & rules and the same is based on cogent and convincing grounds.
- b) The order passed by the respondents is in accordance with principle of Seniority cum fitness basis, hence denied.
- c) The order of respondents is based on cogent reasons and grounds.
- d) The order of the respondents is based on thorough perusal of ACRs and working papers by the Departmental Promotion Committee as laid down in relevant rules.
- e) As above.

- h) That the appeal is not maintainable. Apart from the above, it is apt to mention that in meeting of departmental promotion committee held on 21.05.2022 the appellant was considered for promotion along with other candidates but one ACR out of last three ACRs of the





appellant/official was adverse, hence, promotion was deferred to the appellant.

i) No comments.

In light of above, it is submitted that the impugned order dated 21.05.2022 is based on cogent and convincing grounds; therefore, it is humbly prayed that appeal of the appellant may kindly be dismissed with cost, being meritless.



Similarly, promotion criteria for Daftari & Record lifter (BPS-04) was followed as mentioned in Judicial Esta Code Revised 2021 on page No. 468, para 21 & 22 respectively.

A tentative Seniority list of all the officials was issued vide this Office Letter No. 1816/DSJ/ Kurram dated 27/07/2021, which was circulated amongst the all and asking them to file objections/grievances, if any, within 14 days. One Junior Clerk namely Mr. Fazal Haq filed and put up an application regarding his merit, and the same was put up before the local DPC Committee and was decided by the Committee vide Office Order No. 1837/DSJ/Kurram, dated 30/08/2021.
