CAPTION OF INQUIRY	The Inquiry was initiated in the light of the Judgement of Honorable Service Tribunal Khyber Pakhtunkhawa Peshawar dated 29-02-2024 in service appeal No 7209-21 titled as "istifanosh Khan Vs. Government of Khyber Pakhtunkhawa" regarding the payment of pensionary benefit on the basis of retirement on Medical ground on 20-09-1983.

5 - BRIEF HISTORY OF THE CASE	The committee is directed to be provide complete report the following matter as. <ol style="list-style-type: none">1. The appellant was appointed as PST on 15-09-1966 in education department.2. Whereas the appellant claimed that he was retired on Medical ground on 20-09-1983.3. Whereas the appellant claimed that after the retirement on medical ground the pensionary benefit was not provided to him by the concerned District Account Offices.4. Whereas the appellant further submitted that he had submitted many applications to the respondent No 3 i.e. DEO Male Battagram regarding the provision of Pensionary benefits but in vain.5. Whereas he filed service appeal No 7209/2021 titled as "istifanosh Khan Vs. Government of Khyber Pakhtunkhawa" vide dairy No 7427 on 09-08-2021 before the honorable Service tribunal Khyber Pakhtunkhawa Peshawar.6. Whereas the honorable Service Tribunal passed the order dated 29-02-2024 with the direction that the DAO Battagram would also coordinate with DEO (M) Mansehra and after submission of papers DAO Mansehra will verify whether any pension was released after retirement of the appellant, if so,



	<p>the appellant would be informed and in case the pension was not released to the appellant, the case of pension would be processed and he would be paid according to his entitlement as early as possible but not later than Two months. Disposed of accordingly.</p>
<p>6. PROCEDURE</p>	<p>The inquiry was initiated under the direction DEO Male Mansehra vide No 3097 dated 25-03-2024, in the light of the Judgement of Honorable Service Tribunal Khyber Pakhtunkhawa Peshawar dated 29-02-2024 in service appeal No 7209-21 titled as "istifanosh Khan Vs. Government of Khyber Pakhtunkhawa" regarding the payment of pensionary benefit on the basis of retirement on Medical ground on 20-09-1983.</p> <p>In compliance with the order of DEO Male Mansehra both the officers visited the office of the SDEO Male Battagram on 29-04-2024 to probe the matter and for the collection of record regarding the instant case. Furthermore the appellant was also called for personal appearance before the inquiry committee, which he did accordingly. The questionnaire was served to the appellant and he reply of that questionnaire accordingly along with supporting documents. In the same way the record was also provided by the SDEO Male Battagram regarding the instant case.</p> <p>Furthermore, the inquiry officer forwarded the letter vide Endst: No 2015 dated 29-04-2024 as well as letter No 4059 dated 10-05-2024 to the District Account Officer Mansehra for verification whether the pensionary benefit has already been paid to the appellant or not (ANNEXURE C&D). Also the inquiry officer forwarded the letter to the Director General health Service Khyber Pakhtunkhawa Peshawar regarding verification of Medical board of the appellant vide letter No 2015 dated 29-04-2024 as well as letter No 4060 dated 10-05-2024, but still awaited. Furthermore, the inquiry officer also forwarded the letter to the Medical Superintendent DHQ Abbottabad where the Medical Board of the appellant was held vide letter No 2077 dated 29-04-2024 (ANNEXURE E) as well as letter No. 4057 dated 10-05-2024 for the provision of record and remarks of the Medical Board, which are still awaited. The inquiry committee also submitted a letter to DEO (M) Battagram vide letter No.501 dated:27/07/2024 and whereupon the reply of the said letter was received to inquiry committee vide letter No.7901 dated:31/07/2024(ANEX-F), whereupon the DEO (M) Battagram deliberately denied the verification with regard to the medical ground and stated that the matter is related to the DEO (M) Mansehra as there is no record exist in the said office and in the same context the inquiry committee also sent letter vide No.500 dated:20/07/2024 to SDEO (M) Battagram (ANNEXURE-G), in response of the said letter the SDEO (M) Battagram replied vide letter No.756 dated:31/07/2024 wherein he stated that the district Battagram was established in 1994 and retirement sanction of Mr.</p>

	<p>Istifianosh may be verified from district Mansehra as there is no record exist before the establishment of District Battagram. (ANEX-H)</p> <ul style="list-style-type: none"> ➤ The undersigned endorsed copy of letter No.138 dated:17/02/2024 to DEO (M) Mansehra (ANEX-I) for verification of following 02 documents: <ul style="list-style-type: none"> I. Retirement Sanction Order No.787-89 dated:20/09/1983. II. Number Nil and from Director General Health Services to DEO (M) Mansehra to appear before DHQ Hospital Abbottabad but the same are still not verified by the DEO (M) Mansehra. (ANEX-J and K) ➤ Mr. Sami Ullah PST S/O Mr. Istifanosh Khan has been appointed as PST under deceased son quota and not on medical grounds under Endst: No.1344-49 dated:05/12/2022/ 05/03/2022 (copy attached as (ANEX-L&M)) inspite of the fact that Mr. Istifanosh Khan has not died and is still alive. ➤ Also to clarify that the deceased policy rules are made in 1989 while Mr. Istifanosh Khan has alleged his duty upto 1983. ➤ Also to clarify that rules for retirement on medical grounds are made in 2016 while the father of Mr. Sami Ullah (Istifanosh Khan) has worked upto 1983. ➤ Entry of retirement in service book on the basis of medical ground is markedly varying and is markedly bright as compared to other writing on the relevant pages which makes this retirement doubtful. ➤ All documents available with Service book are photocopies while original documents are not found. ➤ Medical board documents are not available, only call letter which is without number and date from Director General Health Services to DEO (M) Mansehra to appear for medical board while any recommendations for fitness is not available (copy attached as ANEX-K) ➤ Claim of pension is badly time barred that after 40 years. ➤ Application with regard to the retirement on medical ground could not be found in any concerned office i.e DEO (M) Mansehra and DEO (M) Battagram. ➤ Also to clarify that no medical record that any investigation, laboratory reports, Doctor's prescriptions are not available.

CROSS EXAMINATION</p>	<p>The questionnaire was served to the appellant (ANNEXURE-N (p-1,2)) and the reply of the questionnaire received (ANNEXURE-O (p-1,2)) and he failed to provide any authentic supporting document to the Inquiry Committee in the instant case.</p>

<p>8. FACTS/ FINDINGS</p>	<p>Brief facts of the instant case are as under:-</p> <ol style="list-style-type: none"> 1. In response of the letter No 3097 dated 25-03-2023 the SDEO Male Battagram provided the following record these these record including Service Book of the appellant alongwith other service record as well as different correspondence between the DEO Male Battagram & SDEO Male Battagram. The original service book was also found from the office of the SDEO Male Battagram. 2. For further verification of the retirement order and payment of pension benefits, the letters were issued to the District Account Officer Mansehra but no response yet received. Furthermore the letter issued to the DG Health Services Peshawar and MS DHQ Abbottabad for the provision of the opinion of the Medical Board dated 20-09-1983 which are still awaited. 3. No record of the appellant was found in the office of the DEO Male Mansehra regarding the retirement order on Medical ground basis as well as pensionary benefits. 4. The appellant has failed to provide the genuine documents regarding his Medical ground retirement and other service record.
<p>9. CONCLUSION</p>	<p>On the basis of above it is concluded that:-</p> <ol style="list-style-type: none"> i. No original record was found regarding the retirement on Medical ground as well as pensionary benefits in the light of the letters forwarded to different offices, and without original record the Committee is unable to decide any decision after the lapse of 40 years regarding pensionary benefits.
<p>10- RECOMMENDATIONS</p>	<p>In the light of above facts and circumstances of the case, the appellant/Ex-PST is not eligible/entitled for any kind of pensionary benefits.</p>







With due respect it is stated that cited above subject is clarified on the following grounds:

1. Reference to the letter No 76, dated 29-01-2024, the said PST was asked to clarify his position and appear in person before the undersigned on dated 06-02-2024 along with complete documents but he failed to appear.
2. As per order of service tribunal, his father Mr. Istefanosh Khan was asked to provide all the relevant documents for processing his pension case to DEO (M) Mansehra, but unfortunately he failed to appear and providing documents.
3. Mr. Istefanosh Khan is claiming that, he has been retired from service on medical grounds and his son Mr. Sami Ullah is appointed as PST on the basis of Son quota retirement on medical grounds, but on the other side it is crystal clear from the appointment order of his son Mr. Sami Ullah having No 1344-49, dated 05-12-2022, that is wording "UNDER DECEASED QUOTA" and not on medical grounds.
Also to clarify that Deceased policy rules are made in 1989, while Mr. Istefanosh Khan has worked upto 1983.
Also to clarify that rules for retirement quota on medical grounds are made in 2016, while father of Sami Ullah, Mr. Istefanosh Khan has worked upto 1983.
4. Entry of retirement in service book on the basis of medical ground is vary and markedly bright-as appeared to other writing on the relevant pages which make this retirement doubtful.
5. All documents available with service book are Photostat copies while original documents are not found.
6. Medical board documents are not available only call letter which is without No and date from Directorate General Health services to DEO (M) Mansehra to appear for medical board while any recommendations for fitness are not available.
7. On retirement sanction letter No 787-89, dated 20-09-1983, He is retired and written as under rules 20 of NWFP revised leave rules 1981.
So in the stated above circumstances is concluded that the whole process look like as doubtful and fake, therefore it is requested to conduct fact finding inquiry for clarification and further necessary actions please.


