notification dated 08.12.2021 on record from notification dated 08.12.2021, it is to established that date of regular appointment of the three promotees is 01.07.1997 as PHST while appellant was promoted as PHST on 26.02.2014, which means that she is junior to all the three promotees of above mentioned notification dated 08.12.2021.

- Learned council for the appellant referred to condition No. 4 of her 10. promotion order dated 26.02.2014 which is "their inter se seniority on lower post will remain intact." This is of no help to the appellant as she failed to established on record that in lower post PST all the three promotees were junior to her and upon promotion as PHST appellant will regain his seniority position being batch mates of these three promotees of order dated 08.12.2021.
- For what has been discussed above, we find no merit in the service 11. appeal in hand, hence dismissed. Costs shall follow the event. Consign.

- 6. Perusal of record reveals that appellant through instant appeal seeks antedation of her promotion order dated 26.02.2020 to the date, when her juniors were promoted and challenged promotion order of other teachers PST to SST (BPS-16) dated 8.12.2021
- 7. Appellant filed instant service appeal under section 4 of Khyber Pakhtunkhwa service Tribunal ACT 1994 which reads as:

"Any civil servant aggrieved by any final order, whether original or appellate, made by a departmental authority in respect of any of the terms and conditions of his service may, within thirty days of the communication of such order to him, prefer an appeal of the appeal having jurisdiction in the matter"

- 8. Appellant had not filed departmental appeal against order dated 26.02.2014 to her appellate authority within thirty days of its passing for antedating it, moreover, she had not mentioned any specific order with number or date nor any junior official who was promoted before appellate as PST, beside she actualized her promotion immediately after order dated 20.02.2014, so now she is estopped by her conduct to seek antedation for her promotion.
- 9. Appellant also challenged promotion notification dated 08.12.2021 vide which three PHST were promoted to post of SST(G) (BPS-16) on the ground that she being senior to them was entitled for promotion. She had not annexed any seniority list or any other document from which factum of seniority of the appellant can be determined as compare to all the three promotees of

no.3, and not promoted petitioner due to senior teacher, petitioner is entitle for promotion against the post of PST (BPS-15) with effect from when junior teacher where promoted and also promote against the post of set (BPS-16) from the date when junior teacher were promoted as set with all back benefits, any other relief which this honourable tribunal deem fit and appropriate given to the petitioner."

- 2. Brief facts of the case are that appellant was appointed as Primary School Teacher vide order dated 03.08.1986. She passed her Primary Teaching Certificate (PTC) in the year 1992 and B.A in 2013. She was promoted to the post of PSHT (BPS-15) vide notification dated 26.02.2014. On 08.12.2021 respondents promoted juniors to the appellant to the post of SST, but she was ignored. Feeling aggrieved she filed departmental appeal on 10.02.2022, which was not responded, hence the instant service appeal.
- 3. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 4. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.
- 5. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order(s).

RASHIDA BANO, MEMBER (J): The instant appealinstituted under section 4 of the Khyber Pakhtunkhwa Service Tribunal, Act 1974 with the prayer copied as below:
