at serial No.31 of the appointment notification dated 09.12.2009 in accordance with her merit position assigned by the Public Service Commission but when seniority list issued on 31.11.2019 of her cadre she was wrongly placed at serial No.291 rectification of which she seeks from this Tribunal through instant appeal.

09.12.2009 is dated contended order that Respondents 7. adjustment/posting order of the Subject Specialist of various subjects and not inter se seniority allotted by the Public Service Commission on the basis of merit order assigned to them. Perusal of notification dated 09.12.2022 reveals that it is appointment/posting order of the Subjects Specialist of various subjects wherein appellant name was mentioned at serial No.31 of the same, but nowhere it is mentioned that Subject Specialist were appointed in order of merit or on the basis of merit assigned to them by Public Service Commission in accordance with Section 8 of the Khyber Pakhtunkhwa, Civil Servants Act, 1973 which read as under;

"seniority of the civil servant in cadre will be determine on the basis of merit to them by the Public Service Commission."

In the instant case respondent were directed to produce merit order/list issued by the Public Service Commission for the purpose of determination inter se seniority of selectees of 2009 batch of Subject Specialist, which they produced along with covering letter dated 04.03.2019.

8. Perusal of merit list of Female Subject Specialist (BPS-17) selectee in consequence of advertisement No.1/2009 for the purpose of determining inter se seniority of them, reveals that appellant was assigned merit order

remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant."

- 2. Brief facts of the case are that the appellant was appointed as Subject Specialist (BPS-17) Pakistan Studies upon the recommendation of Khyber Pakhtunkhwa Public Service Commission vide notification dated 09.12.2009 and was placed at Serial No. 31. On 31.01.2019 respondents issued seniority list wherein private respondents were made senior to the appellant. Feeling aggrieved from the impugned seniority list, he filed departmental appeal, which was not responded to, hence the instant service appeal.
- 3. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 4. We have heard learned counsel for the appellants and learned Deputy District Attorney for the respondents.
- 5. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order(s).
- 6. Perusal of record reveals that appellant was appointed as Subject Specialist (S.S) (BPS-17) in Pak Study consequent upon recommendations of Khyber Pakhtunkhwa Public Service Commission vide notification dated 09.12.2009. It is the contention of the appellant that she was placed
