- 1. That appellant was appointed as constable (BPS 05) at Police Training. College Hangu by the Commandant Police Training College Hangu on the existing vacancy vide the order dated OB NO 592 dated 12/10/2000. (Copy of Appointment Order is attached as Annexure 'A')
- 2. That appellant has successfully completed his Drill Instructor Course in the year 2002 and spending more than three year as Drill Instructor on the basis whereof he was selected for lower school course under police rules 19.22 by the Commandant Police Training College Hangu vide order dated 19/09/2006 and the same has been successfully completed vide notification dated 30/03/2007 wherein the name of appellant is at serial No 64. (Copy of History Sheets of the Drill Instructor selection and notification dated 30/03/2007 are attached as Annexure 'B' & "C &

C-I'Re submitted to day and it wil.



- 3. That on completion of Drill Course and Lower School Course appellant has been promoted to the rank of Head Constable vide order dated 24/05/2007 and thereafter his name was sent for intermediate course on his merit position by the competent authority and he completed the same vide notification dated 06/11/2010 at serial No 72. (Copy of the promotion order and notification are attached as Annexure "D" & "E")
- 4. That appellant filed an application for transfer of LIEN to his parent District Kohat but the same has been refused therefore he filed application before the Competent Authority for transfer of his LIEN to District Swat as there was no rule regarding further promotion in PTC Hangu and accordingly his application has been accepted by the respondent No 01 vide order dated 10/06/2014 with direction that appellant will be placed at the bottom of the seniority list of the head constables of District Police Swat. (Copy of the orders is attached as Annexure "F")
- 5. That thereafter the appellant was placed at the bottom of the seniority list of head constable of district swat and vide order dated 25/01/2016 he was promoted as Assistant Sub Inspector on his own turn and the name of appellantwas placed at serial No 43 of the promotion list and has been confirmed vide order dated 01/08/2019. (Copy of orders are attached as Annexure "G" & "G-I")
- That respondent No. 2 vide order dated 20/12/2023 issued list for 6. promotion of ASIs on list "E" wherein the name of appellant was missing and accordingly appellant filed an application dated 27/12/2023 before the worthy respondent No 03 who forwarded the same before the worthy respondent No 02 who vide Impugned order dated 26/06/2024 decided against the petitioner. The same order has not only decided the application of appellant but also certain other issued discussed and order for the detachment of the Lien from District Swat, to his parent District Karak, Kohat region with further order for fixation of his seniority with the colleagues of his domicile District. Through the Impugned order the appellantalso came to know regarding the passing of another order Endst No 3559-62/E dated 14/03/2023 vide which the regular promotion order of the appellant dated 13/09/2006 has been illegally withdrawn and that too by incompetent person and the same order has never been communicated to the petitioner. (Copy of both the impugned orders are attached as Annexure "H", "I" & "J")

That thereafter appellant approached office of CCPO Peshawar regarding the Attested copies of the impugned orders but only copies have been provided on 09/07/2024 and other relevant documents has been provided to the appellant perusal whereof it was transpired that the appellant promotions has been declared as out of turn promotions which is totally illegal, against the rules and comes under the ambit of colorful exercise of power and authority, hence, the appellant having no other remedy being aggrieved and dissatisfied by the actions and inactions, misuse of power, illegality & irregularity, mala fide and excess of power of the respondents seek the indulgence of this Hon'ble Tribunal on the following amongst other grounds:

GROUNDS:

- A) That respondent have not treated the appellant in accordance with law, rules and policy laid down, the appellant has gain promotion in accordance to rules and regulations and the respondents has illegally term the same as out of turn promotion which is totally against the rules and regulations.
- B) That appellant vide proper order transferred to district police swat and has been place at the bottom of the seniority list of head constables of district police swat and earned his promotion in accordance with law on his own merit position.
- C) That appellant has clear his intermediate course and all other courses required for promotion but the actions of respondents by declaring petitioner's promotion as head constable vide order dated 13/09/2006 as out of turn promotion is totally illegal against the rules and regulations.
- D) That it is very much evident from the order dated 19/09/2006 that appellant has been selected for lower school course on the basis of police rules 19.22. The said rule are very much clear that appellant been drill instructor has been selected for the said course.
- E) That the impugned order dated 14/03/2023 has not been passed by the competent authority neither taken into consideration the observations endorsed by the worthy Commandant PTC Hangu vide letter dated 19/01/2024 which clearly suggest that the case of appellant does not come in the category of out of turn promotion cases.

Ã

- F) That exclusion of the name of the appellant on the basis of alleged out of turn promotion to the rank of Offg: Sub-inspector and his rights secured and guaranteed under the Constitution have been violated.
- G) That Public functionaries were obliged to act in accordance with law which is the mandate of the Constitution under Article 5 (2), therefore, the respondents have wrongly denied the due rights of appellant for promotion to the rank of Offg: Sub-inspector on flimsy grounds.
- H) That respondent No. 2 vide order dated 10/06/2014 transfer the lien of appellant to Swat instead of his own district Karak, Kohat region by placing him at the bottom of the seniority list of head constable and appellant has spend more than 10 years in District Swat and now by detaching his lien will effect his whole career. It is pertinent to mention here that appellant was appointee of Training School Hangu and not of the Kohat region police.
- I) That respondents are legally bound to place the name of appellant on the relevant list on his merit position and thus liable to be promote as per policy and rules, appellant is entitled to be treated equally without any discrimination / nepotism.
- J) That the impugned order dated 26/06/2024 has not only decided the issue of appellant regarding the exclusion of his name from the promotion list but also passed the impugned order regarding other issue which with due respect out side the scope of departmental authority.
- K) That the name of Appellant has been excluded by respondent No. 2 and under the law he was required to send the application / departmental appeal to Learned respondent No. 1 but contrary to the above the same has been decided by respondent No. 2 by himself.
- L) That because the impugned actions and inaction are blatantly against all norms of justice and principles of reasonability based on discrimination.
- M) That appellant also seek permission of this Hon'ble Court to agitate any other grounds at the time of arguments.



It is, therefore, most humbly prayed that on accepting this service appeal, the impugned orders dated 20/12/2023 and 26/06/2024 may graciously be set aside by declaring it illegal, unlawful, without authority, based on mala fide, void abinatio, against the seniority and promotion rules, regulation and policy and thus not sustainable in the eyes of law and appellant is entitled for placement on the promotion of ASIs on list "E" to the rank of Offg: SIs and is entitled for promotion along with his other Colleague and if during the pendency of this appeal his Colleague or Junior are promoted then he is entitled to be promoted from the date his other colleague / junior were promoted with all back benefit of pay and service with all consequential benefits of pay and service.

## ORDER:

Suo-Moto contempt proceedings vide Crl.O. Petition No.38/2021 and in pursuance of Judgments passed by SCMR 456, 2016 SCMR 1254, 2017 SCMR 206, 2018 SCMR 1752, Civil Review Petition No. 193/2003 reported in 2015 Civil Petitions No. 1996, 2026, 2431, 2437 to 2450, 2501 and 2502 of 2019 on issues of Out of Turn Promotions, all Unit Heads, Regional Police Officers and District Police Officers of Khyber Pakhtunkhwa Police were directed vide CPO, Peshawar letter No.CPO/CPB/75, dated 14/02/2023, to ensure compliance of above mentioned Orders in letter and spirit. Accordingly, all Out of Turn Promotions granted to Police personnel either on gallantry or otherwise belonging to different Units, Regions & District have been withdrawn by the concerned authorities and consequently their seniority has been re-fixed along with their Batch-mates who were promoted during their intervening period by maintaining original inter-se-seniority.

- 2. In view of the above, case regarding Out of Turn Promotion of ASI Zahid Iqbal No. 90/M of Swat District was examined. As per detail of this office, he has passed A-1 exam, however, did not qualified B-1 exam. He served for three years at PTC Hangu as Drill instructor as per PR 19.22, on the basis of which he was selected for Lower College Course vide PTC Hangu OB No. 407, dated 13/09/20006. Subsequently, qualified Lower College Course during the term ending 20/03/2007 vide PTC Hangu Notification No. 744 dated 30/03/2007 and also qualified Intermediate College Course during the term ending 20/09/2010 vide PTC Hangu Notification No. 2110/S, dated 06/11/2010, his lien was later on transferred from PTC Hangu to Swat District. Withdrawal of above mentioned Out of Turn Promotion shall bring his name with his colleagues at PTC, Hangu.
- 3. In a Judgment of Honorable Supreme Court of Pukistan 1998 SCMR 2013 titled Siddiq Akbar ASI & Others VS Sanobar Khan ASI, Supreme Court of Pakistan declared Standing Order bearing No. 11/87 issued on 17th January, 1987 by the then IGP, NWFP as without any lawful authority and of no legal effect. Same Standing Order was issued for grant of incentive based accelerated promotions to Police Officials / Officers serving as Cadet Instructor with Police Training Institutes.

The Operating Para No. 8 and 9 of same Judgment are being reproduced as under:-

- 8. We are, therefore of the considered opinion that word "approval" occurring in section-12 of the Act implied the act of passing judgment, the use of discretion, and a determination as a deduction therefrom, to confirm, ratify, sanction or to consent to some act or thing done by the Inspector General of Police. The word 'approval' implies exercise of sound judgment, practical sagacity, wise discretion and final direct affirmative action. Merely because the impugned Standing Order has held the ground for a number of years is not sufficient to assume the grant of 'approval' of the issuance of Standing Order by the Provincial Government.
- 9. We have, therefore, no hesitation to hold that the Standing Order No. 11 issued by the Inspector General of Police having not been approved by the Provincial Government is devoid of the legal status and is, therefore, of no legal authority. We are, therefore, inclined to uphold the finding the Tribunal that the impugned Standing Order is without any lawful authority and of no legal action.
- 4. Similarly, as per Para No. 73 of Judgment of Honorable Supreme Court of Pakistan 2018 SCMR 1218 (Intra Court Appeals No. 4 of 2017 ctc) when any legislative instrument is declared unconstitutional it is declared void ab initio. The Para No. 73 is being reproduced as under:-
  - 73. The contention of Khwaja Haris Ahmad, learned Sr.ASC that in Para No. 123 of Shahid Perviz's case (Supra) this Court had wrongly observed that "we have already declared void ab initio the legislative

instruments that provided for out of turn promotions." because nowhere in the earlier judgment was such a declaration made, is also without force. Suffice it to say that in Para 104 of Shahid Perviz 'case (Supra), it was observed that: "104. Through the successions of its orders, this Court has consistently maintained the unconstitutionality, and the consequential multity of the instruments providing for the out of turn promotion. "Moreover, in Para 129 of the judgment of Ali Azhar Khan Baloch's case (supra), this Court was pleased to observed that when any legislative instruments is declared unconstitutional, the effect of such declaration is that such legislative instruments becomes void ab initio. The relevant part of Para 129 is being reproduced hereunder: "129............Now, it is a settled law of this Court that no right or obligation can accrue under an unconstitutional law. Once this Court has declared a legislative instruments becomes void ab initio, devoid of any force of law, neither can it impose any obligation, nor can it expose anyone at any liability."

- 5. Similarly, Honorable Supreme Court of Pakistan Judgment reported as 2017 SCMR 456 vide Para No. 98 declared Out of Turn Promotions as null and void in the following terms which is reproduced as under:
  - In a series of judgments, this Court has declared Out of non-promotions as being unconstitutional, un-Islamic, and void ab initio. The principle of unconstitutionality attached to the instrument providing for out of turn-promotion was laid down first in the case of Muhammad Nadeem Arif VS IG of Police (2011 SCMR 408). The view taken in this judgment was followed in another case reported as Ghulam Shabbir VS Muhammad Munir Abbasi (PLD 2011 SC 516), wherein it was held that out of turn promotion was not only against the constitution, but also against the injunctions of Islam, and that reward or award should be encouraged for meritorious public service but should not be made basis for out of turn promotion.
  - 6. ASI Zabid Iqbal No. 90/M of Swat District was given chance of personal hearing on 13/03/2023. He was heard in person in detail to ensure due process and natural justice. Perusal of his record reveals that he has passed A-1 exam, however, did not qualified B-1 exam. He served for three years at PTC Hangu as Drill instructor as per PR 19.22, on the basis of which he was selected for Lower College Course vide PTC Hangu OB No. 407, dated 13/09/2006. Subsequently, qualified Lower College Course during the term ending 20/03/2007 vide PTC Hangu Notification No. 744 dated 30/03/2007 and also qualified Intermediate College Course during the term ending 20/09/2010 vide PTC Hangu Notification No. 2110/S, dated 06/11/2010, his lien was later on transferred from PTC Hangu to Swat District. Withdrawal of above mentioned Out of Turn Promotion shall bring his name in the seniority list with his recruit colleagues borne at the strength of PTC, Hangu.
  - 7. Consequently, his Out of Turn Promotion issued vide PTC Hangu OB No. 407, dated 13/09/2006 is withdrawn with immediate effect through this order and after withdrawal of his Out of Turn Promotion, his name is placed in the seniority list with his recruit colleagues borne at the strength of PTC, Hangu.

- Training School (1) The Principal, Police Training School, may retain for service at the school any head constable or constable deputed form districts for training under rules 19-20 and 19-21. Without the approval of the Inspector-General no drill or physical training instructor may be retained for service at the school for more than three years at a time there being an interval of at least one year before he is again so employed. The Principal, Police Training School, Phillaur, is empowered to enter Police Training School, Drill Inspectors directly into the lower school course after their three year's period of deputation, provided that they are sufficiently educated and their service at the Police Training School has been satisfactory.
- (2) All promotions of drill an physical training instructors made at the school shall be temporary and all such men shall revert to their substantive ranks on return their districts. Drill Instructors returned form the Phillaur Drill Staff should not be employed, even temporarily, as Drill Inspectors in districts without the sanction of Range Deputy Inspector-General of Police.
- (3) All lower subordinates employed as drill and physical training instructors at the Police Training School shall be shown on the promotion lists A, B or C of their districts as "Seconded to the Police Training School". They shall be considered equally with other men of their districts promotion. For this purpose the Principal, Police Training School, will furnish an annual report in form 19-22(3) on all drill and physical training instructors to the Superintendents of the districts concerned. In the case of upper subordinates confirmed as such, these reports shall be submitted to the Deputy Inspector-General of the range from which the men were deputed to the Police Training School for inclusion in their personal files.



## STANDING ORDER NO.11 CHAPTER XIX OF POLICE RULES TRAINING STAFF INCENTIVES CADET INSTRUCTORS

#### **BACK GROUND**

Personnel posted as instructor at Police Training School serve with extreme reluctance. The moment an officer is posted on an instructional assignment, he makes every conceivable effort, political, administrative, compassionate, etc, to have his posting orders cancelled.

The state of mind of such a person, who arrives at a police training institution as an instructor, can be clearly visualized. He feels that he has been discriminated against, he is disgruntled and in a pathetic frame of mind. With this state of mind, these instructors create an atmosphere of a panel institution in the Training Centers.

For many years, this department has been cognizant of this problem. Some efforts have been made to find a solution. Various incentives have been offered to instructors but none of them has had any impact. Posting at Police Training still continues to be considered as a punishment posting.

Ideally Instructors in Training School should not only be willing to serve but must be amongst the finest officers in the department. To achieve this end, personnel posted to Police Training Institution as staff member, are being offered the following incentives, will be categorized as CADET INSTRUCTORS.

## INCENTIVES.

## 1. HC INSTRUCTORS.

Constables undergoing the Lower School Course who pass amongst the first five in the class, will be qualified to serve as HC instructors provided that they volunteer to serve in the Training Institute for three years.

Immediately at the end of three years if they have earned category 'A' reports they would be admitted to Intermediate School Course and their names placed on promotion list 'D' as soon as they qualify the Intermediate School Course.

## 2. ASI INSTRUCTORS

Head Constable undergoing the Intermediate School Course, who qualify amongst the first five in the class, will be qualified to serve as instructors provided they volunteer to work there for three years and earn category 'A' reports. They would be confirmed in the rank of ASI and their names would be brought on promotion list 'E'.

## SI INSTRUCTORS.

Sub inspectors undergoing upper college course, who qualify amongst the first five in the class, will be qualified to serve as instructors provided they volunteer to work there for three years and earn category 'A' reports.

At the end of that period, they would be confirmed in the rank of SI and their names will be brought on promotion list 'F'.

### 3.A:

Alternative if volunteers are not available to the offer contained in Para 3 above. Sub Inspectors volunteer to serve as instructors and are selected by the Principal, PTS Hangu, will be offered the same incentive, i.e after a tenure of three years at PTS Hangu

with 'A' reports, they will be confirmed as Sub Inspectors and their names will be brought on list 'F'.

## NOTE.

- 1. These incentives will not apply to directly recruited ASI's.
- 2. These incentives can be availed of only once in person's career.
- 3. Officers, who are selected as instructors on the basis of promotion examinations passed before 1984, will have to serve in the training institution for two years instead of three years.
- 4. The instructional tenure at PTS Hangu will be reduced to half for those officers who have secured first five positions, in the promotion examination but have already served in the training institution for two years.

The Deputy Commandant PTC Hangu vide his letter No. 4456, dated 19-07-95 (copy enclosed) has requested that procedure regarding selection of Lower Subordinates serving in PTC Hangu & RTW Kohat in lacking in uniformity and contrary farness and unity.

In this connection a meeting was held under the chairmanship of DIG/Hqrs NWFP, Peshawar on 20-08-95 to streamlines the affairs.

The committee after the discussion proposed the following procedure which was approved by the Police Chief.

#### l. INTERMEDIATE SCHOOL COURSE

- Official (s) on deputation (other than member(s) of the staff serving under (A) standing order No. 11/1987 must have a continuous service serving at PTC/RTW at least 02 years before joining the course against PTC vacancy.
- (B) During the period mentioned above the official(s) to carn category "A" reports.
- (C) Broken period(s) if any in respect of the incumbents/officials transferred on complaint earned bad reports to be counted.
- (D) The official(s) must be on list C-I on their respective District (s) before selection.
- (E) Seats allowed to go vacant if no one is eligible to qualify the conditions cut fined above.
- Common seniority of the deputationist on the basis of length of their services will (F) be maintained for selection in the Intermediate School Course.

#### LOWER SCHOOL COURSE 11.

- Procedure Marking system" given in standing order No.XI/1987 to apply in (A) selection against the standing order.
- Service at PTC/RTW to be given due weight-age and one year service at (B) PTC/RTW to carry 02 marks, but broken period(s) not form part in counting.
- (C) Common seniority/merit list to be prepared amongst PTC and RTW staff. The matter regarding selection of D.Is on deputation to PTC/RTW Kohat under PR 19-22 in lower School Course was also discussed and it was decided that in future the selection amongst D.Is in Lower School Course will be made from the personnel ATT who have at least 08 years service.

## STANDING ORDER NO. 17/2014

## Incentive for the Physical Training Instructor at PTC and Elite School


This Standing Order is issued under Article 10(3) of Police Order 2002 in pursuance of the Police Policy Board decision taken in its 5th meeting held on 29th January 2014.

- 2. Aim:- Presently, the training institutions face shortage of physical training instructors due to lack of proper incentives for trainers. This Standing Order aims at addressing this issue.
- 3. Selection of Physical Training Instructors: Physical Training Instructors shall be selected for posting in PTC and Elite Training School in accordance with a criteria to be determined by the Provincial Police Officer.
- 4. Physical Training Instructors shall be eligible for Lower School Course at the completion of three years tenure in PTC or any other Police training institutions, in accordance with Police Rule 19:22. The same incentive shall also be provided to the Elite Training qualified officers who serve as Physical Training Instructors.
- 5. Physical Training Instructors shall be returned to their respective Districts at the competition of three years tenure, in accordance with Police Rule 19:22. A Physical Training instructor shall not be retained at the PTC after the completion of three years except with the prior approval of the Inspector General of Police.
- 6. Power to remove difficulties:- If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.
- 7. Amendment:- All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.
