APP for the State present. Accused/petitioner through counsel present. Complainant not present despite service.

Accused/petitioner lltaf s/o Hayat khan and Naseef Ullah s/o Atta Ullah are seeking their post arrest bail in case FIR No. 331 dated 19/02/2018 u/s 406 PPC of PS Fagir Abad.

Arguments by learned counsel for the accused/petitioners on one side and by learned APP for the prosecution on the other sided heard, record perused.

The accused/petitioners have been implicated in the case for offence u/s 406 PPC on report of the complainant namely Imran s/o Muhammad Hanif. Investigation in the case has been completed so that the accused/petitioners are no more required to be kept in custody for the purpose of investigation whereas neither any recovery from any of the accused/petitioners has been made nor they have made any confession. The offence does not fall under the prohibitory clause of section 497 Cr.PC.

Consequently, both the accused/petitioners are deemed entitled to the concession of bail; hence, their instant petition is accepted. They be released on bail subject to furnishing bail bonds by each of them to the tune of **Rs. 80,000/-** with two sureties each in the like amount to the satisfaction of this court/MOD.
