IMPLEADMENT APPLICATION OF THE ABOVEMENTIONED NECESSARY PARTY IN THE ARRAY OF RESPONDENTS AS PRIVATE RESPONDENT IN EXECUTION PETITION NO.265/2024.

### **RESPECTFULLY SHEWETH:**

- 1- That the abovementioned execution petition is pending adjudication before this Honorable tribunal, fixed for hearing today dated 08.05.2024.
- 2- That the applicant/respondent had been impleaded itself as private respondent in abovementioned appeal but it was disposed off by the honorable tribunal as "this being so when he was confronted as to what would be determined by the tribunal in this appeal. He was fair and frank enough that it has rendered fruitless. Disposed accordingly".
- 3- That the petitioner/appellant is repeatedly stressing on the order dated 17.02.2023 which is withdrawn on dated 03.03.2023 while the case is not decided on merit and the applicant/respondent is necessary party in the subject execution petition wherein applicant is deliberately avoided placing him as respondent to decide the case on merit.
- 4- That initially the petitioner/appellant being teaching cadre was transferred on dated 12.03.2021 on management cadre on wrong post of DDEO north waziristan and latter on placed at the disposal of directorate of E&SE Peshawar vide dated 25.11,2021 due to misuse of power for appointments in department and inquiry was also initiated against the petitioner/appellant by serving charge sheet upon him as well and thus the abovementioned transfer order was suspended vide date 25.02.2022. Meanwhile, the department issued order dated 17.02.2023 in which the applicant/respondent was transferred from Lachi Kohat to North Waziristan as DDEO being a management cadre which was later withdrawn to the extent of Appellant and the applicant/respondent was placed at the disposal of directorate E&SE for further posting vide order dated 03.03.2023 on the base of Tribunal order. Copies of transfer order 12.03.202, 25.11.2021 & letters for inquiry & charge sheet, suspension order dated 25.02.2022, transfer order 17.02.2023, withdrawal order 03.03.2023 are attached as annexure...... A, B, C, D, E.
- 5- That after that the honorable tribunal disposed off "being fruitless" the appeal of the appellant vide Tribunal order dated 12.04.2023, later on vide order dated 03.05.2023 the transfer posting order

dated 17.02.2023 is restored, and applicant/respondent is again transferred/posted as DEO vide order dated 17.08.2023 and subsequently cancelled vide order dated 01.09.2023 via tribunal order but surprisingly the applicant/respondent was again given additional charge as DEO north Waziristan dated 10.11.2023. Copies of the tribunal order dated 12.04.2023, withdrawal order dated 03.05.2023, transfer order 17.08..2023, cancellation order 01.09.2023. additional charge order 10.11.2023 are attached as annexure.... F. G. H. I. J.

- 6- That due to non-joinder of the necessary party/applicant the aforementioned execution petition is the clear violation of Article 10-A of the constitution of Islamic Republic of Pakistan 1973 being his fundamental right and is against the principle of natural justice that no one should be condemned unheard.
- 7- That the abovementioned execution petition is filed by the appellant to avoid merit of the case and concealed the facts from tribuna! stealthy manner by not placing a applicant/respondent as private respondent in the column of respondents as the applicant/respondent is from management cadre while the appellant is teaching cadre and in this regard Honorable Peshawar high court has given judgments that policy be followed in strict sense by not adjusting teaching cadre into management cadre vice versa.
- 8- That the abovementioned petition is ambiguous in itself and violates Section 24-A of the General Clauses Act-1967.
- 9- That the law gives ample power to the tribunal to add party to the appeal/execution as respondents being direct affectee to avoid multiplicity of litigation and wastage of precious time of the Honorable tribunal.

It is therefore, most humbly prayed that on acceptance of this impleadment application the applicant/respondent may please be impleaded as private respondent in the row of respondents in the best interest of justice and to avoid multiplicity of litigation.

- 2. The Dy:DEO North made appointments, even in the Female Educational Institutions despite the facts that the incumbent Dy-DEO (Female) is DDO for the Female Schools in District North.
- 3. 143 Class-IV have been appointed whereas 121 were advertised.
