

**APPLICATION FOR EARLY HEARING IN THE ABOVE TITLED CASE**

The Respondents, submit below:

1. That the above subject Service Appeal is pending for adjudication before this worthy Service Tribunal which is fixed for 05-07-2024.
2. That on 24-05-2024, the instant service appeal was fixed for hearing wherein this worthy Service Tribunal had requisitioned for submission of additional documents regarding data of Junior Clerks working under the domain of District Education Officer (Male) Peshawar. The respondents had collected the requisite data and were prepared to submit the same on 24-05-2024 in this worthy Service Tribunal but this worthy Service Tribunal passed order for the attachment of salaries of the respondents.
3. That the respondents have already submitted all the requisite data as per directions of this Worthy Service Tribunal on 05-06-2024 vide Inst: No. 13182 and also submitted an application for release of salaries of the respondents with Inst: No.13185.
4. That the delay in submission of the requisite data was not intentional because the office of District Education Officer (Male) Peshawar is over burden of work due to the huge number of employees and less strength of administrative staff therefore, for compilation of the aforesaid data, a reasonable time was required.
5. That the Respondents are Government Servants and have no other means to run the needs of their families which include aged parents and school going children. If this worthy Service Tribunal did not recall the order dated 24-05-2024 and not release the salaries of the Respondents, their entire family will be suffered from financial crisis.
6. That there is no legal bar or lacuna to release the salaries of the Respondents rather it would be in the best interest of justice to release the salaries of the respondents before the upcoming Eid-ul-Azha.

It is therefore, prayed that on acceptance of this application, date in the above service appeal may be fixed early for the reason mentioned above.

And salaries of the respondents may very kindly be released by recalling the order 24-05-2024 passed by this Worthy Service Tribunal.

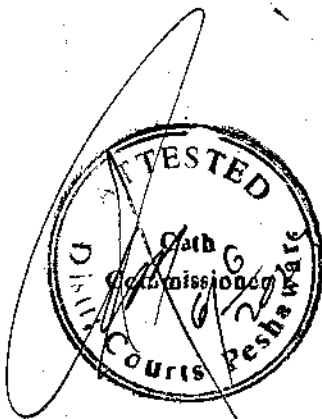
