

APPEAL UNDER SECTION 4 OF KP SERVICE TRIBUNAL ACT 1974, AGAINST THE SENIORITY LIST DATE 31.12.2023, 03.04.2024 WHERE BY THE APPELLANT (REGULAR APPOINTEE OF 2019) HAS BEEN PLACED JUNIOR BELOW THE RESPONDENT 7 TO 20 (APPOINTEE OF 2020, 2021) IN THE ABOVE IMPUGNED SENIORITY LIST.

PRAYER:-

ON ACCEPTANCE OF THE INSTANT APPEAL THE SENIORITY LIST DATED 31.12.2023, 03.04.2024 MAY KINDLY BE SET ASIDE AND THE RESPONDENT NO. 1 TO 2 MAY BE DIRECTED TO CORRECT THE ABOVE SENIORITY LIST AND MAINTAIN THE APPELLANT AT SERIAL NO 06 IN THE SENIORITY LIST.

**FURTHERMORE THE PROCESS OF PROMOTION
MAY KINDLY BE SUSPENDED TILL THE DISPOSAL
OF THE INSTANT APPEAL.**

RESPECTFULLY SHEWETH:-

That the brief facts giving rise to the filing of the instant appeal are as under;-

1. That the appellant is a peaceful law abiding citizen of Pakistan and working in the Khyber Pakhtunkhwa youth affairs department since 2019 as Naib Qasid in BPS-03 posted at district youth office charsadda having 4 years' service. **(copy of the appointment order and arrival report is attached herewith as annexure A and annexure B respectively)**
2. That the respondent no. 1 and 2 are responsible for keeping and maintaining correct and justified record in respect of seniority list of the employees of youth affairs department.
3. That as per seniority list issued on 28-02-2022 appellant is at serial no. 40 whereas the respondent no 3 to 20 are at serial no 41, 44, 45, 47, 51, 52, 54, 56, 57, 58, 58, 59 etc meaning thereby all are junior from the appellant. **(copy of seniority list dated 28-02-2022 is attached as annexure C)**
4. That it is pertinent to mentioned here that the appellant is appointed in 2019 while the respondent 3 to 20 are appointed in 2020, 2021, 2022.

- ✓ 5. That the government of KPK sports, tourism, culture, archaeology, museums and youth affairs department issued a gazette notification on 2019 to the employees naib qasid etc for further promotion subject to the clearance of FA/FSC till 2022 and the appellant followed the said notification and the passed the examination of FA/FSC in the year of 2021 prior to the stipulated period. **(copy of the notification dated 07-02-2022 and SSC certificate of appellant are attached as annexure D)**
6. That as per the seniority list issued by the directorate of youth affairs KPK on 28-02-2022 the appellant at serial no 40 and among these 40 employees 29 were promoted to the post of junior clerk while 06 employees were dropped due to lack of qualification i.e FA/FSC and the appellant is deserve at serial no 06 in the current seniority list.
7. That on 12-01-2024 provisional seniority list has been circulated to all class-IV employees of the respondent department wherein the appellant was placed at serial no 23. **(copy of the provisional seniority list is attached herewith as annexure E)**
8. That the appellant submitted presentation/appeal on 24-01-2024 for the correction of the seniority list/promotion paper but in vain as the respondents department wants to favor the blue eyed employees and till date did not replied the

✓ representation/appeal of the appellant. (copy of the representation appeal is attached as annexure F)

9. That the meanwhile a fresh/final seniority list has been issued to all class- employees of the respondent Department on 03.04.2022 wherein the appellant is placed at serial no 23. (Copy Of Fresh/Final Seniority List Is Attached Herewith as annexure G)

10. That the appellant submitted departmental appeal on 08.04.2024 for the correction of the seniority list but in spite of waiting for statutory period the departmental appeal has not been decided. (copy of department appeal dated 08.04.2024 is attached as annexure H)

11. That the appellant being/aggrieved from the act and action of the respondents department approached this honorable tribunal on the following grounds.

GROUND:-

A. That the seniority list issued in 12.01.2024 is against the law facts rules and against the fundamental rights of the appellant.

B. That the act and action of respondent department is illegal, against law, rules and against the constitution of the Islamic republic of Pakistan 1973.

- ✓ C. That the appellant is appointed in 2019 while the respondent's no. 3 to 20 are appointed in 2020, 2021, 2022 therefore seniority list may kindly be corrected and proper position according to law and rules is given to the appellant.
- D. That according to the judgment of the high court and supreme court of Pakistan no show cause has been issued to the appellant which changing the seniority list of the appellant.
- E. That as per service law and rules the appellant is entitled to be placed in the seniority list at serial no 6 but the respondent 1 and 2 placed the names of the appellant at serial no 33 which is against the law rules and the norm of justice.
- F. That the act of the respondent department are discriminated and violation of the fundamental rights of the appellant enshrine in the constitutional of the Islamic republic of Pakistan 1973.
- G. That the respondent no 1 and 2 by ignoring the law act rules and fundamental rights managed the seniority list on their own whims and wishes by depriving the appellant from his due legal right.
- H. That appellant has not been treated in according with law and rules by the respondent department on the subject noted above and as such the respondents violated article 4 and 25 of the constitution of Islamic republic of Pakistan 1973.
- I. That the act and action of the respondents department are violation of article 38 of the constitution of Pakistan 1973.

J. That the respondent acted in arbitrary and malafide manner by ignoring the appellant for not considering in the promotion process of the class-IV.

K. That any other grounds will be furnished at the time of final arguments with the prior permission of this honorable tribunal.

It is therefore most humbly prayed that on acceptance of the instant appeal the seniority list dated 31-12-2023, 03-04-2024 may kindly be set aside and the respondent/department no 1 and 2 may directed to correct and maintain by rectifying the said illegal, unlawful seniority list appellant may kindly be placed at serial no 6 in the seniority list.


4. That the balance of convenience also leans in favour of applicant/petitioner/appellant.
