# R/SHEWETH:

**QN FACTS:** 

#### Brief facts of the present appeal are as under:-

That the appellant was initially appointed as Chowkidar vide order dated 01.06.1993. That after appointment the appellant took over charge against his respective post and started performing his duty quite efficiently and upto the entire satisfaction of his superiors. Copy of the service book is attached as annexure.

2- That during service the appellant was falsely charged in criminal case Under Section 302/34 PPC, dated 29.04.2006, FIR No.199, Police Station

Chamkani. That after chalking the above mentioned FIR the appellant was informed the authority concerned regarding the incident while the appellant was absented from duty due to life threats. Copy of the FIR is attached as annexure.

B.

- 3- That vide dated 13.07.2011 the appellant was released on bail by the Court of Additional District & Session Judge, Peshawar on the basis of compromise. That after released on bail in the above mentioned criminal case the appellant submitted several applications and as such made verbal requests for his adjustment against his post of Chowkidar which were properly forwarded by the District Education Officer (Female), Peshawar. Copies of the bail order, application and covering letter are attached as annexure.

- 6- That the appellant feeling aggrieved from the impugned order dated 14.03.2017 preferred departmental appeal before the appellate authority but no reply has been received so far. Hence the present appeal on the following grounds amongst the others. Copy of the departmental appeal is attached as

#### **GROUNDS:-**

- A- That the impugned order dated 14.03.2017 is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be modified/rectified to the extent of re-instatement/adjustment w.e.f 29.04.2006 and back benefits w.e.f 27.11.2012.
- B- That the appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the respondent department acted in arbitrary and malafide manner while issued the impugned order dated 14.03.2017 with immediate effect rather than retrospective effect i.e. 29.04.2006 and also denied back benefits w.e.f 27.11.2012 as per recommendations of the inquiry officer mentioned in the inquiry report.
- D- That as per Fundamental Rule-54 the appellant is fully entitle for the grant of back benefits w.e.f 27.11.2012 as per recommendations mentioned in the inquiry report but the respondent department denied the same which not tenable in the eyes of law.
- E- That re-instatement order of the appellant dated 14.03.2017 issued by the District Education Officer (Female), Peshawar is not tenable in the eye of law and liable to be modified/rectified to the extent of re-instatement w.e.f from 29.04.2006 and back benefits as per recommendations of the inquiry officer.
- F- That the impugned order dated 14.03.2017 has been issued by the competent authority in violation of the Principle of natural justice and as such in violation of the Judgments of the Apex Court, hence the same is liable to be modified/rectified.
- G- That there is no adverse order against the appellant is available on the record, therefore, as per law and rules the appellant is fully entitle to be reinstated into service w.e.f 29.06.2006 and also entitle for grant of back benefits as per FR-54 w.e.f 27.11.2012.
- H-That the appellant feeling aggrieved from the impugned order dated 14.03.2017 preferred the instant departmental appeal before your good self.

Respected Sir,

With great respect it is most humbly stated that the appellant was initially appointed as Chowkidar vide order dated 22.05.1993. That after appointment the appellant took over charge against his respective post and started performing his duty quite efficiently and upto the entire satisfaction of his superiors.

That during service the appellant was falsely charged in criminal case Under Section 302/34 PPC, dated 29.04.2006, FIR No.199, Police Station Chamkani. That after chalking the above mentioned FIR the appellant was informed the authority concerned regarding the incident while the appellant was absented from duty due to life threats.

That vide dated 13.07.2011 the appellant was released on bail by the Court of Additional District & Session Judge, Peshawar on the basis of compromise. That after released on bail in the above mentioned criminal case the appellant submitted several applications and made verbal requests for his adjustment against his post of Chowkidar which were properly forwarded by the District Education Officer (Female), Peshawar.

That it is pertinent to mention that during the absence period there was no adverse order had been issued against the appellant while the authority concerned conducted fact finding inquiry in the matter and it was held by the inquiry officer in the findings of inquiry report that the appellant submitted an application on 13.07.2011 for his re-instatement/adjustment after release on bail in the criminal case. That the inquiry committee recommended the appellant for re-instatement on his original post with full benefits in light of Fundamental Rule-54 after submission of his application for re-instatement and the absence period w.e.f 29.04.2006 till submission of application may

That the competent authority issued office order even endst: No.5711-15 dated 14.03.2017 whereby the appellant has been re-instated into service but with immediate effect rather than retrospective effect i.e. 29.04.2006.
