The appellant humbly submit as under..

- That the appellant was most senior Clerk/Reader with the Civil Judge District Upper Chitral Khyber Pakhtunkhwa.
- That due to some clerical mistake there were some discrepancies in the names mentioned on the cause list, Daily Registered through sheer inadvertence. (copies of cause lists and daily register No 9 are annexed as annexure "A"&"B")
- That due to above mentioned mistakes which were totally based upon human error, statement of allegation and charge sheet were issued to the appellant (copy of Statement of allegation and charge sheet are annexed as annexure "C"&"D")
- 4. That after charge sheeting the appellant an inquiry officer was appointed to conduct Inquiry regarding the issue, and directed to the appellant to submit his written defense of the charge sheet to the Inquiry Officer, and the appellant submitted the para wise

reply of the charge sheet. Who after conducting inquiry submitted his report to the competent authority, wherein recommendation for withholding increment of one year was made.(copy of reply of charge sheet and an inquiry report are annexed as annexure "E"&"F")

- 5. That after submission report by the inquiry officer show cause notice was issued to the appellant by the competent authority which was duly replied by the appellant (copy of show cause notice and reply are annexed as annexure "G"&"H")
- 6. That the competent authority while accepting recommendations of the Inquiry officer imposed minor penalty of withholding on increment for a period of one year and he also directed that he shall not posted to a responsible position for a period of one year through the impugned order.(copy of order/notification dated 15-03-2024 is annexed as annexure "I")
- That against the mentioned above official letter the appellant submitted departmental appeal the appellate forum which has not decided even after the expiry of 90th days of statutory period.(Copy of departmental appeal is annexed as annexure "J")
- 8. That the appellant invokes the appellate jurisdiction of this Honorable forum for setting aside the impugned order on the following grounds amongst others.

Grounds:

- A. That the impugned order is against the law facts and circumstances of the case hence not tenable and liable to be set aside.
- B. That the appellant submitted his reply during the inquiry proceeding wherein the appellant stated that the mistakes mentioned were totally the result of human error while some of

the allegation were shown baseless on the basis of available record/cause list registers.

- C. That the Inquiry officer did not take in to consideration the details mentioned in the reply and came to a wrong conclusion by making recommendation of withholding increment of the appellant.
- D. That the appellant has been performing his duties for the last so many years and there has been no complaints against the appellant from any quarter.
- E. That the enquiry report totally one sided and lacks the characteristics of a speaking and reasonable report by ignoring the real facts and details given in the reply of the appellant.
- F. That the impugned order which was purely based upon the enquiry report is a harsh one and against the norms of justice, hence liable to be declare null and void.

It is therefore humbly prayed that on acceptance of this appeal the impugned order dated 16-03-2024 may kindly be set aside and the penalty imposed upon the appellant may also be withdrawn.

On 26.09.2023, the learned Civil Judge Upper Chitral made a compliant to the Hon'ble District & Sessions Judge, Upper Chitral contained in letter No.91/CJ/JM/UCTL, complaining against Mr. Iftikhar Uddin, Senior Clerk, the then Reader in the court of the learned Civil Judge for wrong entries in the Daily Diary and Cause List.

The Hon'ble District Judge issued Statement of Allegations and Charge Sheet to the official on 28.09.2023 and vide office order No.614-618/DSJ/ZQ/UCTL, dated 28.09.2023 appointed the undersigned as Inquiry Officer and appointed Mr. Fazal Mehboob, Budget & Accounts Assistant, District Courts, Upper Chitral as Departmental Representative.

On receipt of the order alongwith relevant documents, reply was sought from the official who submitted his reply wherein he admitted the allegations levelled under Heads No.02,03 and 05 of the Charge Sheet to be true and correct, however he disputed rest of the allegations. Therefore, representative of the competent authority was directed to record his statement and produce evidence availing which the representative recorded his statement who was cross examined by the accused. Similarly, statement of the accused was recorded in defense.

He submitted a statement in writing with the contention that his whildren are residing in Lower Chitral while his mother in Mulkhow and he himself resides here in Booni. For the above reasons, he is not mentally composed. Besides, he has to deal with some family problems as well. Therefore, some clerical mistakes surfaced in the official work. He stated that the mistakes were not meant for any gains and that he will be careful in future and prayed for filing the inquiry.

As stated above that the accused admits the allegations at S.No.02,03 and 05 to be true and correct. The said heads of allegations are reproduced here:

- ĬÍ. That, cases mentioned at serial No. 3, 6 and 17 of daily diary register of dated 12.07.2023 are not mentioned by you in the cause list of the same date.
- iii. That, case mentioned at serial No.13 of the daily diary register on dated 13.07.2023 is mentioned by you in the cause list with different name.
- That, case mentioned in serial No. 1 of the daily diary register dated 14.07.2023 is again recorded at serial No. 13 by you.

So far as rest of the allegations bearing No.01,04,06 and 07 are concerned, the evidence produced suggests as follow:


ALLEGATION UNDER HEAD NO.01:

That, in the daily diary register, dated 07.07.2023, the names /titles of the cases mentioned at serial No. 4 & 5 of daily diary and cases mentioned at serial No. 10 and 11 in daily cause list have been written with different names by you.

Copy of relevant page of the Daily Diary dated 07.07.2023 (EX:PW1/1) bears title of a case as "Nazar Uddin versus Fazal Habib" and an application connected with the matter has been shown as Ditto while in the Cause List of the even date the title finds mention as "Nazir Ahamd & others versus Fazal Habib". Thus, in the name of has differently been written as Nazir as Nazar Uddin and Nazir Ahmad in the Daily Diary and Cause List. The accused in the reply has termed the same to be human error and written out of inadvertence but the same depicts carelessness on his part.

ALLEGATION UNDER HEAD NO.04:

That, one case of dated 14.07.2023 is incorrectly recorded in the daily diary register dated 13.07.2023.







In reply to the said allegation, the accused has contended that the allegation is the result of misunderstanding as no case was fixed for 13.07.2023. Relevant pages of the Daily Diary dated 13.07.2023 and Cause List of the even date are available on file as EX:PW1/3 and EX:PW1/10 respectively. In the Daily Diary dated 17.07.2023 at S.No.13 title of a declaratory suit is written as "Ali Rehmat Shah versus Rehman Ali Shah" while in the Cause List of the even date at S.No.05 the tittle has been written as Rehmat Ali Shah versus Rehman Ali Shah". Thus, his reply regarding the allegation to be the result of misunderstanding is not supported by record. However, the official has written "Ali" before and after "Rehmat" in both the Daily Diary & Cause List which seems to be clerical mistake.

In the complaint, it is mentioned that "Case mention date, S.No. of the Diary Register dated 14.07.2023 is incorrectly recorded in the Daily Diary". The above sentence in the complaint is not clear. In the copy of the Register Daily Diary, dated 14.07.2023 (EX:PW1/4), the learned Civil Judge/Complainant has highlighted a case titled "Muhammad Amin versus Syed Sadat Shah" (Execution Petition) and with red ink entered the same entry to be incorrect, however, I do not find any incorrect entry in the Cause List of the even date.

ALLEGATION UNDER HEAD NO.06:

That, on dated 02.08.2023 case mentioned at serial No.3 in the daily diary register as incorrectly recorded to be decreed as well as the date fixed and the title of the case are not correctly recorded by you.

I went through the Daily Diary dated on 02.08.2023 (Copy is on file as EX:PW1/12) where in at S.No.03, a case titled "Shahida Bibi versus Ibrahim & others" finds mention, however, there is no mention

1



of incorrect recording of the said matter to be decreed or wrong entry of the same as alleged in the complaint. The same entry finds mention in the Cause List of the even date.

4. ALLEGATION UNDER HEAD NO.07:

That, a case titled "Ali Hussain vs Nizam Uddin" was decreed on 15.08.2023 but is again incorrectly recorded by you in daily diary register on dated 23.08.2023 and the said case is missing in the cause list of the said date.

The accused has responded to the allegation under Head No.07 according to the following terms:

The said case was fixed for 15.08.2023. On the date fixed, the matter has been shown as "decreed" in the Daily Diary (EX:PW1/6). Similarly, in the Cause List of the even date the matter has been shown as "decreed". The matter finds entered in the Daily Diary of 23.08.2023 wherein it has been written that "the matter has stood decreed". In the Daily Diary of 23.08.2023, entry of the case is missing. However, Order Sheets of the case show that arguments were heard on 02.08.2023 and the matter was fixed for order on 15.08.2023. On the date fixed i.e 15.08.2023, the parties and their counsel were present before the court and the matter was decreed.

In the above scenario, the contention of the accused that after hearing arguments on 02.08.2023, initially the matter was fixed for 23.08.2023, however, the date was fixed for 15.08.2023, sounds well. The contention is supported by record as well as order sheets which carry presumption of genuineness under the law. In the wake of the above, there was no need to enter the case in the Cause List of 23.08.2023.

In view of the above facts crux of the inquiry is that:

Charge under Head No.01: Proved.

Charge under Head No.02: Proved, as accused admits.

Charge under Head No.03: Proved. Admitted by accused.

Charge under Head No.04: Not proved.

Charge under Head No.05: Proved. Admitted by accused.

Charge under Head No.06: Not proved.

Charge under Head No.07: Not proved.


The Hon'ble District Judge has directed the undersigned to make recommendations as to punishment or other appropriate actions against the accused.

It is observed that accused's contention regarding the entries being the result of inadvertence does not carry any force with it for the reason that the official having 17 years' service to his credit and having being promoted to the elevated position of Senio Clerk is not expected and supposed to make wrong entries in the Daily Diary Register and Cause List and he cannot seek refuge behind the alleged inadvertence. The above facts speak about his inefficiency.

In case of wrong entries, there is every possibility of the litigants getting wrong Parcha Peshi of another case and date which may result

into dismissal of one's suit for non-prosecution, initiation of ex-parte proceedings against a party, penalties and getting their appeals time barred etc.

The official has already been issued advisory as well by the learned Civil Judge dated 10.04.2023 (EX:PW1/15). He has also been issued with warning. <u>Therefore, I recommend that one increment of the official for a year maybe withheld.</u>

On 26.09.2023, the learned Civil Judge Upper Chitral made a compliant to the Hon'ble District & Sessions Judge, Upper Chitral contained in letter No.91/CJ/JM/UCTL, complaining against Mr. Iftikhar Uddin, Senior Clerk, the then Reader in the court of the learned Civil Judge for wrong entries in the Daily Diary and Cause List.

The Hon'ble District Judge issued Statement of Allegations and Charge Sheet to the official on 28.09.2023 and vide office order No.614-618/DSJ/ZQ/UCTL, dated 28.09.2023 appointed Senior Civil Judge, Upper Chitral as Inquiry Officer and Mr. Fazal Mehboob, Budget & Accounts Assistant, District Courts, Upper Chitral as Departmental Representative. The Inquiry Officer submitted Inquiry Report.

I examined the report and found that the inquiry has been conducted in accordance with the provisions of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011. I found that the charges against the accused under heads No.01 to 02 and 05 have stood proved.

Having satisfied myself with the Inquiry Report, Final Show

Cause Notice was issued to the accused on 16.02.2024. The accused

submitted reply to the notice; however, did not submit any additional submit and additional the proposed penalty into Warning. Thereafter, the accused alongwith

Welfage Becoud to



the department representative was called for personal hearing. On 02.03.2024, audience was given to the accused official and he was patiently heard. He urged that allegations under heads No.01, 02 and 04 were not proved against him. Record was again perused and comparison was made which transpired that the second portion of allegation No.01, two parts of allegation No.2 (to the extent of S.No.03 and 06) and allegation No.04 was not correct against the accused official.

Today, I went through the record thoroughly which depicts that during the course of inquiry, the accused official submitted his detailed reply to the Statement of Allegations and Charge Sheet wherein he admitted the allegations in the charge under Heads No.02, 03 and 05 to be correct. His stance is that the entries detailed in the charges ibid were the result of human error and inadvertence. The Inquiry Officer has found the charge under Head No.01 to be proved against him and has held charges under Heads No.04,06 and 07 have not been proved.

His contention regarding the entries to be human error and inadvertence cannot be taken into consideration for the reason that per report the official has a lengthy service of 17 years to his credit and he is presently serving in the elevated position of Senior Clerk (BPS-14). Therefore, he is not expected to make wrong entries in Daily Diary Register and Cause List and seek refuge behind alleged inadvertence. The accused official has already been issued advisories by the Presiding Officers for such like acts; hence, his plea of inadvertence loses significance. Even if it is assumed that there were alleged wrong entries due to inadvertence even then being in a responsible position of Reader, he was required to go through the registers and correct the same well

within time. In fact, it was not the inadvertence rather his inefficiency and carelessness which resulted into embarrassment to the court and hardships to the litigants. In case of such wrong entries, there is possibility of getting Parcha Peshi containing wrong date of hearing and date of hearing of any other case which may result into dismissal of suit for non-prosecution, initiation ex-parte proceedings, imposition of fine and penalties and appeals of litigants getting barred by time etc.

Keeping in view the Inquiry Report and personal audience given to the accused official, I am satisfied that the accused official is guilty of inefficiency within the meaning of Rule-03, Clause (A) of the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011. In view of the given facts and circumstances, I find myself in agreement with the recommendation made by the Inquiry Officer.

Therefore, minor penalty of withholding one increment with non-accumulative effect for a period of one year is imposed upon the accused official in terms of Rule-04 (1), Clause-02 of the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011. Further, he shall not be posted to a responsible position for a period of one year.

Instant file be consigned to record room after its necessary completion and compilation and a copy of the same is provided to the wofficial concerned free of cost.

REVIEW/REPRESENTATION AGAINST THE ORDER/NOTIFICATION DATED 15-03-2024 PASSED BY THE LEARNED DISTRICT AND SESSION JUDGE/ZILLA QAZI UPPER CHITRAL WHEREBY IMPOSSING MINOR PENALTY OF WITH HOLDING ARE INCREMENT FOR A PERIOD OF ONE YEAR WAS IMPOSSED UPON THE APPELLANT.

Respectfully Sheweth:

The appellant humbly submit as under.

- 1. That the appellant was most senior Clerk/Reader with the Civil Judge District Upper Chitral Khyber Pakhtunkhwa.
- 2. That due to some clerical mistake there were some discrepancies in the names mentioned on the cause list, Daily Registered through sheer inadvertence. (Copies of cause lists and daily register No. 9 are attached)
- 3. That due to above mentioned mistakes which were totally based upon human error, statement of allegation and charge sheet were issued to the appellant. (copy of Statement of allegation and charge sheet are attached)
- 4. That after charge sheeting the appellant an inquiry officer was appointed to conduct inquiry regarding the issue, and directed to the appellant to submit his written defense of the charge sheet to the inquiry Officer, and the appellant submitted the para wise reply of the charge sheet. Who after conducting inquiry submitted his report to the competent authority, wherein recommendation for withholding increment of one year was made. (copy of reply of charge sheet and an inquiry report are attached).
- 5. That after submission report by inquiry officer showcase notice was issued to the appellant by the competent authority which was duel replied by the appellant. (Copy of Showcase notice and replied are attached)
- 6. That the competent authority while accepting recommendation of the inquiry officer imposed minor penalty of withholding on agreement for a period of one year and he also directed that he shall not posted to a responsible position for a period of one year through the impugned order. (Copy of order notification dated 15-03-2024 are attached.)



7. That the appellant invokes the appellate jurisdiction of this honorable forum for sitting aside the impugned order on the following ground amongst others.

Grounds:

- A. That the impugned order is against the law facts and circumstances of the case hence not tenable and liable to be set aside.
- B. That the appellant submitted his reply during the inquiry proceeding wherein the appellant stated that the mistakes mentioned were totally the result of human error while some of the allegation were shown baseless on the basis of available record/cause list registers.
- C. That the Inquiry officer did not take in to consideration the details mentioned in the reply and came to a wrong conclusion by making recommendation of withholding increment of the appellant.
- D. That the appellant has been performing his duties for the last so many years and there has been no complaints against the appellant from any quarter.
- E. That the enquiry report totally one sided and lacks the characteristics of a speaking and reasonable report by ignoring the real facts and details given in the reply of the appellant.
- F. That the impugned order which was purely based upon the enquiry report is a harsh one and against the norms of justice, hence liable to be declare null and void.

It is therefore humbly prayed that on acceptance of this review/ representation the impugned order dated 15-03-2024 may kindly be set aside and the penalty imposed upon the appellant may also be withdrawn.
