SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER NO. 3122-27/E DATED: 04.03.2024, RECEIVED ON 20.03.2024, WHEREBY THE PENALTY OF COMPULSORY RETIREMENT FROM SERVICE IS IMPOSED UPON THE APPELLANT AGAINST THE LAW, RULES AND FACTS AND IS LIABLE TO BE SET ASIDE.

### Prayer:-

That on acceptance of this service appeal the order impugned may very kindly be set aside being void and against the law and rules and the Appellant be reinstated back into service with all the consequential / back benefits.

## Respectfully Sheweth:

Facts:

i.

iii.

That the Appellant joined the Police Department back in the year 2009 and since then is regularly performing his duties to the best of his abilities with great zeal, honestly, efficiently and with punctuality.

That the Appellant has performed his duties to the utter satisfaction of the authorities and till date no complaint has ever been received against the Appellant.

That all of a sudden the Appellant was issued and Charge Sheet coupled with Statement of Allegations, wherein the allegation of absence was levelled against the Appellant, although the Appellant has never absented himself willfully and for every single absence a proper application was timely submitted. The Appellant submitted a proper reply the same and denied the allegations. Copies of the Charge Sheet and Statement of Allegations are enclosed as Annexure "A" and that of the reply is enclosed as Annexure "B", respectively.

iv. That the Appellant submitted the relevant documents regarding his absence, which include the medical certificates and an application regarding the issue of his biometric attendance, as the bio metric scanner would not recognize the thumb impression of the Appellant. Copies of the medical certificates and that of the application are enclosed as Annexure "C".

v. That to the utter surprise of the Appellant neither the reply was considered nor the relevant documents were paid any heed to the utter detriment of the Appellant and a farce inquiry was initiated against the Appellant.

vi. That the inquiry was conducted with the predecided result and finding and the Appellant was never properly associated with the inquiry throughout.

vii. That neither was Appellant afforded any opportunity to defend himself nor was any chance of personal hearing ever afforded to the Appellant. Flabbergasting enough the Appellant was not even issued a Show Cause Notice, which reflects clearly the intentions of the inquiry committee.

viii. That the inquiry committee submitted its findings which are faulty, tainted with mala fide and lacunas and are not worth consideration at all. Copy of the finding report is enclosed as Annexure "D".

ix. That the again very strange enough without issuing any Show Cause Notice to the Appellant major penalty of Dismissal from service imposed upon the Appellant vide order O.B. No. 126 dated 13-09-2022. Copy of the order dated 13-09-2022 is enclosed as Annexure "E".

That the Appellant feeling aggrieved submitted a departmental appeal for the redressal of his grievances. Copy of the departmental appeal is enclosed as Annexure "F".

That the appeal of the Appellant was considered partially to the extent that the penalty of dismissal from service was converted into forfeiture of three years of approved service and the period out of service was converted into leave without pay vide order No. 11778/E dated 22-10-2022. Copy of the order dated 13-10-2022 is enclosed as Annexure "G".

That the Appellant approached this Honourable Tribunal for the redressal of the grievances in service appeal, which was allowed vide judgment dated 07-04-2023 in terms that the order impugned was set aside and the Respondent Department was directed to conduct de novo inquiry. Copy of the Judgment dated 07-04-2023 is enclosed as Annexure "H".

xiii. That strange enough in mean while another charge sheet was issued to the Appellant with allegations of issuing license to person not present and also that of conversion of LTV driving license to HTV. Copy of the charge sheet is enclosed as Annexure "I".

xiv. That the Appellant submitted a detailed reply to the same, but the same was not considered and the Appellant was issued final show cause notice, the reply to which was also not considered. Copies of the reply is enclosed as Annexure "J", that of the show cause notice as "K" and the reply as "L", respectively.

xv. That to the utter surprise of the Appellant major penalty of compulsory retirement was imposed upon the Appellant vide order No. 3122-27/E dated 04-03-2024, received on 20-03-2024, against the law and rules on the subject. Copy of the order dated 04-03-2024 is enclosed as Annexure "M".

xvi. That feeling aggrieved the Appellant preferred a departmental appeal against the same, but the same is not responded to despite the lapse of statutory period of time. Copy of the departmental appeal is enclosed as Annexure "N".

xvii. That having no other option and still feeling aggrieved this Honourable Tribunal is approached on the following grounds.

### <u>Grounds:</u>

a. That the order impugned is based on the allegations against which the Appellant is never afforded any opportunity to defend himself, which makes the same void ab initio.

- c. That the Appellant has been condemned as unheard and also the mandatory provisions of the relevant law and rules have been bulldozed blatantly.
- d. That this is classic case of exercise of authority which is never vested in the Respondent No. 3, which makes the whole process a nullity in the eyes of law.
- e. That the Appellant has never absented himself willfully neither has the Appellant ever committed any action of commission or omission which may constitute any offence under any law.
  - 5. That the Appellant has never done any act while posted as In-charge License Branch which may constitute any offence, rather the charges levelled are baseless for the reason that the Appellant had no access to the master computer at Peshawar CPO to make the alleged changes.

It is, therefore, very respectfully prayed that on acceptance of this service appeal the order impugned may very kindly be set aside being void and the Appellant reinstated back into service with all back/consequential benefits. Any other relief deemed appropriate in the circumstances and not specifically prayed for may also very kindly granted.





The allegations leveled against him is proved during course of enquiring in light of available record. Therefore, we the enquiring committee are of the view that the delinquent computer operator Muhammad Ali remained absent without prior leave permission from high ups and absent from duty for total 91 days which a gross misconduct the delinquent official as still absent and dispute of enquiry initiated against him, he did bother to report for his duties, this act of delinquent official speaks him disinterest discharging him official duties. It light of above facts and circumstances, the members of enquiry committee reached to the conclusion that delinquent official computer operator Muhammad Ali is no more interest to carr on his job, therefore, the committee unanimously recommended him for major punishment submitted approved, please.

JUDGMENT:

Precisely stated the SALAH-UD-DIN, MEMBER:facts surrounding the instant service appeal are that the appellant, while posted as Incharge OG/PG and missing persons branch, had remained absent from duty, therefore, disciplinary action was taken against him. On conclusion of the inquiry, he was awarded major penalty of dismissal from service vide order bearing OB No. 126 dated 13.09.2022 passed by the then District Police Officer Swat. Attested The appellant being aggrieved of the same, filed departmental appeal. ESTED before the Regional Police Officer Malakand Region Swat, which was decided vide order dated 22.10.2022, whereby the penalty of

dismissal from service was converted into forfeiture of three years approved service. The appellant has now approached this Tribunal through filing of instant appeal for redressal of his grievance.

2. On admission of the appeal for regular hearing, notices were issued to the respondents, who contested the appeal by way of filing of para-wise comments, wherein they refuted the assertion raised by the appellant in his appeal

3. Learned counsel for the appellant has addressed his arguments supporting the grounds agitated by the appellant in his service appeal. On the other hand, learned District Attorney for the respondents has controverted the arguments of learned counsel for the appellant and has supported the comments submitted by the respondents.

4. At the very outset of his arguments, learned counsel for the appellant contended that the appellant being a Computer Operator, was a member of ministerial staff and in view of Section-44 of Khyber Pakhtunkhwa Police Act, 2017 (hereinafter referred to as the "Act"), the District Police Officer Swat was not the Authority competent to take disciplinary action against him. In order to properly appreciate the contention of learned counsel for the appellant, it would be appropriate to reproduce Section-44 of

"Ministerial staff etc. ---(1) Subject to rules,

Provincial Police Officer, may appoint ministerial

staff and other employees to assist the Police.

ATTESTED EXAMINE Knybderpiloftukhwa Service 'Cribunaj Peshawar (2) Any person employed under sub-section (1) shall be under the direction and control of Provincial Police Officer.

(3) The powers of direction and control referred to in sub-section (2) shall include the powers of discipline and dismissal.

 (4) Subjects to rules, Provincial Police Officer, may delegate his powers and authority under this section to an officer of appropriate rank.

While going through Section-44 of the Act, it is crystal clear 5. that disciplinary action against the ministerial staff could either be taken by the Provincial Police Officer himself or by any other officer to whom such powers are delegated by the Provincial Police Officer. In the instant case, the appellant was issued charge sheet as well as statement of allegations by the District Police Officer Swat and disciplinary proceedings were taken against the appellant under Police Rules, 1975. The appellant was dismissed from service by the District Police Officer Swat vide order bearing O.B No. 126 dated 13.09.2022. It appears from perusal of the said order that District Police Officer Swat too had realized at the time of passing of the same that disciplinary proceedings against the appellant could not have been taken under Police Rules, 1975, therefore, in concluding para of the aforementioned order dated the 13.09.2022, it has been mentioned that he was awarding penalty to the appellant as competent Authority under Khyber Pakhtunkhwa Efficiency & Discipline Rules, 1973 as amended in 2011. In view STED. of Section-44 of the Act, Provincial Police Officer was the

competent Authority, therefore, disciplinary proceedings taken against the appellant were corum-non-judice for all intents and purposes.

In view of the above discussion, the appeal in hand is allowed 6. by setting-aside the impugned order and the matter is remitted to the competent Authority to conduct de-novo inquiry against the appellant in accordance with relevant rules strictly in accordance with law within a period of 60 days of receipt of copy of this judgment. Needless to mention that the appellant shall be associated with the de-novo inquiry by providing him opportunity of self defence as well as personal hearing. The issue of back benefits shall be subject to outcome of de-novo inquiry. Parties are left to bear their own costs. File be consigned to the record room.





### **ORDER**

This order will dispose of the departmental enquiries conducted against Computer Operator Muhammad Ali (BPS-16) of District Swat (Now Investigation Wing, Swat) as follows:-

I.

He while posted as Admin Driving License Branch District Swat has:-

a) Issued a driving license to one Tahir Irshad S/O Irshad Ahmad R/O Loung, Tehsil Phalia District Mandi Baha-ud-Din, Punjab having Driving License No.104000094334 and CNIC No.220209017323, as the license holder was gone abroad, as intimated by Deputy Inspector General of Police, Traffic, Khyber Pakhtunkhwa, Peshawar vide his office Letter No.18-19/IT, dated 04-01-2023.
b) Converted Driving License from LTV to HTV illegally/unlawfully in the name of Akhtar Ali S/O Momin Khan R/O Kabal, Swat having Driving License No.104000081917 and CNIC No.1560205492907, as intimated by CPO, Peshawar vide Memo: No.Ops/FC/ Verification of Pakistani Driving License Mr. Akhtar Ali/2857-58, dated 24-01-2023.

He was initially issued charge sheet by the District Police Officer, Swat vide No.54/PA, dated 15-03-2023 on the above allegations and findings of which was submitted to this office for further action. On perusal of the same the undersigned noticed that the enquiry proceedings initiated by the District Police Officer, Swat against Computer Operator Muhammad Ali (BPS-16) were against the directions received from CPO, Peshawar vide Memo: No.2704-20/E-V, dated 08-09-2022, being competency of RPO, therefore, the enquiry was declared void-ab-initio vide this office Order No.13662-63/E, dated 28-09-2023 and a fresh Charge Sheet & Statement of Allegations were issued by this office on the same allegations vide this office No.13685-87/E, dated 28-09-2023 and Mr. Amir Nawaz, Superintendent of Police, Headquarters, Swat was deputed as Enquiry Officer to conduct proper departmental enquiry against above-named Computer Operator and submit his findings report. The Enquiry Officer, during the course of enquiry, recorded statements of all concerned and provided ample opportunity to the delinquent Computer Operator to defend the charges leveled against him. The Enquiry Officer, after conducting proper departmental enquiry, submitted his finding report, wherein the E.O. intimated that the allegations leveled against above-named Computer Operator are proved and recommended him for appropriate action. Subsequently, he was issued a Final Show Cause Notice vide this office No.17340-41/E, dated 13-12-2023, reply to which by the Computer Operator concerned was submitted on 19-01-2024 and found unsatisfactory.

II. Another enquiry on account of absence from duty of Ninety One (91) days was initiated by the District Police Officer, Swat vide Charge Sheet No.44/PA, dated 30-05-2022, wherein he was awarded major punishment of "Dismissal from Service" by the District Police Officer, Swat vide OB No.126 dated 13-09-2022 from the date of his absence i.e. 11-05-2022 and the absence period was treated as leave without pay. Subsequently, he preferred a departmental appeal in this office, which was accepted and the punishment of "Dismissal from Service" was converted into "Forfeiture of Three (03) years approved service", while the period of absence as well as intervening period were treated as leave without pay vide this office Order No.11778/E, dated 22-10-2022.

Feeling aggrieved with the above-mentioned order, the Computer Operator concerned filed a Service Appeal No.1546/2022 before the Khyber Pakhtunkhwa Service Tribunal, Peshawar at Camp Court, Swat, wherein in pursuance of the judgement dated 07-04-2023 of Honorable Service Tribunal, Khyber Pakhtunkhwa and directions received from the Deputy Inspector General of Police, Internal Accountability Branch, Khyber Pakhtunkhwa, Peshawar vide Memo: No.1604-8/CPO/IAB, dated 18-10-2023, de-novo departmental proceedings were initiated on the same charges as under:-

He while posted as In-Charge OG, PG and Missing Persons in the office of the District Police Officer, Swat, on 23-05-2022, the District Police Officer, Swat checked the biometric attendance system, wherein it was found that abovenamed Computer Operator was absent from his lawful duties without prior permission or leave on 05-04-2022, 07-04-2022, from 11-04-2022 to 13-04-2023, from 19-04-2022 to 09-05-2022 and from 11-05-2022 up till dismissal from service i.e. 13-09-2022, which shows disinterest and malafide intention in the performance of lawful duties on his part.

He was issued a fresh Charge Sheet coupled with statement of allegations on the above-mentioned charges vide this office No.390-94/E, dated 09-01-2024 and the following Police Officers were deputed as Enquiry Committee/Panel by the Deputy Inspector General of Police, Internal Accountability Branch, CPO, Peshawar vide above-quoted reference:-

i) Mr. Ghulam Sadiq Khan, Addl: SP/Lower Swat.

ii) Mr. Naeem Khan, DSP/HQrs:, Swat.

The Enquiry Officers, conducting de-novo departmental enquiry against abovenamed delinquent Computer Operator, recorded statements of all concerned as well as the Computer Operator concerned and submitted their findings report vide No.21/R, dated 15-01-2024, wherein the Enquiry Officers intimated that above-named Computer Operator was deliberately absented from duty for a period of Ninety One (91) days without any genuine excuse as evident from his statement and also proved from the biometric system record and recommended that his previous punishment i.e. forfeiture of three years approved service as well as 91-days as leave without pay may be retained as such.

III. Besides the above, the Superintendent of Police, Investigation Wing, Swat vide his office Memo: No.209/E, dated 08-01-2024 intimated that the Computer Operator concerned has again absented himself from lawful duties without prior permission or leave w.e.f. 06-12-2023 up till now.

He was called in Orderly Room held in this office on 28-02-2024 and heard him in person, but he could not produce any plausible evidence to defend the charges leveled against him, foregoing in view, the above-mentioned facts, recommendations of the Enquiry Officers and his continued absence from duty till date, the undersigned is of the considered opinion that there are no chances that Computer Operator Muhammad Ali (BPS-16) of District Swat (Now Investigation Wing, Swat) will become an efficient Police official and his further retention in service is bound to affect the discipline of the entire force, therefore, I, Muhammad Ali Khan, PSP, Regional Police Officer, Malakand Region as a competent authority, am constrained to award him major punishment of "Compulsory Retirement from Service" from the date of his absence i.e. 06-12-2023.

# Subject: Departmental appeal against the order No. 3122-27/E dated 04-03-2024, received on 20-03-2024.

Respected Sir;

The Appellant submits as under;

- 1. That the Appellant joined the Police Force back in the year 2009 when whole of the Swat was under Tehrik Taliban Pakistan and no government writ was there.
- 2. That the Appellant performed his duties most efficiently with courage and regularly and not absented for a single day.
- 3. That due to the hard work and devotion the Appellant has got many good and excellent entries in his service record and that not a single bad entry is present in the complete record of the Appellant.
- 4. That the Appellant is regularly performing his duties and not a one day absence is present in the complete record.
- 5. That the Appellant dismissed from service on wrong and incorrect basis because the I never made a single absentee.
- 6. That the biometric system is not reading the Appellant fingerprint and I wrote many applications to change the system to eye reading. It was changed for a little time but again was removed and I was not given a reason.





- 7. That the Appellant challenged the order in Khyber Pakhtunkhwa Service Tribunal and it was set aside and de novo inquiry was ordered to be made.
- 8. That again I was Compulsory Retired from service by the order above against the law and rules.
- 9. That the order is also not correct as it is the on charges to which no inquiry is made and no charge sheet statement of allegations and no final show cause notice is issued.
- 10. That the inquiries are also not according to law and rules and I have been kept uninformed of the whole process.
- 11. That I have not any access to master computer of CPO to make changes of LTV to HTV and to post scanned photo on driving license. This not true and possible for me to make these changes.
- 12. That the order of compulsory retirement from service is illegal and against the law.
- 13. That I have been afforded any chance to defend myself or do cross examination.
- , 14. That I may be humbly given the chance of personal hearing.

It is, therefore, very humbly requested that on acceptance of this departmental appeal the order of compulsory retirement may be set aside and the Appeliant reinstated back into service with all back benefits.




