SERVICE APPEAL UNDER SECTION 4 OF KP SERVICE TRIBUNAL ACT, 1974 AGAINST THE AGAINST OFFICE /F.NO.7-**ENDST** NO.14037-41 ORDER **BEARING** 13/03/2024 ISSUED BY DATED I/EB/SDEO(M)/VOL:I RESPONDENT NO.3 VIDE WHICH THE EARLIER OFFICE ENDST. NC.11496-99/F.NO.1-ORDER **BEARING** 3/EB/ADJUSTMENT ORDER DATED 14/12/2023 WHEREBY THE APPELLANT WAS TRANSFERRED FROM GPS THEH TO GPS PHARHARI HAS BEEN WITHDRAWN IS ILLEGAL, UNLAWFUL, AGAINST THE POLICY OF GOVERNMENT ON TRANSFER / POSTING, HENCE, INEFFECTIVE UPON THE RIGHTS OF APPELLANT.

PRAYER: ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED OFFICE ORDER BEARING ENDST NO.14037-41 /F.NO.7-1/EB/SDEO(M)/VOL:I DATED 13/03/2024 ISSUED BY RESPONDENT NO.3 MAY KINDLY BE SET-ASIDE AND OFFICE ORDER DATED 14/12/2023 MAY GRACIOUSLY BE ORDERED TO BE RESTORED WITH DIRECTION TO RESPONDENT TO ALLOW THE PETITIONER TO CONTINUE PERFORMING HIS DUTIES AT GPS PHARHARI DISTRICT

It is respectfully submitted as under:-

- 1. That the post of appellant was upgraded in the year 2019 under the order of Honorable Peshawar High Court, Abbottabad Bench, however, the respondent issued order on 12/04/2023 from BPS-14 to BPS-15. Not only the order was issued after sufficient time but the appellant was also transferred to a far flung hilly area and that too about 70 KM away from the house of appellant.
- 2. That it is worth to mention here that the appellant is a heart patient, is unable to drive motorcycle and no local transport is available, therefore, the appellant requested the respondent for his transfer in any nearest station.
- 3. That the request of appellant was shelved, and when the appellant obtained medical leave another head teacher was posted who is still performing his duties. It is also worth to mention here that in the school of appellant only 35 students are enrolled.
- 4. That later on, vide office order bearing Endst. No.11496-99/F.No.1-3/EB/Adjustment order dated 14/12/2023 the appellant was transferred from GPS Theh to GPS Pharhari. Copy of order dated 14/12/2023 is attached as Annexure "A".
- 5. That after period of 03 months the transfer order dated 14/12/2023 of the appellant has been withdrawn by the respondent vide withdrawal / transfer order bearing

Endst. No.14037-41/F.No.7-1/EB/SDEO(M)/Vol:I dated 13/03/2024. Copy of withdrawal order dated 13/03/2024 is attached herewith as Annexure "B".

- 6. That the appellant tried his level best to convince the respondents to withdraw the impugned transfer office order dated 13/03/2024 and restoration of order dated 14/12/2023 but to no avail.
- 7. That thereafter, the appellant preferred departmental appeal before respondent No.2 and despite lapse of prescribed period, till, no decision whatsoever on the departmental appeal has been passed by respondent No.2. Copy of departmental appeal is attached as Annexure "C".
- 8. That since, the time prescribed for filing the instant appeal is going to be lapsed and the purpose of respondent No.2 behind not deciding the departmental appeal is deprive the appellant from redressal of his grievance through this Honorable Tribunal.
- 9. That the appellant has now come to this Honourable forum for setting aside the impugned transfer order interalia on the following grounds;-

## **GROUNDS:-**

a. That the impugned transfer order of the appellant dated 13/03/2024 is politically motivated and based on malafide intention. Hence, the impugned transfer order is liable to be set aside.

- b. That the impugned office order has been passed against the policy as premature transfer without any lawful justification is not warranted since, no lawful justification is available with the respondents to issue such premature transfer order, hence the impugned office order is liable to be set-aside.
- c. That the earlier order dated 14/12/2023 has been withdrawn by respondent vide impugned transfer order dated 13/03/2024 after passage of 03 months which is premature, against the tenure policy of the Civil servants. Hence, the appellant as per law and policy is entitled to be posted at GPS Pharhari District Haripur.
- d. That the impugned transfer order is perverse, discriminatory, against the natural justice and a blunt blow of hammer on the rights of appellant.
- motivation and influence. Despite of the fact that Section 10(2) of NWFP Civil Servant Act, 1973 provides that all government servants are prohibited to exert political, administrative or any other pressure upon the posting / transfer authorities for seeking posting / transfer of their choice and against the public interest, the respondent No.3 passed the impugned order which is totally against the law on the subject. Hence, liable to be set aside.
- f. That it is worth to mention here that the appellant has not been given any posting in any other school and the impugned withdrawal order dated 13/03/2024 is liable to be set-aside because the beneficiary of impugned order is an influential person having political backing.

- g. That respondents are well in the knowledge regarding the time prescribed for filing the instant appeal and the purpose of respondent No.2 behind not deciding the departmental appeal is to deprive the appellant from redressal of his grievance through this Honorable Tribunal. Hence, the impugned order followed by the act of respondents is liable to be set aside.
- h. That the instant appeal is well within time.

It is therefore, humbly prayed that on acceptance of instant appeal, the impugned office order bearing Endst No.14037-41 /F.No.7-1/EB/SDEO(M)/Vol: dated 13/03/2024 issued by respondent No.3 may kindly be set-aside and office order dated 14/12/2023 may graciously be ordered to be restored with direction to respondent to allow the petitioner to continue performing his duties at GPS Pharhari District Haripur. Any other relief which this honourable tribunal may deem fit and proper may also be granted to appellant.

## **INTERIM RELIEF:**-

In the meanwhile, the operation of office order bearing Endst No.14037-41 /F.No.7-1/EB/SDEO(M)/Vol:I dated 13/03/2024 issued by respondent No.3 may graciously be ordered to be suspended, till final decision of instant departmental appeal.


