SERVICE APPEAL UNDER SECTION 4 OF KP SERVICE TRIBUNAL: ACT, 1974 AGAINST THE TRANSFER / ADJUSTMENT ORDER **BEARING ENDST** NO.15455-51/F.NO.1-3/EB/ADJUSTMENT ORDER DATED 21/03/2024 ISSUED BY RESPONDENT WHEREBY APPELLANT HAS BEEN TRANSFERRED FROM GPS DHERI SIKANDAR PUR TO GPS BAYAN AHMED ALI KHAN IS ILLEGAL, UNLAWFUL, AGAINST THE POLICY **GOVERNMENT** OF TRANSFER // POSTING, HENCE, INEFFECTIVE UPON THE RIGHTS OF APPELLANT.

PRAYER: ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED TRANSFER / ADJUSTMENT ORDER BEARING ENDST NO. 15455-51/F.NO.1-3/EB/ADJUSTMENT ORDER DATED 21/03/2024 ISSUED BY RESPONDENT MAY GRACIOUSLY BE SET-ASIDE AND RESPONDENT MAY KINDLY BE DIRECTED TO ALLOW THE APPELLANT TO CONTINUE PERFORMING HIS DUTIES AT GPS DHERI SIKANDAR PUR DISTRICT HARIPUR. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL MAY DEEM FIT AND PROPER MAY ALSO BE GRANTED TO APPELLANT.

It is respectfully submitted as under:-

- 1. That the appellant was appointed as a PST Teacher on 17/10/2005, with his initial posting in the Khanpur area, specifically Jab Kali Tarar. Subsequently, the appellant was transferred from an out-of-city location to the Central Jail Area. Following this, the appellant received promotions over time and in 2022, he was promoted to PSHT and transferred to Biyan Ahmed Ali Khan, where he diligently performed his duties. However, on 12/06/2023, the appellant was transferred to GPS Dheri School, where his tenure lasted only 09 months. Subsequently, on 21/03/2024, the appellant was transferred back to Bayan Ahmed Ali Khan which act of respondent is against the law and misuse of authority. Copy of transfer order dated 21/03/2024 is attached as Annexure "A".
- 2. That the appellant exerted utmost effort to persuade the respondent to retract the challenged transfer office order, however, all attempts proved futile as the respondent remained unyielding in his decision.
- 3. That the appellant tried his level best to convince the respondents to withdraw the impugned transfer office order dated 21/03/2024 but to no avail.
- 4. That thereafter, the appellant preferred departmental appeal before respondent No.2 and despite lapse of prescribed period, till, no decision whatsoever on the departmental appeal has been passed by respondent No.2. Copy of departmental appeal is attached as Annexure "B".
- 5. That since, the time prescribed for filing the instant appeal is going to be lapsed and the purpose of respondent No.2 behind not deciding the departmental

appeal is deprive the appellant from redressal of his grievance through this Honorable Tribunal. Hence,

6. That the appellant has now come to this Honourable forum for setting aside the impugned transfer order interalia on the following grounds;-

GROUNDS:-

- a. That the impugned transfer order of the appellant dated 21/03/2024 is politically motivated and based on malafide intention. Hence, the impugned transfer order is liable to be set aside.
- b. That the impugned office order has been passed against the policy as premature transfer without any lawful justification is not warranted since, no lawful justification is available with the respondents to issue such premature transfer order, hence the impugned office order is liable to be set-aside.
- c. That the appellant almost remained out of station at far flung areas and now he is entitled to be transfer / adjusted to a nearest station.
- d. That the impugned transfer order is perverse, discriminatory, against the natural justice and a blunt blow of hammer on the rights of appellant.
- e. That the respondent with malafide intention and in order to give benefit to persons of their choice transfer and posted the appellant. Hence the impugned transfer order is liable to be set-aside.

- f. That the impugned order is the result of political motivation and influence. Despite of the fact that Section 10(2) of NWFP Civil Servant Act, 1973 provides that all government servants are prohibited to exert political, administrative or any other pressure upon the posting / transfer authorities for seeking posting / transfer of their choice and against the public interest, the respondent No.3 passed the impugned order which is totally against the law on the subject. Hence, liable to be set aside.
- g. That respondents are well in the knowledge regarding the time prescribed for filing the instant appeal and the purpose of respondent No.2 behind not deciding the departmental appeal is to deprive the appellant from redressal of his grievance through this Honorable Tribunal. Hence, the impugned order followed by the act of respondents is liable to be set aside.
- h. That the instant appeal is well within time.

It is therefore, humbly prayed that on acceptance of instant appeal, the impugned transfer / adjustment order bearing Endst No.15455-51/F.No.1-3/Eb/Adjustment order dated 21/03/2024 issued by respondent No.3 may graciously be set-aside and respondent may kindly be directed to allow the appellant to continue performing his duties at GPS Dheri Sikandar Pur District Haripur. Any other relief which this Honourable Tribunal may deem fit and proper may also be granted to appellant.

INTERIM RELIEF;-

In the meanwhile, the operation of impugned transfer / adjustment order bearing Endst No.15455-51/F.No.1-3/Eb/Adjustment order dated 21/03/2024 issued by respondent No.3 may graciously be ordered to be suspended, till final decision of instant departmental appeal.
