SERVICE APPEAL UNDER SECTION 4 OF KP SERVICE TRIBUNAL ACT, 1974 AGAINST THE OFFICE ORDER BEARING ENDST. NO. 13934-37 / TRANSFER / POSTING DATED 12/03/2024 ISSUED BY RESPONDENT NO.3 VIDE WHICH THE APPELLANT AGAIN TRANSFERRED FROM GMS BANDI MIAN PIR DAD TO GHS KARPILIAN IS DISTRICT **HARIPUR** ILLEGAL. UNLAWFUL, POLICY **OF** GOVERNMENT AGAINST THE TRANSFER / POSTING, HENCE, INEFFECTIVE UPON THE RIGHTS OF APPELLANT.

PRAYER: ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED THE OFFICE ORDER BEARING ENDST. NO. 13934-37 / TRANSFER / POSTING DATED 12/03/2024 ISSUED BY RESPONDENT NO.3 MAY KINDLY BE SET-ASIDE AND APPELLANT BE ALLOWED TO CONTINUE PERFORMING HIS DUTIES AT GMS MANDI MIAN PIR DAD DISTRICT HARIPUR. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL MAY DEEM FIT AND PROPER MAY ALSO BE GRANTED TO APPELLANT.

- 1. That the appellant was appointed in education department and was appointed in the year 1997 and after performing his duties as such in different schools as PST, SPST. Thereafter, in the year 2017 the appellant was promoted from SPST to C.T and was transferred to Government Middle School Serian Dharm Pani.
- 2. That thereafter after completion of tenure of 03 years at GMS Serian Dharm Pani, the appellant was transferred to Government Middle School Bandi Mian Pir Dad.
- 3. That to the utter surprise of appellant, just after few months, the appellant was again transferred from GMS Bandi Mian Pir Dad to GHS Karpilian District Haripur vide impugned office order bearing Endst. No. 13934-37 /Transfer / Posting dated 12/03/2024. Copy of the impugned transfer order dated 12/03/2024 is attached as Annexure "A".
- 4. That the appellant tried his level best to convince the respondents to withdraw the impugned transfer office order but to no avail.
- 5. That thereafter, the appellant preferred departmental appeal before respondent No.2 and despite lapse of prescribed period, till, no decision whatsoever on the departmental appeal has been passed by respondent No.2. Copy of departmental appeal is attached as Annexure "A".
- 6. That despite lapse of prescribed period, till, no decision whatsoever on the departmental appeal has been passed by respondent No.2.

- 7. That since, the time prescribed for filing the instant appeal is going to be lapsed and the purpose of respondent No.2 behind not deciding the departmental appeal is deprive the appellant from redressal of his grievance through this Honorable Tribunal.
- 8. That the appellant has now come to this Honourable forum for setting aside the impugned transfer order interalia on the following grounds;-

GROUNDS;-

- a. That the impugned transfer order of the appellant dated 12/03/2024 is politically motivated and based on malafide intention. Hence, the impugned transfer order is liable to be set aside.
- b. That the impugned office order has been passed against the policy as premature transfer without any lawful justification is not warranted since, no lawful justification is available with the respondents to issue such premature transfer order, hence the impugned office order is liable to be set-aside.
- c. That the earlier transfer order of appellant at GMS Bandi Mian Pir Dad has not been considered by respondents and vide impugned transfer order dated 12/03/2024 after passage of few months which is premature, against the tenure policy of the Civil servants. Hence, the appellant as per law and policy is entitled to be posted at GMS Bandi Mian Pir Dad, District Haripur.

- d. That the impugned transfer order dated 12/03/2024 is perverse, discriminatory, against the natural justice and a blunt blow of hammer on the rights of appellant.
- e. That the impugned order is the result of political motivation and influence. Despite of the fact that Section 10(2) of NWFP Civil Servant Act, 1973 provides that all government servants are prohibited to exert political, administrative or any other pressure upon the posting / transfer authorities for seeking posting / transfer of their choice and against the public interest, the respondent No.3 passed the impugned order which is totally against the law on the subject. Hence, liable to be set aside.
- f. That respondents are well in the knowledge regarding the time prescribed for filing the instant appeal and the purpose of respondent No.2 behind not deciding the departmental appeal is to deprive the appellant from redressal of his grievance through this Honorable Tribunal. Hence, the impugned order followed by the act of respondents is liable to be set aside.
- g. That the instant appeal is well within time.

It is therefore, humbly prayed that on acceptance of instant appeal, the impugned office order bearing Endst. No. 13934-37 / transfer / posting dated 12/03/2024 issued by respondent No.3 may kindly be set-aside and appellant be allowed to continue performing his duties at GMS Mandi Mian Pir Dad District Haripur. Any other relief which this honourable tribunal may deem fit and proper may also be granted to appellant.
