SERVICE APPEAL UNDER SECTION 4 OF KP SERVICE TRIBUNAL ACT, 1974, FOR DECLARATION TO THE EFFECT THAT TRANSFER / ADJUSTMENT ORDER BEARING ENDST NO.14284-86/F.NO.1-3/EB/ADJUSTMENT ORDER DATED 18/03/2024 ISSUED BY RESPONDENT WHEREBY APPELLANT HAS BEEN TRANSFERRED FROM GHS ALOLI TO GHS B.P DHERI DISTRICT HARIPUR IS ILLEGAL, UNLAWFUL, AGAINST THE POLICY OF GOVERNMENT ON TRANSFER / POSTING, HENCE, INEFFECTIVE UPON THE RIGHTS OF APPELLANT.

PRAYER: ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED TRANSFER / ADJUSTMENT ORDER BEARING ENDST NO.14284-86/F.NO.1-3/EB/ADJUSTMENT ORDER DATED 18/03/2024 ISSUED BY RESPONDENT NO.3 MAY GRACIOUSLY BE SET-ASIDE AND RESPONDENTS MAY KINDLY BE DIRECTED TO ALLOW THE APPELLANT TO CONTINUE PERFORMING HIS DUTIES AT GHS ALOLI DISTRICT HARIPUR. ANY OTHER RELIEF WHICH THIS HONOURABLE FORUM MAY DEEM FIT AND PROPER MAY ALSO BE GRANTED TO APPELLANT.

- Government High School (GHS) Aloli, was diligently executing his duties. However, the respondent, through Endorsement No. 14284-86/F.NO.1-3/EB/Adjustment Order dated 18/03/2024, issued a transfer directive relocating the appellant from his current posting at GHS Aloli to Government High School B.P Dheri, an area situated at a considerable distance from his present location, thus designating it as a far-flung area. Copy of transfer order dated 18/03/2024 is attached as Annexure "A".
- 2. That the appellant exerted utmost effort to persuade the respondent to retract the challenged transfer office order, however, all attempts proved futile as the respondent remained unyielding in his decision.
- 3. That thereafter, the appellant preferred departmental appeal before respondent No.2 and despite lapse of prescribed period, till, no decision whatsoever on the departmental appeal has been passed by respondent No.2. Copy of departmental appeal is attached as Annexure "B".
- 4. That since, the time prescribed for filing the instant appeal is going to be lapsed and the purpose of respondent No.2 behind not deciding the departmental appeal is deprive the appellant from redressal of his grievance through this Honorable Tribunal. Hence,
- 5. That the appellant has now come to this Honourable forum for setting aside the impugned transfer order interalia on the following grounds;-

GROUNDS:-

- a. That the impugned transfer order of the appellant dated 18/03/2024 is politically motivated and based on malafide intention. Hence, the impugned transfer order is liable to be set aside.
- b. That the impugned office order has been passed against the policy as premature transfer without any lawful justification is not warranted since, no lawful justification is available with the respondents to issue such premature transfer order, hence the impugned office order is liable to be set-aside.
- c. That the impugned transfer order is perverse, discriminatory, against the natural justice and a blunt blow of hammer on the rights of appellant.
- d. That even otherwise in between GHS Aloli and GHS B.P Dheri there are 5 to 7 schools wherein posts of Sr. PET are vacant and the appellant could have easily been adjusted, but the respondent with malafide intention and in order to give benefit to a persons of their choice, transfer and posted the appellant. Hence the impugned transfer order is liable to be set-aside.
- e. That the impugned order is the result of political motivation and influence. Despite of the fact that Section 10(2) of NWFP Civil Servant Act, 1973 provides that all government servants are prohibited to exert political, administrative or any other pressure upon the posting / transfer authorities for seeking posting / transfer of their choice and against the public interest, the respondent No.3 passed the impugned order which is totally against the law on the subject. Hence, liable to be set aside.
- f. That respondents are well in the knowledge regarding the time prescribed for filing the instant appeal and the purpose of respondent No.2 behind not deciding the departmental appeal is to deprive the appellant from

redressal of his grievance through this Honorable Tribunal. Hence, the impugned order followed by the act of respondents is liable to be set aside.

That the instant appeal is well within time. g.

> It is therefore, humbly prayed that on acceptance of instant appeal, the impugned transfer / adjustment order bearing Endst No.14284-86/F.No.1-3/EB/Adjustment Order 18/03/2024 issued by respondent No.3 may graciously be setaside and respondents may kindly be directed to allow the appellant to continue performing his duties at GHS Aloli District Haripur. Any other relief which this Honourable Forum may deem fit and proper may also be granted to appellant.

INTERIM RELIEF;-

In the meanwhile, the operation of office order bearing. Endst No.14284-86/F.No.1-3/EB/Adjustment Order dated 18/03/2024 issued by respondent No.3 may graciously be ordered to be suspended, till final decision of instant departmental appeal.
