Para-wise comments on behalf of respondents.

Respectfully Sheweth.

That the respondents submit as under:-

PRELIMINARY OBJECTIONS:-

- 1. That the instant Service Appeal is not maintainable in the present form.
- 2. That the appellant is estopped by his own conduct to file the instant appeal.
- 3. That the appellant has not come to the Hon'ble Tribunal with clean hands.
- 4. That the appellant has suppressed material facts from the Hon'ble Tribunal.
- 5. That the instant Service Appeal is barred by law and limitation.

ON FACTS:-

- 1. In reply to this para it is submitted that the appellant SI Abdul Khaliq No. H/199 was retired from service on attaining the age of superannuation on 04.09.2022 vide SP Investigation, Abbottabad Notification No. 3776/Retirement dated 06.09.2022 (Copy of retirement notification is attached as Annexure "A").
- 2. That the appellant was appointed as constable on 24.09.1980 in Police Department and after qualifying mandatory courses, he was promoted to the rank of offg: ASI by Regional Police Officer, Hazara vide vide order No. 4568-80/E dated 08.04.2008. Later on after completion of probation period, the appellant was promoted to the rank of offg: SI vide Regional Police Officer, Hazara Order No. 16614-27/E dated 17.10.2014. (Copies of promotion orders are enclosed as Annexure "B").

- 3. In reply to this para, it is submitted that the name of appellant was brought on list "F" vide Notification No. 127 / E-III dated 11.01.2019 by the competent authority. (Copy of Notification is attached as Annexure "C").
- 4. In reply to this para, it is submitted that a letter seeking requisite information from Police authorities/ units vide No. CPO / CPB/ DPC/ 60 dated 22.02.2022 for conduct of DPC in the 1st week of the March, 2022 was circulated for submission of information regarding the sub inspectors (BPS-14) to the rank of officiating Inspector (BPS-16), in which the name of the appellant was also mentioned at Serial No. 92 for provision of information. (Copy of letter is enclosed as Annexure "D").
- 5. Pertains to record. Moreover, the name of the appellant was placed at serial No. 182 in Notification of list "F" vide No. 127/E-III dated 11.01 2019 and respondent No. 6 & 7 were at serial No. 208 and 219 and respondent No. 08 was brought on list "F" at serial No. 15 vide Notification No. 576 /E-III darted 14.02.2020. (Copy of Notification is attached as Annexure "E")
- 6. Subject to proof
- 7. In reply to this para it is submitted that the following 04 confirmed Sub Inspectors of list "F" who were on the verge of retirement were promoted to the rank of officiating Inspector (BPS-16) vide Notification No. 641/E-III dated 30.03.2022 (Copy of Notification is attached as Annexure "F"). They were promoted keeping in view their superannuation age. It is worth mentioning that appellant was still in service and had to retire on superannuation later on. Therefore, the appellant has no legal claim against the promotion order of respondents as there were so many senior Sub-Inspectors to the appellant at list "F" who could not be promoted in the DPC held on 30.03.2022. Therefore, the claim of the appellant is devoid of legal force.
- 8. Incorrect, the appellant was not eligible for promotion to the rank of officiating Inspector on any legal ground. He retired on 04.09.2022 till that no DPC was held, therefore, the appellant's claim is against the law, rules, regulations and govt: policy.
- 9. Incorrect, that the appellant has no legal claim for promotion to the rank of officiating inspector as he had retired from service on 04.09.2022. The instant service appeal is badly time barred and not maintainable.
- 10. Incorrect, the appellant is generating false stories to get undue advantage not warranted under the law/ rules.
- 11. Incorrect, the instant service appeal is badly time barred and appellant is adducing false claim.

12. Incorrect, the appellant has no locus standi to file the instant service appeal. Moreover, the instant service appeal is not maintainable under the law/rules and policy.

GROUNDS:-

- a. Incorrect, the notification with respect to the respondent No. 6,7 & 8 who were retired from service on superannuation of 60 years of age is lawful and maintainable. The appellant was serving when DPC dated 30.03.2022 was held and only 04 confirmed SIs (respondent No. 6, 7 & 8) were promoted, the appellant had length of service in his credit and he did not apply for promotion to the rank of offg: Inspector before retirement on attaining age of superannuation, therefore, his claim is based on his presumptions and assumptions.
- b. Incorrect, the appellant was treated in accordance with law, rules, regulations and policies. Promotion and conduct of DPC is not vested right of civil servant rather it is the discretion of competent authority. The appellant was serving and had length of service at his credit and till his retirement no subsequent DPC for promotion of offg. Inspector was held.
- c. Incorrect, the appellant was dealt with in accordance with law, rules and govt: policy, fair play and principles of natural justice.
- d. Incorrect, the competent authority proceeded fairly, justly in accordance with law, rules and govt policy and issued the notification for promotion of respondents who were at the verge of superannuation.
- e. Incorrect, respondent No. 6, 7 & 8 were promoted as officiating inspectors vide Notification No. 641/E-III dated 30.03.2022 keeping in view their retirement which was due on 31.03.2022. It is worth mentioning that appellant did not apply for the promotion as officiating inspector with those who had earlier applied for promotion and DPC was conducted to consider their cases. The appellant was still in service and no subsequent DPC for promotion of officiating inspectors was held, in the meanwhile the appellant had retired from service on 04.09.2022, there were so many confirmed sub inspectors above/ senior to the appellant who could not be promoted to the rank of officiating inspectors, his colleagues were promoted as officiating inspectors vide Notification No. 233 /E-II dated 19.04.2023.
- f. Incorrect, the Notification of promotion of officiating inspectors consequent upon the recommendation of DPC dated 30.03.2022 is lawful and maintainable.
- g. The instant service appeal is not maintainable being time barred and devoid of any legal force.

h. The respondents with the permission of this Honourable Tribunal will adduce any other grounds / points at the time of hearing of service appeal.

PRAYER,

In view of above, it is most humbly prayed that the instant Service Appeal does not hold any legal force which may graciously be dismissed with costs.


