#### **Preliminary Objections**

- 1. That the appellant has got no cause of action.
- 2. That the appeal is badly barred by law and limitation.
- 3. That the appellant has been estopped by his own conduct to file the instant appeal.
- **4.** That the appeal is not maintainable in its present form.
- **5.** That the appellant has not come to the Honourable Tribunal with clean hands.
- **6.** That the appeal is bad for mis-joinder and non-joinder of necessary parties.

#### REPY ON FACTS

- 1. Para to the extent of appointment of appellant as constable in respondent department is correct, while rest of the para is incorrect as prior to the instant dismissal, appellant had earlier been dismissed from service due to absence of duty. However, he was reinstated into service by the appellate authority. Both the dismissal orders dated 30.11.2013 & 06.12.2023 are annexed as 'A & B'.
- 2. Incorrect. On 17.08.2023 an accused namely Waqar s/o Noor Islam r/o Tetara Taru Jaba was arrested with a pistol within the premises of Judicial Complex Charsadda. When the accused was interrogated, he stated that he has been hired for Rs. 25-lacs for the murder of Wahid etc. He further revealed that he had been provided the pistol in the Judicial Complex by the appellant. Therefore, he was charged in the case FIR No.901 dated 17.08.2023 u/s 120/120-B/15-AA/34 Police Station Charsadda. Copy of FIR No.901 is **annexed as 'C'**.
- **3.** Para is pertains to record.



- 4. Para is correct to the extent that appellant was issued Charge Sheet with Statement of allegations and DSP Sardheri was nominated as enquiry officer. The enquiry officer heard the appellant in person who (appellant) provided his written statement. In addition statement of Moharrar Police Station City as well as CIO of PS City were also recorded. The enquiry officer after fulfillment of legal and all codal formalities recommended the appellant for major punishment. Charge Sheet & Statement of allegation is annexure 'D' & enquiry is annexure 'E'.
- 5. Para already explained above.
- 6. Para correct to the extent that appellant was issued Show Cause Notice to which he submitted his reply but the same was found unsatisfactory. Copy of Show cause notice & his reply is **annexed as 'F'**.
- 7. Para correct to the extent that appellant moved departmental appeal against the punishment order but the same was filed being devoid of merit. Copy of departmental appeal & rejection order is annexed as 'G'. Appellant then moved revision petition before Respondent No.1 but the same was also filed being time barred. Copy of revision petition & rejection order is annexed as 'H'.
- 8. Appeal of the appellant is liable to be dismissed inter alia on the following grounds;

#### GROUNDS

1)

- A. Incorrect. All the orders passed against the appellant are in accordance with law and facts, therefore, are liable to be maintained.
- B. Incorrect. Proper enquiry was conducted in the matter and during the course of enquiry appellant was not only heard but his statement was also recorded. There was sufficient ground against the appellant as he was directly charged in FIR, therefore, the enquiry officer recommended him for major punishment.
- C. Incorrect. On 17.08.2023 an accused namely Waqar s/o Noor Islam r/o Tetara Taru Jaba was arrested with a pistol within the premises of Judicial Complex Charsadda. When the accused was interrogated, he stated that he has been hired for Rs. 25-lacs for the murder of Wahid etc. He further revealed that he had been provided the pistol in the Judicial Complex by the appellant.
- D. Para already explained above.

- **G.** Para is for the appellant to prove.

- H. That as besides being charged in a criminal case, appellant had remained absent from duty for 49-days without any leave or prior permission from his senior officers, therefore, while awarding him major punishment of dismissal from service, his absence period i.e 49-days was treated as without pay.
- I. Para is for the appellant to prove that he was denied provision of enquiry report.
- J. Para already explained.
- K. Para already explained.
- L. That the respondents may also be allowed to advance additional grounds/documents at the time of hearing before this Hon'ble Tribunal.

#### PRAYER:

Keeping in view the facts above, it is therefore humbly prayed that the appeal of appellant, being devoid of merits and substance, may kindly be dismissed with cost, please.

#### O.R.D.E.R

This office order relates to the dispose of departmental Enquiry Constable Amin Shah No. 2165 of FRP HQrs: Peshawar, who remained absent, from official duty w.e. from 15,09,2013.

In this regard formal departmental proceedings were initiated against him and I/C Mess/FRP, HQrs; was nominated as Enquiry Officer. He conducted enquiry into the matter and submitted his findings wherein the accused official Constable Amin Shah No. 2165 has been found guilty of the charge and recommended him for major punishment.

Upon the findings of the Enquiry Officer Constable Amin Shah No. 2165 has been issued Final Show Cause Notice, Which was duly delivered upon him on his home address an d his signature was taken as token of its receipt. His reply to Final Show Cause Notice has not been received in the stipulated period of (15) days. He was summoned for personal hearing but failed to do so.

Keeping in view the finding/recommendations of the Enquiry Officer and other material available on recorded the accused Constable Amin Shah No. 2165 stand guilty of gross misconduct under the relevant law/rules. His service record also shows that he was repeatedly absent from official duty on one pretext or the other during his short span of service. He has been given ample opportunity to reform himself by giving him repeated warning but he failed to mend his habits. It is evident that he is not fit for Police service which requires discipline coupled with punctual performance of official duty especially in prevailing law & order milieu. He has also become a source of in disciplinary inclinations for rank and file due to his repeated absences from and casual/ irregular attitude towards official duty/responsibilities.

Therefore, in view of the above circumstances the defaulter Constable Amin Shah No. 2165 is hereby discharged from service under Police Rules, 1975 with immediate effect.

### ORDER

This order will dispose-off the departmental enquiry against Constable Amin Shah No. 1188, while posted at PS Charsadda, Involved/charged in case FIR No. 901, dated 17.08.2023 u/s 120/120-B/15-AA/34 PPC PS Charsadda and also remained absent from his lawful duty w.e from 16.08.2023 to 03.10.2023 (49-days) without any leave or prior permission from his senior officers. Absence report recorded vide D.D No. 46 dated 16.08.2023. His act is not only objectionable but stigmatized the force name.

On the above allegations he was suspended and closed to police lines Charsadda vide O.B No. 1129 dated 18.08.2023 and was issued Charge Sheet together with statement of allegations under, Section 5 Sub Section 3 of Police Rules 1975 and Mr. Sanober Shah Khan the then DSP Sardheri was nominated as inquiry officer for probing into the matter by conducting departmental inquiry against him but after his posting as SP Investigation Charsadda the instant enquiry was entrusted to Mr. Nasar Ullah Khan DSP HQrs Charsadda (with the additional charge of Sardheri Circle) and he after fulfillment of codal formalities has submitted his findings, recommending him for major punishment upon his 49-days absence from duty and confession of his guilt as evident from the statement of I.O of the case Sub-Inspector Noor Ali which is on enquiry file at Annex-

Subsequently, Constable Amin Shah No. 1188, was issued Final Show Cause Notice U/S 5(3) Police Rules 1975 reply to which was received.

On 05.12.2023 the delinquent official was summoned for orderely room and was heared personaly in detail, but he failed to satisfy the undersigned with his reply. After perusal of the enquiry papers & recommendation of the enquiry officer and hearing him in person, The undersigned reached to the conclusion that the official has nothing to putup in his defence, hence he is hereby awarded the Major punishment of dismissal from service with immediate effect and his absence period i.e 49days is also treated as without pay.

DEPARTMENTAL ENQUIRY AGAINST CONSTABLE AMIN SHALL NO. 1188 POSTED AT JUDICIAL COMPLEX CHARSADDA

ALLEGATIONS:

The subject inquiry was referred to this office vide Endst: No. 1490-91/HC, dated 25.08.2023 for proceeding under the law with respect to the charges that Constable Amin Shah No. 1188 posted at Judicial Complex Charsadda, involved/charged in case FIR No. 901, dated 17.08.2023 u/s 120/120-B/15-AA/34 PPC PS Charsadda and also remained absent from his law full duty w.e from 16.08.2023 till date without any leave or prior permission from his senior officers. Absence report recorded vide DD No. 46 dated 16.08.2023. His act is highly objectionable and also stigmatized the force name. This amounts to grave misconduct on his part which warranting departmental action against him.

#### PROCEEDINGS:

- On 07.09.2023 the MASI PS City was contacted on PTCL to provide information about the alleged official FC Amin Shah No. 1188. In response the MASI PS City stated that as per report of on duty Mobile Officer the alleged official is in sub-jail Charsadda.
- 2. Written Parwana was issued to SHO PS City (Place on file as annexure "A") to provide details regarding FIR No. 901 dated 17.08.2023 u/s 120/120-B/15-AA/34 PPC PS Charsadda, but no reply received to till date.
- On 06.10.2023 the alleged official FC Amin Shah No. 1188 comes to the office of the undersigned, heard in person, he provided his written statement (Place on file as annexure "B") wherein he stated that he was posted in PS City on general duty, the enmity of his cousins are going on, both party are his cousins and enmity with each others, so they are close relatives and he do not belong to any side due to enmity, he was in his house on the day of incident, a case was register against him in the City Police Station vide FIR No. 901 dated 17.08.2023 u/s 120/120-B/15-AA/34 PPC PS Charsadda, after the incident on next day he got BBA which was canceled and he was arrested and closed to sub-jail Charsadda, he has ten 10 years service and performed his duty with good manners, in his ten 10 years service he never been absent the claims made against him are out of personal grudge and malice and have been framed, he have no connections with anyone from either side and not aware of all the claims that have been made against him, written statement based on the facts, ile requested that his departmental inquiry would be filed without any action,
- 4. On 18.09.2023 FC Amin Shah No. 1188 made bail from Peshawar High Court Peshawar (Place on file as annexure "C"). Vide DD No. 40 dated 04.10.2023 he arrived at PS City (Place on file as annexure "D") and DD No. 13 annexure "E").

Written Parwana (Place on file as annexure "F") issued to Security In-charge Judicial Complex Charsadda to submit their written statement in connection with case FIR No. 901, dated 17,08,2023 u/s 120/120-B/15 AV 24 PPC PS Charsadda about which he verbally stated that to approached Judicial Complex for the CCTV recording.

In response to this office written Parwana (Place on file as annexure "G") Muharrar PS City was directed to provide their written statement in connection with above mentioned FIR. He provided his statement Wace on file as annexure "II") wherein he stated that FC Amin Shalt No. 1188 was posted on general duty in PS City, as per the report of Javed Khan ASI that alleged official Amin Shah absented himself from lawful duty vide DD No. to dated 16 08,2023, he was charged in above quoted FIR and suspended by the High ups vide OB No. 1128 dated, he was arrested and closed to sub juil Charsadda, after bail from Peshawar High Court Peshawar he arrival vide DD 1 No. 40 dated 04,10,2023 and closed to Police Lines Charsadda vide DD No. 41 dated 04,10,2023,

Written Parwana (Place on file as annexure "I") issued to CIO PS City to submit their written statement in connection with above mentioned FIR. SI Noor Ali Khan the then OI PS City provided his written statement (Place on file as annexure "J") wherein he stated that accused Waqar s/o Noor-ul islam r/o Titara Taro Jaba was arrested inside the Judicial Complex Charsadda being interrogated he said that it had been agreed with him to kill the accused Wahid etc for 25 lack rupees, his target to kill Wahid etc, all these circumstances have been described by the accused Waqar himself which is written in the FIR. He further stated that the accused Shair Ullah brought the pisiol to Judicial Complex and Amin Shah s/o Shahi Gul r/o Prao Nisatta took the pistol inside the Judicial Complex Charsadda and referred him there to accused Wagar, both the accused Shair Ullah and Wagar recorded their statement under section 161 CrPC that Amin Shah referred the pistol to accused Wagar inside the Judicial Complex, and accused Amin Shah also recorded his written statement under section 161 CrPC that he has referred the pistol to accused Wagar inside the Judicial Complex.

CONCLUSION AND RECOMMENDATIONS:

After conducting proper enquiry into the matter, the undersigned reached to the conclusion that Constable Amin Shah No. 1188 was charged in case FIR No. 901, dated 17.08.2023 u/s 120/120-B/15-AA/34 PPC PS Charsadda he was suspended and closed to Police Lines, he got made bail from Peshawar High Court Peshawar the case is under trail in the Court. His absence period wie from 16,08,2023 to 03,10,2023, (total= 49 days) being a member of the discipline force his involvement/charge in a criminal case is objectionable, which earns bad name for the force and also leads to his

Therefore, it is recommended that the alleged official Constable Vinn Shah No. 1188 may be award "Major Punishment" under the KP Potice Kules 1975,



ORDER.

This order will dispose off the departmental appeal preferred by Ex-Constable Ameen Shah No. 1188 of Charsadda District Police against the order of the then District Police Officer, Charsadda, whereby he was awarded major punishment of dismissal from service vide OB: No. 1542 dated 06.12.2023. The appellant was proceeded against departmentally on the allegations that he while posted at Police Station Charsadda, Involved/charged in case vide FIR No. 901. dated 17.08.2023 u/s 120/120-B/15-AA/34 PPC Police Station, Charsadda and also absented himself from his lawful duty with effect from 16.08.2023 to 03.10.2023 (49days) without any leave or prior permission from his senior officers. Absence report was recorded vide daily diary No. 46 dated 16.08.2023.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and the then Sub Divisional Police Officer (SDPO) Sardheri, Charsadda was nominated as Enquiry Officer. But after his posting as Acting Superintendent Police, Investigation, Charsadda the instant enquiry was entrusted to Deputy Superintendent of Police, Headquarters, Charsadda (with the additional charge of Sardheri Circle). The Enquiry Officer after fulfilling codal formalities, submitted his findings wherein he recommended the delinquent Officer for major punishment upon his 49 days absence from duty and confession of his guilt as evident from the statement of Investigation Officer of the case Sub Inspector Noor Ali Khan which was placed on enquiry file.

He was issued Final Show Cause Notice to which his reply was received and found unsatisfactory.

On 05.12.2023, the delinquent Officer was summoned for orderly room and was heard personally in detail, but he failed to satisfy the then District Police Officer, Charsadda, After perusal of the enquiry papers & recommendation of the enquiry officer and hearing him in person, he was awarded major punishment of dismissal from service with immediate effect and his absence period i.e 49-days is also treated as without pay.

Feeling aggrieved from the order of the then District Police Officer. Charsadda, the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in this office on 24.01.2024.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations leveled against the appellant have been proved beyond any shadow of doubt. Moreover, the involvement of appellant in this heinous criminal case is clearly a stigma on his conduct. Hence, the retention of appellant in Police Department will stigmatize the prestige of entire Police Force as instead of fighting crime, he has himself indulged in criminal activities. He could not present any cogent justification to warrant interference in the order passed by the competent authority.

Keeping in view the above, I, Muhammad Suleman, PSP Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, therefore, the same is rejected and filed, being devoid of merity
