PRELIMINARY OBJECTIONS

- 1. That the appellant has not approached this Hon'ble Tribunal with clean hands.
- 2. That the appellant has concealed the actual facts from this Hon'ble Tribunal.
- 3. That the appellant has got no cause of action or locus standi to file the instant appeal.
- 4. That the appellant is estopped by his own conduct to file the instant Service Appeal.
- 5. That the appeal is unjustifiable, baseless, false, flawless and vexatious and the same is liable to be dismissed with special compensatory cost in favour of respondents.
- 6. That the Hon'ble Tribunal has no jurisdiction to adjudicate the matter.
- 7. That the appeal is bad for miss-joinder and non-joinder of necessary parties.

REPLY ON FACTS

- 1. Para to the extent of enlistment in Police Department as Constable pertains to record needs no comments.
- 2. Incorrect. Stance of appellant is baseless, because every Police Officer is under obligation to perform his duty upto the entire satisfaction of his superiors, because his performance was not satisfactory and he is habitual absentee. Moreover, the perusal of service record of the appellant revealed that due to his lethargic attitude his entire service record is tainted with bad entries (Copies of list of bad entries is attached as Annexure A).
- 3. Incorrect. Plea taken by the appellant is not plausible, because being a member of disciplined force he was supposed to inform his seniors about his mother's illness or submit application for leave but he failed to do so and remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.2021, this attitude of the appellant clearly showed that he was no more interested in Police Department, which is gross misconduct under the Police Rules, 1975.
- 4. Incorrect. Para for the appellant to prove.

- 5. Incorrect. Stance taken by the appellant is not plausible because he while posted at Police Station Sheikh Maltoon, remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.2021 till date of dismissal. On account of aforementioned allegations, the appellant was issued Charge Sheet with Statement of allegations vide No. 181/PA dated 02.08.2021 and enquiry was entrusted to Mr. Sadat Ali the then DSP Security Mardan.
- 6. Incorrect. Stance taken by the appellant is not plausible because he while posted at Police Station Sheikh Maltoon, remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.202 till date of dismissal. On account of aforementioned allegations, the appellant was issued Charge Sheet with Statement of allegations and enquiry was entrusted to Mr. Sadat Ali the then DSP Security Mardan, which was received by the appellant on 14.08.2021. During the course of enquiry the appellant was contacted time and again to appear before the enquiry officer but neither did he appear before the enquiry officer nor did he submit his reply. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended the delinquent officer for major punishment. In light of above, the appellant was called for Orderly Room on 03.11.2021, 08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 & 05.01.2022 respectively through notices but neither he appeared nor assumed duty till date of dismissal. Besides, the appellant was issued Final Show Cause Notice vide No. 991-92/PA dated 01.03.2022 which was received by the appellant on 05.02.2022 to which he was bound to submit his reply within stipulated time but he failed, nor he assumed duty till date of dismissal hence, he was awarded Major Punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant (Copy of Served Charge Sheet with statement of allegations, enquiry papers, Final Show Cause Notice, Receiving receipt of Final Show Cause Notice and dismissal order are attached as Annexure-B, C, D & E).
- 7. Incorrect. Stance taken by the appellant is not plausible because he has been proceeded against departmentally by issuing him charge sheet with statement of allegations on account of willful absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.2021 till date of dismissal and enquiry was entrusted to Mr. Sadat Ali the then DSP Security Mardan, which was received by the appellant on 14.08.2021. During the course of enquiry the appellant was contacted time and again to appear before the enquiry officer but neither he appeared before the enquiry officer nor submitted his reply. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended for major punishment. In light of above, the appellant was called for Orderly Room on 03.11.2021,

08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 & 05.01.2022 respectively through notices but neither he appeared nor assumed duty till date. Besides, the appellant was issued Final Show Cause Notice vide No. 991-92/PA dated 01.03.2022 which was received by the appellant on 05.02.2022 to which he was bound to submit his reply within stipulated time but he failed, nor he assumed duty till date, hence he was awarded Major Punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant.

- 8. Correct to the extent that the appellant preferred departmental appeal before the appellate authority which was filed, being devoid of merit. As the appellant was provided full-fledged opportunity of defending himself but he bitterly failed to produce any cogent proofs/reasons to justify his innocence. Hence, after perusal of entire material available on record coupled with enquiry report as well as the order of punishment, the departmental appeal was rejected and filed being devoid of merit and badly time barred (Copy of orders is attached as annexure-"F").
- 9. That the appeal of the appellant is liable to be dismissed on the following grounds amongst the others.

REPLY ON GROUNDS:

- A. Incorrect. Stance taken by the appellant is baseless because order passed by the competent authority is legal as per law, facts according to norms of natural justice and material available on record, hence liable to be maintained, because all legal & codal formalities have been fulfilled.
- B. Incorrect. Plea taken by the appellant is not plausible, because the respondents have no grudges against the appellant, hence denied.
- C. Incorrect. Stance taken by the appellant is baseless because order passed by the competent authority as per law, rules and policy, hence liable to be maintained.
- D. Incorrect. Stance taken by the appellant is not plausible because he while posted at Police Station Sheikh Maltoon, remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.2021 till date of dismissal. On account of aforementioned allegations, the appellant was issued Charge Sheet with Statement of allegations and enquiry was entrusted to Mr. Sadat Ali the then DSP Security Mardan, which was received by the appellant on 14.08.2021. During the course of enquiry the appellant was contacted time and again to appear before the enquiry officer but neither he appeared before the enquiry officer nor submitted his reply. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended for major punishment. In light of above, the appellant was called for Orderly Room on 03.11.2021, 08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 &

05.01.2022 respectively through notices but neither he appeared nor assumed duty till date of dismissal. Besides, the appellant was issued Final Show Cause Notice vide No. 991-92/PA dated 01.03.2022 which was received by the appellant on 05.02.2022 to which he was bound to submit his reply within stipulated time but he failed, nor he assumed duty till date of dismissal hence, he was awarded Major Punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant.

- E. Incorrect. Plea taken by the appellant is not plausible, because being a member of disciplined force he was supposed to inform his seniors about his mother's illness or submit application for leave but he failed to do so and remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.2021, this attitude of the appellant clearly showed that he was no more interested in Police Department, which is gross misconduct under the Police Rules, 1975. However, after fulfilling all legal and codal formalities by providing fulfledged opportunity of defending himself before the competent as well as appellate authority but he bitterly failed to produce any cogent reasons in his defense, Hence he was awarded Major Punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant.
- F. Incorrect. Plea taken by the appellant is not plausible, because the appellant was called for Orderly Room on 03.11.2021, 08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 & 05.01.2022 respectively through notices but neither he appeared nor assumed duty till date of dismissal. Besides, the appellant was issued Final Show Cause Notice vide No. 991-92/PA dated 01.03.2022 which was duly received by the appellant on 05.02.2022 to which he was bound to submit his reply within stipulated time but he failed, nor he assumed duty till date of dismissal, however, after fulfilling all legal and codal formalities the competent authority passed the said order as per law.
- G. Incorrect. Stance taken by the appellant is not plausible because he while posted at Police Station Sheikh Maltoon, remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.2021 till date of dismissal. On account of aforementioned allegations, the appellant was issued Charge Sheet with Statement of allegations and enquiry was entrusted to Mr. Sadat Ali the then DSP Security Mardan, which was received by the appellant on 14.08.2021. During the course of enquiry the appellant was contacted time and again to appear before the enquiry officer but neither he appeared before the enquiry officer nor submitted his reply. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended for major

punishment. In light of above, the appellant was called for Orderly Room on 03.11.2021, 08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 & 05.01.2022 respectively through notices but neither he appeared nor assumed duty till date of dismissal. - I. Incorrect. Stance taken by the appellant is not plausible because he while posted at Police Station Sheikh Maltoon, remained absent from duty without any leave/permission of the competent authority vide DD No. 41 dated 30.06.202 till date of dismissal. On account of aforementioned allegations, the appellant was issued Charge Sheet with Statement of allegations and enquiry was entrusted to Mr. Sadat Ali the then DSP Security Mardan, which was received by the appellant on 14.08.2021. During the course of enquiry the appellant was contacted time and again to appear before the enquiry officer but neither he appeared before the enquiry officer nor submitted his reply. However, after fulfillment of all legal and codal formalities, the Enquiry Officer recommended for major punishment. In light of above, the appellant was called for Orderly Room on 03.11.2021, 08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 & 05.01.2022 respectively through notices but neither he appeared nor assumed duty till date of dismissal. Besides, the appellant was issued Final Show Cause Notice vide No. 991-92/PA dated 01.03.2022 which was received by the appellant on 05.02.2022 to which he was bound to submit his reply within stipulated time but he failed, nor he assumed duty till date, hence he was awarded Major Punishment of dismissal from service, which does commensurate with the gravity of misconduct of the appellant.
- J. Incorrect. Stance taken by the appellant is baseless because order passed by the competent authority is as per norms of law and natural justice, hence maintainable in the eyes of law.
- K. Incorrect. Stance taken by the appellant is baseless because orders passed by the competent as well as appellate authority are legal as per law and rules. The respondents also seek permission of this honorable tribunal to adduce additional grounds at the time of arguments.



PRAYER:-

It is therefore, most humbly prayed that on acceptance of above submissions, appeal of the appellant may very kindly be dismissed **being a badly time-barred** and devoid of merits.







FINAL SHOW CAUSE NOTICE

ORDER ON ENQUIRY OF CONSTABLE SAEED KHAN NO.2451

This order will dispose-off a Departmental Enquiry under Police Rules 1975, initiated against the subject official, under the allegations that while posted at Police Station Sheikh Maltoon (Mardan), remained absent from duty without any leave/permission of the competent authority vide DD No.41 dated 30-06-2021 till-date.

To ascertain facts, he was proceeded against departmentally through Mr. Saadat Ali DSP/Security Mardan vide this office Statement of Disciplinary Action/Charge Sheet No.181/PA dated 02-08-2021, who (E.O) after fulfilling necessary process, submitted his Finding Report to this office vide his office letter No.542/DSO dated 27-09-2021, holding responsible the delinquent official of gross misconduct on the eve of not submitting his reply in compliance of delivered Statement of Disciplinary Action/Charge Sheet within stipulated time of (07) days to him (Enquiry Officer), nor assumed duty at PS Sheikh Maltoon till finalizing the enquiry process.

In order to further verify his misconduct, he was called for hearing in Orderly Rooms on 03-11-2021, 08-12-2021, 15-12-2021, 22-12-2021, 29-12-2021 & 05-01-2022 respectively on proper notices delivered upon him through local Police of PS Rustam, but he failed to comply with. At last on 12-01-2022, he appeared before the undersigned in O.R, during which, he made a request to the undersigned for a last chance to continue Police Service, upon which, I have taken a lenient view against him by directing to assume duty at his place of duty i.e. PS Sheikh Maltoon today on 12-01-2022, but he failed to comply with **till-date**.

He was given another chance to join Police service in the shape of Final Show Cause Notice, under Khyber Pakhtunkhwa Police Rules-1975, issued vide this office No.991-92/PA dated 03-02-2022, which was served on him through local Police of PS Rustam on 05-02-2022 & in compliance, he was bound to submit his reply to this office within stipulated time of (07) days, but neither has he submitted his reply, nor assumed duty **till-date**, clarifying that he is not interested in Police Force.



ORDER.

This order will dispose-off the departmental appeal preferred by Ex-Constable Saeed Khan No. 2451 of Mardan District Police against the order of the then District Police Officer, Mardan, whereby he was awarded major punishment of dismissal from service vide OB No. 515 dated 25.02.2022. The appellant was proceeded against departmentally on the allegations that he while posted at Police Station Sheikh Maltoon, District Mardan on account of absence from his lawful duty without any leave or prior permission of the competent authority vide daily diary No. 41 dated 30.06.2021 till date of his dismissal from service.

Therefore, proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and the then Deputy Superintendent of Police, Security, Mardan was nominated as Enquiry Officer. The Enquiry Officer after fulfilling codal formalities submitted his findings to the then District Police Officer, Mardan, wherein he reported that the delinquent Officer was contacted time and again to appear before the enquiry Officer, but he failed and remained absent, which showed that he was no more interested in Police Service. He recommended the delinquent Officer for ex-parte action.


He was also provided opportunity of self defense by summoning him in the Orderly Rooms by the then District Police Officer, Mardan on 03.11.2021, 08.12.2021, 15.12.2021, 22.12.2021, 29.12.2021 and 05.01.2022, but he failed to appear. At last on 12-01-2022, he appeared before the then District Police Officer, Mardan in Orderly Room, during which, he made a request to the then District Police Officer, Mardan for a last chance to continue Police Service, upon which, taken a lenient view against him by directing to assume duty at his place of duty i.e. Police Sheikh Maltoon on 12-01-2022, but he failed to comply with till-date of his dismissal.

He was given another chance to join Police service in the shape of Final Show Cause Notice, which was served on him through local Police of Police Station, Rustam on 05-02-2022 and in compliance, he was bound to submit his reply stipulated time of (07) days, but neither has he submitted his reply, nor assumed duty till-date of his dismissal, clarifying that he was not interested in Police Force.

Details of his absence's period from 30-06-2021 are as under:-

- 1. Daily diary No.41 dated 30-06-2021 to daily diary No. 22 dated 09.09.2021.
- 2. Daily diary No. 37 dated 09.09.2021 to daily diary No. 17 dated 15.12.2021.
- 3. Daily diary No. 37 dated 15.12.2021 till date of his dismissal.

In the light of above discussion the delinquent Officer was not a witting worker and his retention in Police department will be bothered for Government Exchequer, therefore, awarded him major punishment of dismissal from service with effect from 30.06.2021 vide OB: No. 515 dated 25.02.2022 by the then District Police Officer, Mardan,

Feeling aggrieved from the order of the then District Police Officer, Mardan, the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in this office on 22.02.2024.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations leveled against the appellant have been proved beyond any shadow of doubt. As he has bitterly failed to produce any cogent reason to justify his absence because the same clearly depicts his casual and lethargic attitude towards his official duties. The very conduct of appellant is unbecoming of a disciplined Police Officer. On perusal of previous service record of the appellant, it was noticed that he is habitual absentee and prior to this, the appellant had been earlier punished on various occasions on account of his misconduct. Hence, order passed by the competent authority does not warrant any interference. Besides the above, the appellant approached this forum at a belated stage by filing the instant appeal which is badly time barred for 01 year, 07 months and 22 days without advancing any cogent reason regarding such delay.

Keeping in view the above, I, Muhammad Suleman, PSP Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, therefore, the same is rejected and filed, being devoid of mefit as well as badly time barred 01 year, 07 months and 22 days.
