Reply/Comments on behalf of respondents No 3 to 5

Respectfully Submitted:

Preliminary Objections

- 1. That the appellant has no Locus Standi and cause of action to file instant appeal.
- 2. That the appeal is not maintainable in its present form.
- 3. The appeal is barred by law and limitation.
- **4.** This honorable Tribunal has got no jurisdiction to entertain the titled appeal.
- 5. The tentative seniority list was circulated on 14-10-2021, and the final seniority list was issued on 22-02-2022. However, the appellant submitted observations/objections on the tentative seniority list after a lapse of 13 months, as indicated in DSO Bannu's letter dated 23-11-2022. (A copy of the letter is enclosed as Annexure-A).



- **6.** That the appeal is bad for misjoinder and non-joinder of necessary parties.
- 7. Respondents No 3 to 5, being highest in merit, were rightly placed at the top of the seniority list, under Rule 17 (1) (a), of the KP Civil Servants (Appointment, Promotion & Transfer) Rules 1989.
- 8. Respondents No. 3 to 5, being the most senior, have been appointed on an Acting Charge Basis as Assistant Directors (IT) (BPS-17) under the provision contained in Rule-9 (1) of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion, & Transfer) Rules, 1989.

PARAWISE REPLY/COMMENTS ON FACTS

- 1. The appellant was appointed on fixed pay as a Monitoring & Data Collection Assistant under a project by the Health Department.
- 2. Pertains to record hence needs no reply.
- 3. Correct to the extent of appointment of the appellant, however, it is further explained that Respondent No. 3 was appointed under the merit quota following the written refusal of a successful candidate on the same day (Annex-B). The respondents scored higher than the appellant in the final merit list, with Respondent No. 3 securing 90.5, Respondent No. 4 securing 90, and Respondent No. 5 securing 89.5, while the appellant obtained a score of 89. Consequently, seniority has been determined based on merit, as reflected in the Seniority List (A copy of the merit lists are enclosed as Annexure-C).).
- 4. Para under reply is correct to the extent of the Seniority List as well as seniority positions of the appellant as well as replying respondents, however, the same position was assigned as per their merit position, in accordance with law.
- **5.** Para No.5 pertains to record however Tentative Seniority List was circulated on 14-10-2021, against which no objections were raised by the appellant and after resolving the objections of others, the Final Seniority List was issued on 22-02-2022 and the appellant raised objections over the same on 23-11-2023 after many months, further detailed reply has been given in preceding paras.
- 6. Incorrect, there is no mention as to whether the appellant has filed a departmental appeal against the Tentative Seniority List or against the Final Seniority List, as even there is no mention of the date of the Seniority List which he has filed a departmental appeal, hence appeal

is not maintainable. The appellant has even filed no appeal to the department against the promotion of the replying respondents and even instant appeal absent the Acting Charge Promotion is not maintainable.

7. Incorrect. His appeal was re-evaluated and responded accordingly vide Sports Department letter No. SO (Sports) 1-41/Seniority list/2023/3978-82 dated 12-04-2023, however, the appellant has not challenged the same but rather has challenged the Comments of respondent No 2 which he had submitted to respondent No 1 in response to the departmental appeal, hence service appeal is not tenable and liable to be dismissed (Annex-D).

REPLY TO GROUNDS:

- A. Para under reply incorrect as the impugned Seniority List is in accordance with law and rules and no right of the appellant has been violated hence he has got no cause of action.
- **B.** As no right of the appellant has been infringed, the seniority list has been issued in accordance with law on the subject and he has been treated in accordance with law and rules.
- C. Incorrect, as the seniority list has been prepared following the order of merit which is in accordance with Rules 17 of the Khyber Pakhtunkhwa Civil Servants (Appointment Promotion & Transfer), Rules 1989 and thus the same is based on law and rules on the subject.
- D. Incorrect, detailed reply has been given in the above paras.
- E. Incorrect, respondent No. 3 was appointed the same day,i.e 24-12-2019, however, it is clarified that there were two senior candidates in merit quota, of which one refused in writing to join service and respondent No 3 being next on merit was appointed accordingly, as per law on the subject and who was better in merit than the appellant as explained above.
- F. Incorrect the appellant has been treated in accordance with the law and rules on the subject and no illegality has been done to him.
- **G.** Para under reply legal however the replying respondents also seek leave of this honorable Tribunal for additional grounds at the time of arguments.

It is therefore prayed that the appeal of the appellant may kindly be dismissed with heavy costs.

Prior to my this appointment I also remained a Government Servant as Computer Operator since 30.11.2016 (copy F/B) and I applied for the instant post through proper channel (copy F/C) due to which my previous service is required to be considered/included in the seniority list of Computer Operator which was totally ignored.
- 2. That presently I was listed at Serial No.04 while 03 other Computer Operators are listed more senior than me on the basis of ambiguous -Merit-Score-as such Merit criteria of all selected candidates are unknown (copy F/D).
- 3. That—Ist Entry-into-Government-Service in-respect of the Computer Operator at Senior No.01 of Seniority List was shown as 24.12.2019 while his actual entry into regular Government Service is 15.01.2020 according to SAP System Generated Report of the Accountant General Peshawar (copy F/E).

That initially a list of all selected candidates showing addresses of the selected computer operators was displayed on the Directorate Official Facebook Page (https://www.facebook.com/KPDGSports?mibextid=ZbWKwL) (copy F/F) in which the Computer Operator at Serial No.01 of the Seniority List was not shown which creates question marks on the 1st Position of the said Computer Operator (copy flagged as F/G).

I am directed to refer to your letter No. 643-644/DSO/BU dated 23-11-2022 on the subject noted above and to submit the para-wise comments as under: -

- 1. It is correct that you have applied through proper channel in this office and appointed through initial recruitment against the vacant post at District Sports Office, Bannu. However, your plea regarding seniority from your first appointment i.e., 30.11.2016 is not covered under the rules as the previous service is only count for the purpose of pay & pension protection not for seniority. Furthermore, you have been granted the experience marks which makes you eligible for selection in District Sports Office, Bannu.
- 2. The seniority list has been made under the rule 17 of APT rules 1989.
- 3. The first date of entry into service in respect of Serial No. 1 of the seniority list is mentioned as 24.12.2019, there were two senior candidates on provincial posts in the merit list out of which one of them didn't join the service and refused in writing to join this Directorate soon after the receipt of offer of appointment. Next candidate which is mentioned at Serial No. 1 of the seniority list being the senior in the waiting list which was maintained for the period of 03 months was offered the appointment order on the same day i.e., 24.12.2019 under the rules. Later on, he requested to extent his joining period due to clearance of some liabilities in the department where he was serving. As such his joining period was extend by the competent authority under the rules. Due to typographically mistake his date of joining in the seniority list has been wrongly mentioned as 24-12-2019 instead of 15-01-2020 which will be corrected in due course of time. But the date of appointment or joining is not considered for the purpose of seniority as the seniority is fixed on the basis of merit.



<u>DEPARTMENTAL</u> APPEAL FOR CORRECTION OF THE IMPUGNED SENIORITY LIST OF DIRECTORATE GENERAL OF SPORTS COMPUTER OPERATORS.

Kindly refer to your letter No. SO (Sports) 1-41/seniority list/2023/3350-53 dated 17-03-2023 on the subject noted above and submit para-wise comments in respect of Departmental Appeal of Mr. Asif Usman, Computer Operator (BPS-16), office of the District Sports Officer, Bannu as under: -

- 1. Need no comments.
- 2. The applicant has correctly mentioned that he applied through proper channel for the post of Computer Operator in this Directorate. However, his plea regarding previous seniority of Zakat & Usher Department cannot be allowed under the rules as he was appointed through initial recruitment in this Directorate and previous service can only be considered for the purpose of pay & pension protection. As such his claim of seniority for the service from his first date of appointment in Zakat & Usher Department i.e., 30.11.2016 is not covered under the rules. However, he was given the experience marks due to which he became eligible for his selection in this Directorate.
- 3. The seniority list of computer operators has been prepared under rule 17 of APT Rules
- 4. The name of Mr. Ishfaq Ahmad has been placed on the top on the basis of merit list. As regards his date of entry into service in the Directorate General of Sports as 24.12.2019, there were two senior candidates for provincial headquarter posts in the merit list out of which one of them didn't join the service and refused in writing to join this Directorate on the same day i.e., 24.12.2019. Mr. Ishfaq Ahmad being the senior in the waiting list was offered the appointment order on the same day i.e., 24.12.2019 under the policy / rules. Later on, he requested to extent his joining period due to clearance of some liabilities in the department where he was serving. As such his joining period was extended by the competent authority under the rules. Due to typographically mistake his date of entry into govt service in the seniority list has been wrongly mentioned as 24-12-2019 instead of 15-01-2020 which will be rectified in due course of time. It is added that the date of appointment or joining is not considered for the purpose of seniority as the seniority is fixed on the basis of merit in the initial recruitment as per the APT rules, 1989.

- 6. In pursuance of his letter dated 23-11-2022 (as referred in para-6 in his application) the District Sports Officer, Bannu was asked to provide a copy of his earlier letter of dated 10-11-2021 as the same was not available on the record of this office. Astonishingly he provided a copy of letter dated 10-11-2022 instead of 10-11-2021. Therefore, the DSO Bannu was asked to bring their record and appear along with complainant. The DSO Bannu and a senior clerk attended this office along with the original record while the complainant did not bother to attend this office in order to redressal to his grievances. After going through the record, the letter of dated 10.11.2021 (as referred in para-6 of his application) was not found in their record too. It is pointed out that as per practice in vogue, the tentative seniority list was circulated on 14-10-2021, on which some computer operators had raised observations / objections. After clearance of all observations / objections and their satisfaction, the final seniority list was issued on 22-02-2022. After lapse of 08 months, he has submitted observations / objections through DSO Bannu letter No. 643-644/DSO/BU dated 23-11-2022 by giving above reference which doesn't exist. As such his plea regarding non consideration of his previous application is baseless.
- 7. The applicant has used un-parliamentarian language. The seniority list was prepared on the basis of merit under rule 17 of APT Rules 1989 which is not ambiguous.

8. As explained in Para-No.6 above.

In view of the above it is clear that the observation raised by the complainant are baseless, without merit and having no justification which may kindly be filed.
