Learned counsel for the appellant present and eshawar vide impugned order dated 08.04.2024 the transfer/posting order of the appellant was withdrawn. He further argued that appellant was removed from service vide order dated 08.11.2023 against which appellant filed departmental appeal which was accepted vide order dated 28.03.2024, therefore, appellant was posted against the post after reinstatement vide order dated 08.04.2024. Appellant assumed the charge of post on the same date. One Faiz Ur Rehman was also relieved from the said post by DEO (F), Charsadda on 08.04.2024 i.e on same date. He further argued that vide impugned order shown to be issued on 08.04.2024 by back dating it infact it was issued after performance of duties for four days by the appellant. Points raised need consideration. Appeal in hand is admitted for regular hearing subject to all just and legal objections. Appellant is directed to deposit security fee within seven days, thereafter, notices be issued to the respondents for submission of written reply.
