SENIORITY LIST OF MEMBERS OF SERVICE (MANAGEMENT CADRE)
BPS-19 AND 20 ISSUED VIDE LETTER DATED 04-01-2024,

TO THE EXTENT OF RESPONDENTS NO 4 TO 22, WHEREBY RESPONDENTS NO 4 TO 22 HAVE BEEN PLACED SENIOR TO THE APPELLANT AND AGAINST WHICH DEPARTMENTEAL APPEAL OF THE APPELLANT HAS NOT BEEN RESPONDED SO FAR DESPITE THE LAPSE OF MORE THAN THE STAUTORY PERIOD OF NINETY DAYS.

#### PRAYER:-

On acceptance of this appeal the impugned Provisional Seniority List of Members of Service (Management Cadre) Doctors BPS-19 and BPS-20 issued vide Letter dated 04-01-2024, to the extent of respondents No 4 to 22, may kindly be modified, thereby placing the name of the appellant above the name of respondents No 4 to 22, with all back benefits including promotion.

#### Respectfully Submitted:-

- 1. That the appellant was initially appointed as Medical Officer (BPS-17) on 15-09-1997 and after being fit, eligible, senior and coming up to the criteria, was promoted to BPS-18 on 06-04-2015 and was promoted to BPS-19 on 14-11-2017 and since appointment, the appellant performed his duties with honesty and full devotion and to the entire satisfaction of his high ups.
- 2. That process for formation of Management Cadre in Health Department was initiated in the year 2008 and accordingly Khyber Pakhtunkhwa, Health Management Services Rules 2008, were framed and notified by the department on 11-12-2008 and the ibid rules were published in the Official Gazette on 02-11-2016. There after the Doctors of General Cadre were informed and under Rule 10 of the Health Management Services Rules 2008, option and requisite documents were also sought from the Doctors and as such Final List of Option was submitted to respondent No 2 vide Letter dated 14-07-2009. (Copy of Letter dated 14-07-2009 is enclosed as Annexure A).
- 3. That against the Notification dated 11-12-2008, Dr. Sher Muhammad and others approached this honorable Tribunal, by filing number of Service Appeals, which were disposed whereby Notification dated 11-12-2008 was modified and cushion period of two years was provided to those Doctors who wanted to join Management Cadre for improving their qualification within two years from the date of decision and that they may opt and join the Management Cadre without effecting their Seniority/Service vide Judgment dated 03-01-2012. Civil Petitions were filed against the Judgment of this honorable Tribunal which were also dismissed. According, Khyber Pakhtunkhwa, Health Management Services Rules 2008, were amended vide Notification dated 10-

- 4. That subsequently, on option number of Doctors who had improved their qualification during the given period of two years, were inducted in Health Management Cadre vide Notifications dated 10-05-2018, Notification dated 10-09-2018 & Notification dated 01-10-2018, however their seniority was protected. [Copies of Notifications dated 10-05-2018, Notification dated 10-09-2018 & Notification dated 01-10-2018 are enclosed as Annexure C).
- 5. That Provisional Seniority List dated 01-01-2019, of Members of Service (MBPS-19, Officers of the Cadre was issued, on 01-01-2019 however it worth to mention that some Doctors who were not eligible for induction into Management Cadre were also inducted in the Cadre and after being pointed out, their induction in the Management Cadre was de-notified. The issue of Seniority has been the bone of contention at various foras including this honorable Tribunal, and even till date no Final List of the members of Management Cadre has been notified as required under Sub Section (5) of Section 8 of the KP Civil Servants, Act, 1973. (Copy of Seniority List dated 01-01-2019 & Letters dated 17-01-2020 & Letter dated 13-09-2021 are enclosed as Annexure D & E).
- 6. That again the KP Health Management Service Rules, 2008, were amended, whereby window was provided to the members of General Cadre for their posting against the post of Management Cadre with certain conditions vide Notification dated 11-02-2022. (Copy of Notification dated 11-02-2022 is enclosed as Annexure F).
- 7. That the appellant time and again approached respondents for placing his name at due place in the Seniority List which representation was duly forwarded but with no fruits. (Copy of Letter dated 17-07-2023 is enclosed as Annexure G).
- 8. That Provisional Seniority List of Members of Service (Management Cadre) Doctors BPS-19 and BPS-20 was issued vide Letter dated 04-01-2024, wherein the appellant being senior to respondents No 4 to 22, was placed at Serial No 32 while respondents No 4 to 22 were placed at Serial No 5 to 23. (Copy of Provisional Seniority List & Letter dated 04-01-2024 is enclosed as Annexure H).



- That the appellant filed Representation/Objections against the Provisional Seniority List dated 04-01-2024, which are not responded so far. (Copy of Representation/Objections is enclosed as Annexure I).
- 10. That in the meanwhile official respondents initiated process for promoting respondents No 4 to 22 by scheduling the meeting of Provincial Selection Board on 29-07-2024, wherein the case of respondents No 4 to 22 for promotion to BPS-20, has been included at Agenda Item No 31, however the same was deferred, again the same schedules on 30-07-2024 but again the same could not be considered, however the official respondents are going to schedule the meeting of PSB any time for promoting the private respondents, despite the fact that till date no Final Seniority List has been notified as per Sub Section (5) of Section 8 of the KP Civil Servants, Act, 1973. (Copies of Letters dated 26-07-2024 and Letter dated 29-07-2024 is enclosed as Annexure J & K).
- 11. That the impugned Provisional Seniority List issued vide Letter dated 04-01-2024, to the extent of respondents No 4 to 22, is against the law, facts and principles of justice on grounds inter-alia as follows:-

#### **GROUNDS:**

- **A.** That the impugned Provisional Seniority List issued vide Letter dated 04-01-2024, to the extent of respondents No 4 to 221, is illegal, unconstitutional, and unlawful, without lawful authority and of no legal effect, therefore need the interference of this honorable Court.
- B. That the appellant is denied treatment in accordance with law and rules which being his fundamental right as per Article 4, 10-A and 25 of the Constitution and law of the land.
  - **c.** That the appellant is senior to respondents No 4 to 22 with respect to the date of appointment and even with respect to his promotion, but even then he is not placed at his due place in the Seniority List.
  - D. That even the Judgment dated 03-01-2012 rendered in Service Appeal No 513-517 of 2010, whereby the appellant was allowed induction in Management Cadre it was held that they may join the Management Cadre without effecting their seniority/service, hence the appellant could not be placed junior to private respondents. (Copy of Judgment)

#### Dated 03-01-2012 is enclosed as Annexure L).



- **E.** That the law does not recognize the Provisional Seniority List, which is just issued by the Department for inviting objections in order to issue Final Seniority List, while official respondents are going to process the case of private respondents for promotion to BPS-20 on the basis of Provisional Seniority List, which is not known to law.
- **F.** That it is worth to mention that the appellant has been discriminated, as respondents No 4 to 22 after induction in Management Cadre were allowed seniority from the date of their appointment/promotion while the appellant has been allowed seniority from the date of induction in the Management Cadre.
- **G.** That the appellant joined the Management Cadre subsequent to the Judgment of this honorable Tribunal and hence the appellant could not be punished for the fault of others even if any.
- H. That the induction Notification of private respondents, was even not published in the Official Gazette in the year 2009 and the same was published in the Official Gazette on 02-11-2016 within the manning of Notification in accordance with law, hence too the impugned seniority List is liable to be modified.
- 1. That the impugned Seniority List is in violation of law and rules on the subject, hence liable to modification on this score alone.
- J. That the malice is verily floating on surface of record, as private respondents are going to be promoted on the basis of disputed Seniority List in violation of promotion policy of the Provincial Govt.
- **K.** That since seniority being recurring cause of action and issuing fresh Seniority List gives fresh cause of action, hence too the impugned Order and Seniority List is liable to set aside.
- L. That the appellant has been deprived of due seniority in violation of Article 10-A of the Constitution, in violation of the principles of natural justice besides providing him any opportunity of hearing.
- **M.** That the appellant seeks the permission of this honorable Tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that Service Appeal of the appellant may kindly be accepted, as prayed for.

Any other relief not specifically asked for and deemed appropriate in the circumstances of the case, may also be granted in favor of the appellant.

No.SOH (Z-V)/4-4/Managen ent Service Rules, 2008/2022/ In exercise of the powers conferred by section 26 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973), the Chief Minister of Khyber Pakhtunkhwa is pleased to direct that in the Khyber Pakhtunkhwa Health (Management) Service Rules, 2008, the following further amendments shall be made, namely:

#### **AMENDMENTS**

- In rule 4, the existing provision shall be numbered as sub-rule (1) of rule 4 and after sub-rule (1) as so renumbered, the following new sub-rule shall be added, namely:
  - "(2) Notwiths anding anything contained in sub-rule (1), in cases where no suitable officer amongst the members of Service is available for appointment against any post mentioned in Schedule-I, the respective appointing authority, under rule 17 of the Khyber Pakhtunkhwa Government Rules of Business, 1985, may post any suitable dictor from amongst the General Cadre doctors, having equivalent pay scale, to such post:

Provided that the General Cadre doctors so posted shall hold office during the pleasure of the respec ive appointing authority:

Provided further that the respective appointing authority may also consider one grade lower candidate for any position in the Management Cadre on his own pay scale.

- (3) For the purpose of sub-rule (2), the Health Department, if deemed appropriate, may determine any criteria and/ or mechanism for recommending to the relevant appointing authority, for their posting to a position in the Management Cadre.".



#### JUDGMENT

SYED MANZOOR ALI SHAH. MEMBER.— This appeal has been filed by Dr. Sher Muhummad, appellant under Section 4 of the Khyber Pakhtunkhwa, Service Tribunal Act, 1974, against the notification 11.12.2008 known as Khyber Pakhtunkhwa Health (Management) Service Rules, 2008 vide which service structure was changed and "Management Cadre" was introduced in the Health Department. It has been prayed that on acceptance of the appeal, the impugned notification may be declared as illegal, unlawful, void-abinitio and of no legal effect, being corum non-judice.

- Brief facts of the case as averred in the memo: of appeal are that the appellant. being MBBS Graduate, entered into government service, Health Department, Government of Khyber Pakhtunkhwa in the year, 1985. Respondent No.1, in exercise of the powers conferred by Section 26 of the North West Frontier Province Civil Servants Act, 1973 vide notification dated 11.12.2008 made Rules known as Khyber Pukhtunkhwa Health (Management) Service Rules, 2008, vide which Service Structure was changed and "Management Cadre" was introduced in Health Department. Feeling aggrieved, the appellant filed Writ Petition No. 2382/2009 before the Hon'ble Peshawar High Court, Peshawar which was disposed off in limine on 10.11.2009, with direction to the departmental authority, to decide the representations of the appellant pending before them within one month positively in accordance with the law. The respondents did not comply with the direction of the Hon'ble Peshawar High Court, Peshawar, therefore, the appellant filed contempt of court petition No. 10/2010, implementation of ...der dated 10.11.2009, which was disposed off on 9.2.2010, with observation that the appellant could file appeal before the Service Tribunal after the expiry of ninety days, hence this appeal.
  - 3. After admission of the appeal, notices were issued to the respondents. Respondents No. 1,2,3,5 and 7 have filed their joint written reply. Respondent No.4 was not a necessary party; hence his name was deleted from the list of respondents vide order dated 19.8,2010. Private respondents have filed written reply through their counsel and contested the appeal.

Arguments heard and record perused.

The learned AAG at the very outset pointed out that Khyber Pakhtunkhwa blealth (Management) Service Rules, 2008 have been formulated by the Governor of the province in exercise of powers conferred by Section 26 of the Khyber Pakhtunkhwa Civil Servants Act, 1973, according to which the Governor or any

persons authorized by him in this behalf, may make such rules as appear to him to be necessary or expedient for carrying out the purpose of this Act i.e. Civil Servant Act, 1973; Section 2(b) which is a general statute i.e. rules can be framed for Civil Servants Act, 1973 and under it rules for any particular cadre cannot be made, delegatory legislation for Health Department can not be performed under this Section. Any rules for a particular endre can be done only through Act of parliament and the Section 2(b) does not confer inherited power for further legislation for any specific cadre. He further argued that this Tribunal has no jurisdiction to entertain the present appeal as the validity of the notification/rules should have been challenged and that the present appeal is time-barred.

- On the point of jurisdiction, the learned counse! for the appellant argued that through the impugned notification/rules, terms and conditions of service of the appellant have been affected, which can be challenged before this Tribunal, having vast power to confirm, set aside, vary or modified the order challenged before it. The Survice Tribunal has vast jurisdiction to redress the grievances of the persons before it. The learned counsel for the appellant relied on PLD 2003-Supreme Court-724(d). Regarding limitation, the counsel for the appellant stated that the appellant had been diligently pursuing his remedy before the Hon'ble Peshawar High Court and the period spent before the wrong forum can be condoned by the Service Tribunal in view of the angust Supreme Court judgment reported in 2004-SCMR-1419.
  - The learned counsel for the appellant stated that the appellant is mainly Ğ. aggrieved from Rule 10 of Khyber Pakhtunkhwa Health (Management) Service Rules, 2008, wherein it has been stated that notwithstanding anything contained in the provision of those less Government shall, as one-time exercise, fill in posts in the Service described in Schedule-I by way of permanent transfer from amongst the Officers of General Cadre in equivalent basic pay scale who have the qualification of Master of Public Health or Postgraduate Diploma in Public Health or Postgraduate Diploma in Hospital Administration or Health Planning and Management or equivalent Master's Degree/Diploma in Health management or altied disciplines and opt for absorption. It shows that no chance/time period has been given to the appellant to improve his qualification required and has been confined to General Cadre and is to be curried out as one time exercise, whereby denying him chances of further promotion which is highly discriminatory. In this respect, he referred to Provincial Management Service Rules notified on 11.5.2007. In para-7 of the said rules the cushion period of seven years has been provided. The General Headquarters MS. Branch, Rawalpindiissued MS Branch Policy Compendium 2003, Amendment No.2/2010, wherein

years cushion period has been provided to enable max GDMOs to acquire LPG, the Med Directorate was directed to ensure that equal opportunity is afforded to all GDMOs to acquire LPG, and that modalities may also be evolved to get LPG, through evening programme distant learning approved from PM&DC.

- 7. The learned counsel for private respondents argued that the government felt to achieve better results for which Administrative and Professional Cadres were separated and introduced "Management Cadre" & "General Cadre" through the Health (Management) Service Rules, 2008. Since the appellant basically belongs to General Cadre and had not acquired the requisite qualification for Management Cadre, therefore, his name has been brought on the strength of General Cadre. He further argued that on formation of Management Cadre, no financial loss occurred to the appellant nor his seniority has been disturbed. He requested that the appeal may be dismissed.
  - The Tribunal observes that Section 10 of the said rules does not provide any cushion period and denying chance to improve qualification for joining the management cadre to the appellants. The same be modified to the extent that two years cushion period be allowed to all those who wish to improve qualification as per Health (Management) Service Rules, and to join Management cadre if they succeeded in acquiring the requisite qualification as per the afor, mentioned Rules. This would however, not entitle the appellants and others not having requisite qualifications for posting in the Management Cadre posts but only provide them a cushion period and if they acquire the requisite qualification within 2 years from the date of the decision, they may ant and join Management Cadre without effecting their seniority/service.
  - With the above variation/modification in the impugned notification dated 11.12.2008, the present appeal is disposed of accordingly. Parties are left to bear their own costs. File be consigned to the record.
  - This order will also dispose of the following connected appeals No. 514/2010, Dr. Gul Akbar, No. 515/2010, Dr. Wakeel Muhammad, No. 516/2010, Dr. Shadhat Ali, and Mr. 517/2010, Dr. Syed Mujahid Hussain, in the same manner.
