Learned counsel for the appellant at the outset of his arguments contended that the appellant is working as Junior Clerk in the respondent-department since 11.06.2009 and is aggrieved of the dated 07.11.2019 when on order recommendations of DPC dated 16.10.2019, the appellant was promoted as Senior Clerk with immediate effect rather than 2013 when his juniors were promoted Senior Clerks as erstwhile recommendations of DPC dated 05.07.2013. Moreover, seniority list of Junior Clerks circulated on 17.06.2015 did not mention and include name of the appellant for which representations were submitted on 10.05.2017, 08.03.2018 and 04.03.2019. The appellant submitted departmental appeal on 25.08.2021 against the impugned order dated 07.11.2019 however, no appellate order was passed on his departmental appeal within the statutory period where-after he submitted the instant service appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 on 06.12.2021. Learned counsel for the appellant was confronted with the question of limitation that the appellant had submitted departmental appeal after almost two years. Learned counsel for the appellant referred to 2002 PLC (C.S) 1388 and 2021 SCMR 1230 where-under matters pertaining to promotion, pay and other emoluments or financial claims, limitation does not run in such cases.

APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974, AGAINST THE IMPUGNED ORDER DATED 07.11.2019 WHEREBY THE APPELLANT HAS BEEN GRNATED PROMOTION TO THE POST OF SENIOR CLERK (BPS-14) WITH IMMEDIATE EFFECT NOT w.e.f 2013 WHEREIN COLLEAGUES & JUNIORS TO THE APPELLANT WERE PROMOMTED TO THE POST OF SENIOR CLERKS (BPS-14) IGNORED APPELLANT UNLAWFULLY AND UNJUSTFIABLY AND THE AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN STATUTORY PERIOD OF NINTY DAYS.

PRAYER:

That on acceptance of this appeal the impugned order dated 07.11.2019 may very kindly be modified/rectified to the extent of appellant by directing the respondents to promote the appellant to the post of Senior Clerk (BPS-14) w.e.f 2013 whereby colleagues & juniors to the appellant were promoted to the post of Senior Clerk (BPS-14) with all back benefits including seniority. Any other remedy which this August Tribunal deems fit that may also be granted in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts raising the present appeal are as under:-

1-	That the appellant is initially appointed as Junior Clerk vide order
	dated 11.06.2009 in the police department and since appellant
	appointment he is performing his duty efficiently and up to the mark
	of his superiors. Copy of the appointment order dated 11.06.2009 is
	attached as annexureA.

- 3- That the appellant after couple of years performing his duties entirely to the satisfaction of his superiors was expected to be promoted to the post Senior Clerk but woefully promotion Notification No.17477 in year 2013 was issued by the respondents in which colleagues & juniors to the appellant were promoted to the post of Senior Clerk (BPS-14) and ignored appellant without any cogent justification. Copy of the Notification No.17477 in year 2013 is attached as annexure..C.
- 5- That the appellant feeling aggrieved from the Promotion Notification No.17477 issued in the year 2013 preferred multiple representation to the concerned authority for consideration to the promotion of Senior Clerk (BPS-14) but all vent in vain. Copy of the letters dated 10.05.2017 & representation, letters dated 4.03.2019 & 08.03.2018 are attached as annexure.

- 8- The appellant feeling aggrieved from merging of the seniority preferred application for issuance of revised seniority list and its correction which is not responded by the respondent department with good omen as per rights of the appellant ignoring the appellant deliberately. Copy of application and letter dated 29.09.2020 & letter 10.11.2020 are attached as annexure.
- 10-That the appellant further feeling aggrieved and having no other remedy but to file this appeal on the following grounds inter alia.

ON GROUNDS:

- A- That the issuance of impugned order dated 07.11.2019 by the respondents is against law, facts and norms of natural justice, hence not tenable in the eye of law and the impugned order dated 07.11.2019 be modified/rectified and granted promotion to the post of Senior clerk w.e.f notification No.17477 of 2013 whereby his colleagues & juniors were promoted to the post of Senior Clerk.
- B- That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and thus respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That action of the respondents is discriminatory in nature and thus granting promotion to the appellant to the post of Senior Clerk (BPS-14) with immediate effect not w.e.f 2013 is against norms of natural justice.
- D-That the action and inaction of the respondent is in arbitrary and malafide manner by not granting promotion to the appellant w.e.f

2013 whereby his colleagues & juniors were promoted to the post of Senior Clerk (BPS-14) and left the appellant deliberately and later on merging the seniority of the juniors and appellant vides dated 06.08.2020 to hide their illegalities and inefficiency in the name of merit.

- E- That the action of the respondent is against Section-8, 9 of the Civil Servant Act 1973 and Appointment, promotion and transfer Rules 1989) Rule, 7 & 17 thus impugned order dated 07.11.2019 may be modified/rectified to the extent of appellant and be granted promotion to the post of Senior Clerk (BPS-14) w.e.f 2013.
- F- That the action of the respondents caused financial loss to the appellant which is against Article 38(e) of the Constitution of the Islamic Republic of Pakistan 1973.
- G- That the appellant seeks permission to advance any other proof & ground at the time of regular hearing.

It is therefore most humbly prayed that the appeal of the appellant may very kindly be accepted as prayed for.







After appointment of the appellant another notification was issued in which juniors to the appellant were appointed as Junior Clerks on the next date of the appellant appointment vide order dated 12.06.2009. After couple of year performing his duties entirely to the satisfaction of his superiors appellant was expected to be promoted to the post Senior (Clerk BPS-14) but in the meanwhile promotion Notification No.17477 in year 2013 was issued by the department in which juniors to the appellant were promoted to the post of Senior Clerk BPS-14) and ignored appellant without any justification. Department than issued promoted Senior Clerks (BPS-14) seniority list vides dated 17.06.2015 in which promoted juniors were apparently juniors to the appellant those who were appointed on the very next day of the appellant appointment. Resultantly the appellant felt aggrieved from the Promotion Notification No.17477 issued in the year 2013 preferred multiple representations to the concerned authority for consideration to the promotion of Senior Clerk (BPS-14) which were not duly considered by the department. After considerable period, the department issued impugned order dated 07.11.2019 granting promotion to the appellant to the post of Senior Clerk (BPS-14) with immediate effect not with effect from 2013 whereby juniors to the appellant were promoted to the post of Senior Clerk (BPS-14). Department again unstoppably stamped on the right of the appellant and issued notification dated 06.08.2020 in which all those who were appointed on different dates merged and considered their appointment from i.e 11.06.2009 to hide illegalities which is against law and rules.


