SERVICE APPEAL UNDER SECTION-4 OF KPK SERVICE TRIBUNAL ACT 1974 AGAINST ORDER DATED 01-03-2022 OF THE DISTRICT POLICE OFFICER HARIPUR WHEREBY APPELLANT HAS BEEN "DISMISSED FROM SERVIE" ILLEGALLY AND AGAINST THE DEPARTMENTAL RULES AND REGULATIONS GOVERNING THE TERMS AND CONDITIONS OF APPELLANT SERVICE.

PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL THE MPUGNED ORDER DATED 01-03-2022 OF THE RESPONDENT MAY NOLY BE SET ASIDE AND APPELLANT BE REINSTATED IN SERVICE FIGURE THE DATE OF DISMISSAL WITH ALL CONSEQUENTIAL SERVICE BACK BENEFITS.

Resperted Sir,

- 1. That appellant was inducted in District Police Haripur in the year 2014 and since then appellant has been performing her duties with devotion, dedication and honesty. Appellant has exemplary service record.
 - 2. That on \$1-01-2022, while appellant posted at Police Lines, Harpur was telephonically informed from abroad Dubai by her cousin (daughter of his Aunt) that she was serious yill and admitted to Hospital and there was no one, to look after her. The appellant in emergency



informed In-charge Police Lines Haripur of the situation and started preparation for abroad.

- 3. That due to serious illness of her cousin abroad, appellant informed her In-charge to get her leave sanctioned from her officers and left for abroad. Appellant when reached abroad she found her cousin in a very serious condition and admitted to hospital. In such a situation the appellant had to stay with her as an attendant in the Hospital as her cousin was helpless and was without any attendant to be cared.
- 4. That no sooner the appellant's cousin felt some better, the appellant get her discharged from the hospital and managed returned air tickets to bring her home. Appellant alongwith her cousin reached home in Pakistan on 28-03-2022. Just after reaching appellant reported for her duties at police lines Haripur and appeared before the District Police Haripur on 29-03-2022 and explained the entire situation and problems and requested for grant of covering sanction of leave for already availed 60 days.
- 5. That the honorable District Police Officer Haripur did not pay any heed to the appellant's request of compulsions and problems and told that she had been dismissed from service vide order dated 01-03-2022 which was then delivered on 05-04-2022. (Copy of dismissal order dated 01-03-2022 is attached as "A").
- 6. That appellant has 08 years service in the police department and during the entire service she has never



obtained even a single day **EARNED LEAVE** and sufficient leave balance is available in her credit and she can be granted 60 days leave from her balance.

- 7. That absence of appellant was not a deliberate and willful act rather due to acute compulsion for serious illness of her cousin (daughter of aunt) but these facts were never taken into consideration by DPO Haripur and dismissed her within a short time of her absence.
- 8. That no proper departmental inquiry was conducted against the appellant. Neither she was issued with a Charge Sheet nor Show Cause Notice before awarding major penalty of dismissal from service. Even the appellant was not given copy of inquiry report. The appellant was condemned unheard and principle of natural justice was seriously violated in her case.
- 9. That appellant aggrieved of the dismissal order preferred a departmental appeal before the Regional Police Officer, Hazara Region, Abbottabad on 05-04-2022 which was never responded within statutory period by the respondent appellate authority. (Copy of appeal dated 05-04-2022 is attached as Annex-"B").
- 10. Hence this service appeal inter alia on the following grounds:-

GROUNDS:

A) That orders dated 01-03-2022 of the respondents is illegal, unlawful, against the facts, departmental rules & regulations, Police E&D Rules 1975, passed in a whimsical,



arbitrary & cursory manner; hence liable to be set aside.

- B) That no proper departmental inquiry was conducted. No Charge Sheet and Show Cause Notice was issued to her. Copy of enquiry report, if any, was also not given to appellant. Even opportunity of personal hearing was not afforded to him and he was condemned unheard.
- That the appellate authority has also failed to abide by the law, neither had he taken into consideration the grounds of appeal presented by appellant in his departmental appeal nor was it replied within statutory period. Thus act of the appellate authority is contrary to the Police E&D Rules 1975 read with section 24-A of General Clause Act 1897 and Article 10A of the Constitution of Islamic Republic of Pakistan 1973.
- D) That appellant was wrongly dismissed from service and departmental inquiry also could not bring any thing adverse on record against the appellant and she has been penalized without any reason and justification.
- E) That instant service appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain & adjudicate upon the lis.

PRAYER:

It is, therefore, humbly prayed that on acceptance of instant Service appeal order 01-03-2022 of the respondent may graciously be set aside and appellant be re-instated in service from the date of dismissal with grant of all consequential 5



ORDER.

LFC Sanam Naz No.725, while she posted at Police Lines, Haripur absented herself from her legitimate duties without any leave or information from the competent authority w.e.f. 25.09.2021 to 26.09.2021 (01) day, vide DD No.06 dated 25.09.2021 Folice Lines, 23.10.2021 to 25.10.2021 (02) days, vide DD No.28 dated 23.10.2021 Police Lines, 18.11.2021 to 21.11.2021 (03) days, vide DD No.19 dated 18.11.2021 Police Lines, and 01.01.2022 to till date vide DD No.22 dated 01.01.2022 Police Lines. She was also not taking interest towards her legitimate duties. Her acts were severe violation of discipline, inefficiency and a gross misconduct in terms of Khyber Pakhtunkhwa Police Efficiency & Discipline Rules 1975 (amended-2014). Therefore, she was served with charge sheet and statement of allegations vides this office Endst No. 08-09/PA, dated 28.01 2022.

To probe the allegations Deputy Superintendent of Police, HQrs, Haripur, was appointed as Enquiry Officer, who conducted proper departmental enquiry and submitted his findings, vide his office Memo No. 144 dated 10.02.2022 and held that the LFC Sanam Naz No. 725 willfully absented herself from duties and proceeded abroad without any leave or permission/NOC. The enquiry officer held the charges of misconduct against the defaulter official proved and recommended her for major punishment of dismissed from service under section-4 of Khyber Pakhtunkhwa Police Efficiency & Discipline Rules 1975 (amended-2014). Hence, she was issued with Final Show Cause Notice, vide this office Endst: No.19/PA dated 15.02.2022, but she did not submit her written reply within the stipulated period.

On receiving the recommendation of enquiry officer and relevant record, I, am fully satisfied that the charges of misconduct are proved against the defaulter police official LFC Sanam Naz No. 725 who absented herself from lawful duties without any leave or permission from the competent authority. She also went abroad without any NOC. So, the charges of misconduct stands proved beyond any doubt. Therefore, I. Lt. Cdr ® Kashif Aftab Ahmad Abbasi (PSP), District Police Officer. Haripur being competent authority under the Khyber Pakhtunkhwa, Police Efficiency and Discipline Rules 1975 (amended-2014), awarded her major punishment of "Dismissed from Service", with immediate effect...

Respectfully the following few lines are submitted for kind consideration and favorable order please:-

- 1. That on 01-01-2022, while appellant posted at Police Lines, Haripur was informed telephonically from abroad Dubai by her cousin (daughter of his Aunt) that she was seriously ill and admitted to Hospital and there was no one to look after her. The appellant in emergency informed In-charge Police Lines Haripur of the situation and started preparation for abroad.
- 2. That due to serious illness of her cousin abroad, the appellant could not spare time for approaching her officers with regard to sanction of her leave and she verbally informed her in-charge to get her leave sanction from her officers and left for abroad.

 Appellant when reached abroad she found her cousin in a very serious condition and admitted to

hospital. In such a situation the appellant had to stay with her as an attendant in the Hospital as her cousin was helpless and was without any attendant to care her.

- 3. That no sooner the appellant's cousin felt some better, the appellant get her discharged from the hospital and managed returned air tickets to bring her home. Appellant alongwith her cousin reached home in Pakistan on 28-03-2022. Just after reaching appellant reported for her duties at police lines Haripur and appeared before the District Police Haripur on 29-03-2022 and explained the entire situation and problems to his highness and requested for grant of covering sanction of leave for 60 days.
- 4. That the honorable District Police Officer Haripur did not pay any heed to the appellant's request of compulsions and problems and straight way dismissed her from service vide order dated 01-03-2022 without any reason. (Copy of dismissa) order dated 01-03-2022 is attached as "A").
- 5. That no proper departmental inquiry was conducted against the appellant. Neither she was issued with a Charge Sheet nor Show Cause Notice before awarding major penalty of dismissal from service. Even the appellant was never provided with the opportunity of personal hearing. The appellant was condemned unheard and principle of natural justice was seriously violated in her case.

- 6. That the appellant was appointed as Constable in the Police Department in the year 2014 and thus has rendered more than 08 years service. - 9. That if the appellant is provided with a chance of personal hearing she will really prove her innocence before your Highness about her constrains which she had to face during illness of her cousin.

It is, therefore, earnestly requested that keeping in view the aforementioned facts & circumstances the impugned order dated 01-03-2022 of the District Police Officer Haripur may kindly be set aside and the appellant be granted earned

PRELIMINARY OBJECTIONS:-

- 1. That the instant Service Appeal is not maintainable in the present form.
- 2. That the appellant is estopped by his own conduct.
- 3. That the appellant has not come to the Honorable Tribunal with clean hands.
- 4. That the appellant has suppressed material facts from the Honorable Tribunal.
- 5. That the instant Service Appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- 6. That the instant Service Appeal is badly barred by law and limitation.
- 7. That the appellant has filed the instant service appeal just to pressurize the respondents.
- 8. That the order passed by the authorities are based on facts & rules, after fulfilling all the codal formalities, hence, the appeal is liable to be dismissed without any further proceeding.

REPLY ON FACTS:-

1. In reply to this para, it is submitted that the appellant Ex-LFC Sanam Naz No.725, hile posted at police lines Haripur, absented herself from legitimate duties without any leave or permission from the competent authority with effects from 25.09.2021 to 26.09.2021 (01) days vide daily dairy No.06 dated 25.09.2021 Police Lines, 23.10.2021 to 25.10.2021 (02) days vide daily dairy No.28 dated 23.10.2021 Police lines, 18.11.2021 to 21.11.2021 (03) days vide daily dairy No.19 dated 18.11.2021 Police lines, and 01.01.2022 to till date vide daily dairy No.22 dated 01.01.2022 Police Lines Haripur. She was also not taking interest towards her legitimate duties. The acts and omissions of the appellant were misconduct under Khyber Pakhtunkhwa, Police Efficiency and Discipline Rules 1975. Therefore the appellant was issued charge sheet and statement of allegations by the then District Police Officer, Haripur, vide his office Endst: No. 08-09/PA dated 28.01.2022. (Copy of charge sheet and stamen of allegation is attached as annexure "A"). Mr. Fida Muhammad Deputy Superintendent of Police, HQrs Haripur was appointed as enquiry officer/ E.O. who conducted proper departmental enquiry and submitted his findings vide his

office Memo No.144 dated 10.02.2022, in which he held that the appellant willfully absented from duties and proceeded abroad without any leave orpermission/NOC. (Copy of inquiry findings is attached as annexure "B"). The E.O. held that the charges stood proved against her and recommend her for major punishment of dismissal from service. Therefore, she was issued Final Show Cause Notice vide this office Endst: No.19/PA dated 15.02.2022. (Copy of Final Show Cause Notice is attached as annexure "C") Hence, the appellant was awarded lawful punishment of dismissal from service vide OB.No.149 dated 01.03.2022 by the then District Police Officer, Haripur. (Copy of order is attached as annexure "D"). Therefore, the appellant filed departmental appeal against the punishment to the Regional Police Officer, Hazara Region, Abbottabad, who filed/rejected appeal of appellant, vide his office order No. 115/PA dated 02.08.2022. (Copy of order is attached as annexure "E")

- 2. Incorrect, the appellant is generating false stories. She proceeded abroad without any leave or permission from competent authority. Her conduct was contrary to discipline of police force.
- 3. Incorrect, the appellant is deceiving the authorities. She absented herself from lawful duties and proceeded abroad. Being government servant she ought to follow the law, rules and regulations of government/department, she was member of police force and her leaving the country without following the law, rules, regulations and procedures is neither warranted nor overlooked in public interests. Her conduct was probed and she was held guilty of gross misconduct. Having fulfilled all legal requirements, she was awarded major punishment of dismissal from service.
- 4. Incorrect, the appellant took the law in her hands. She proceeded abroad without any leave or permission from competent authority. There is no proof of any such illness of her alleged cousin, it is worth mentioning that the appellant was not health specialist, who allegedly proceeded abroad for treatment. She has admitted her proceeding abroad. Her conduct was a security threat/risk. She is not entitled for re-instatement in service, as she would tarnish the image of police in public. Her misconduct was proved in the departmental enquiry, to which she was awarded quite legal punishment. Moreover, leave is not vested right of civil servant, rather it is desecration of competent authority.
- 5. Incorrect, the appellant had committed gross misconduct. Therefore, lawful action was taken and proper departmental inquiry was conducted against the appellant. She was found guilty of gross misconduct. Therefore, the appellant was awarded quite legal punishment of dismissal from service by the then District Police Officer, Haripur vide OB. No.149 dated 01.03.2022. All facts, circumstances and

relevant evidence were taken into consideration while passing punishment to the appellant.

- 6. Incorrect, the appellant does not possess meritorious service record, rather she was awarded several punishments during her past service on account of absence from duties. She is habitual absentee. The detail is given below:
 - i. Warning vide OB.No.446 dated 21.06.2018.
 - ii. Warning vide OB.No.691 dated 15.10.2018.
 - iii. Fine Rs.300/- vide OB.No.789 dated 21.10.2020.
 - iv. Warning vide OB.No.709 dated 30.12.2021.
- 7. Incorrect, the appellant willfully absented from lawful duties and proceeded abroad without prior leave or permission from the competent authority. She breached the law, rules and regulations and resorted to arrogant acts. Her conduct is also affecting the discipline of member of police force. Her willful absence from duty was proved through cogent evidence. All facts, circumstances and evidence were taken into consideration by the then District Police Officer, Haripur while passing punishment to the appellant. The punishment awarded to the appellant commensurate with the gravity of charges.
- 8. Incorrect, proper departmental inquiry was conducted, the enquiry officer collected the relevant evidence, she was held guilty of gross misconduct by the enquiry officer, on receiving enquiry finding, she was issued Final Show Cause Notice under the law/rules. Hence, all legal requirements and principles of were fulfilled while awarding punishment to the appellant.
- 9. Incorrect, the departmental appellate authority i.e. Regional Police Officer, Hazara Region, Abbottabad vide his office order No.115/PA dated 02.08.2022 rejected the departmental appeal of appellant on lawful grounds and justification.
- 10. Incorrect, the instant service appeal is not maintainable on the following grounds.

REPLY ON GROUNDS:-

- A) Incorrect, the order of punishment of the respondents dated 01.03.2022 and 02.08.2022, are quite legal, based on facts and evidence. Hence, the orders are lawful and maintainable.
- B) Incorrect, proper departmental inquiry was conducted. She did not join the departmental inquiry despite repeated summons by enquiry officer. She was held guilty of misconduct in the departmental enquiry and recommended for major punishment. Therefore, she was also issued Final Show Cause Notice under the law/rules. She was awarded punishment of dismissal from service on lawful grounds and evidence. Hence, all legal requirements were fulfilled while passing punishment to the appellant.
- C) Incorrect, the appellant was dealt in accordance with law/rules. The departmental appellate authority took into consideration all facts, evidence and relevant enquiry

Papers, moreover, the appellant was also heard in person by the appellate authority and being satisfied with punishment order of competent authority, the departmental appellate authority rejected the departmental appeal of appellant vide order No.115/PA dated 02.08.2022. All principles of natural justice were observed, hence, the punishment awarded to the appellant is lawful and maintainable.

- D) Incorrect, the appellant committed gross misconduct to which lawful departmental action was taken and she was awarded major punishment of dismissal from service on lawful grounds, evidence, reasons and justification. Hence, the punishment is maintainable under the law/rules.
- E) Incorrect, the instant service appeal is time barred and not maintainable under the law/rules.

PRAYER:-

In view of above stated facts it is most humbly prayed that the instant service appeal does not hold any legal force, may kindly be dismissed with costs, please.

Incorrect, it is submitted that the applicant/appellant Ex- LFC Sanam Naz No.725, while posted at Police Lines Haripur, absented from legitimate duties without any leave or permission from the competent authority with effect from 25.09.2021 to 26.09.2021 (01) day vide Daily Dairy MADD No.06 dated 25.09.2021 Police Lines, 23.10.2021 to 25.10.2021 (02) days vide Daily Dairy MADD No.28 dated 23.10.2021 Police Lines, 18.11.2021 to 21.11.2021 (03) days vide Daily Dairy MADD No.19 dated 18.11.2021 Police Lines, and 01.01.2022 till date vide Daily Dairy MADD No.22 dated 01.01.2022 Police Lines Haripur. She was also not taking interest in her legitimate duties. The acts and omissions of the appellant were tantamount to misconduct under Khyber Pakhtunkhwa, Police Efficiency and Discipline Rules 1975. Therefore the appellant was issued charge sheet and statement of allegations by the then District Police Officer, Haripur, vide his office Endst: No. 08-09/PA dated 28.01.2022. Mr. Fida Muhammad Deputy Superintendent of Police, HQrs Haripur was appointed as Enquiry Officer/ (E.O.), who conducted proper departmental enquiry and submitted his findings vide his office Memo No.144 dated 10.02.2022, in which he held that the appellant willfully absented from duties and proceeded abroad without any leave or permission/NOC. The E.O. held that the charges stood proved against her and recommend her for major punishment of dismissal from service. Therefore, she was issued Final Show Cause Notice vide this office Endst: No.19/PA dated 15.02.2022. Hence, the appellant was awarded lawful punishment of dismissal from service vide OB.No.149 dated 01.03.2022 by the then District Police Officer, Haripur. The instant servicer appeal is badly time

barred and not maintainable under the law. Moreover, statutory rights have accrued to the respondents department.

- 2. Incorrect, the respondents dealt the applicant/appellant in accordance with law/rules. The orders of punishment passed by the respondents are quite legal, based on evidence and facts, hence, maintainable under the law/rules. Moreover, the applicant has no cause of action to file the instant service appeal, as it is time barred.
- 3. Incorrect, the orders of punishment are quite legal, based on facts, evidence and principles of natural justice, hence, maintainable under the law/rules.
- 4. Incorrect, the application condonation of delay does not hold any legal force and liable to be dismissed.

LFC Sanam Naz No. 725, while she posted at Police Lines, Haripur absented herself from her legitimate duties without any leave or information from the competent authority w.e.f 25.09.2021 to 26.09.2021 (01) day, vide DD No.06 dated 25.09.2021 Police Lines, 23.10.2021 to 25.10.2021 (02) days, vide DD No.28 dated 23.10.2021 Police Lines, 18.11.2021 to 21.11.2021 (03) days, vide DD No.19 dated 18.11.2021 Police Lines, and 01.01.2022 to till date vide DD No.22 dated 01.01.2022 Police Lines. She was also not taking interest towards her legitimate duties. Her acts were severe violation of discipline, inefficiency and a gross misconduct in terms of Khyber Pakhtunkhwa Police Efficiency & Discipline Rules 1975 (amended-2014). Therefore, she was served with charge sheet and statement of allegations vides this office Endst No. 08-09/PA, dated 28.01.2022.

To probe the allegations Deputy Superintendent of Police, HQrs, Haripur, was appointed as Enquiry Officer, who conducted proper departmental enquiry and submitted his findings, vide his office Memo No. 144 dated 10.02.2022 and held that the LFC Sanam Naz No. 725 willfully absented herself from duties and proceeded abroad without any leave or permission/NOC. The enquiry officer held the charges of misconduct against the defaulter official proved and recommended her for major punishment of dismissed from service under section-4 of Khyber Pakhtunkhwa Police Efficiency & Discipline Rules 1975 (amended-2014). Hence, she was issued with Final Show Cause Notice, vide this office Endst: No.19/PA dated 15.02.2022, but she did not submit her written reply within the stipulated period.

On receiving the recommendation of enquiry officer and relevant record, I, am fully satisfied that the charges of misconduct are proved against the defaulter police official LFC Sanam Naz No. 725 who absented herself from lawful duties without any leave or permission from the competent authority. She also went abroad without any NOC. So, the charges of misconduct stands proved beyond any doubt. Therefore, I, Lt. Cdr ® Kashif Aftab Ahmad Abbasi (PSP), District Police Officer, Haripur being competent authority under the Khyber Pakhtunkhwa, Police Efficiency and Discipline Rules 1975 (amended-2014), awarded her major punishment of "Dismissed from Service", with immediate effect.



ORDER

This order will dispose of departmental appeal under Rule 11-A of Khyber Pakhtunkhwa Police Rules, 1975 submitted by Ex. LFC Sanam Naz 725 of district Haripur against the order of punishment i.e. dismissal from service awarded by DPO Haripur vide OB No.149 dated 01.03.2022.

Brief facts leading to the punishment are that the appellant while posted at Police Lines Haripur absented herself from legitimate duties and proceeded abroad without any leave/permission and NOC from the competent authority (absence 02 months and 06 days).

The appellant was issued charge sheet alongwith summary of allegations and DSP Hqrs Haripur was deputed to conduct departmental enquiry. The EO held the appellant responsible of misconduct and recommended her for major punishment. The appellant was issued final show cause notice but she failed to advance any cogent reason before the competent authority. Consequently, DPO Haripur awarded her major punishment of dismissal from service. Hence, the appellant submitted this present appeal.

After receiving her appeal, comments of DPO Haripur were sought and examined/perused. The undersigned called the appellant in OR and heard her in person. However, she failed to advance any plausible justification in her defense. The allegations leveled against the appellant were proved beyond reasonable doubt. She despite been part and parcel of a disciplinary force deliberately violated the rules/procedures and without permission went abroad. Such practices are unacceptable in a disciplined force. Thus, the disciplinary action taken by the competent authority seems suitable and the appeal is liable to be dismissed. Therefore, in exercise of the powers conferred upon the undersigned under Rule 11-4 (a) of Khyber Pakhtunkawa Police Rules, 1975 the instant appeal is hereby filed/rejected with immediate
