**Respectfully Sheweth:**

1. That appellant was initially appointed as Lady-Constable in the year 2011 and was serving the department with efficiency.
2. That on 02-08-2023, appellant was placed under suspension on account of absence from duty without leave / permission by R. No. 01. (Copy as annex "A")


3. That on 07-08-2023, Charge Sheet and Statement of Allegations was issued to appellant regarding the aforesaid absence from duty which was replied on 16-08-2023 and denied the allegations. (Copies as annex "B" & "C")
4. That enquiry into the matter was initiated but the same was not conducted as per the mandate of law. Self-made report was finalized by the Inquiry Office and submitted to the authority for onward action on 04-09-2023 recommended her for major punishment. (Copy as annex "D")
5. That at the same time, appellant was also undergoing treatment for her illness. (Copies as annex "E")
6. That on 09-10-2023, R. No. 01 imposed major punishment of compulsory retirement from service with effect from 09-07-2023 retrospectively. (Copy as annex "F")
7. That on 07-11-2023, appellant submitted representation before R. No. 02 for reinstatement in service, followed by subsequent representation on 11-06-2024 for the same purpose which was rejected on 23-08-2024. (Copies as annex "G", "H" & "I")

Hence this appeal, inter alia, on the following grounds:-

**GROUND S:**

- a. That absence from service of appellant was not willful but was due to the compelling circumstances.
- b. That codel formalities were not followed while dismissing the appellant from service.
- c. That under the law, no administrative order could be affected retrospectively.
- d. That the punishment imposed upon the appellant is very harsh and does not commensurate with the nature of guilty, being female.
- e. That no regular enquiry was conducted into the matter, no statement of any witness(s) was recorded what to speak of giving opportunity of cross examination upon the witness(s)

It is, therefore, most humbly prayed that on acceptance of appeal, orders dated 09-10-2023 and 23-08-2024 of the respondents be set aside and appellant be reinstated in service with all consequential benefits, with such other relief as may be deemed proper and just in circumstances of the case.





**ORDER ON ENQUIRY OF LADY CONST: SHAKEELA NO.1418**

This order will dispose-off a Departmental Enquiry under Police Rules 1975, initiated against Lady Constable Shakeela No.1418, under the allegations that while posted at Police Lines Mardan (now under suspension Police Lines Mardan), was placed under suspension vide this office OB No.1547 dated 02-08-2023, issued vide order/endorsement No.3812-14/OSI dated 04-08-2023, on account of absence from duty without any leave/permission of the competent authority vide DD No.40 dated 09-07-2023 till-date.

To ascertain facts, she was proceeded against departmentally through Inspector Sher Nawas RI Police Lines Mardan vide this office Statement of Disciplinary Action/Charge Sheet No.200/PA dated 07-08-2023, who (E.O) after fulfillment necessary process, submitted his Finding Report to this office vide his office letter No.56 dated 05-09-2023, holding responsible her of gross misconduct & recommended for major punishment.

**Final Order**

Lady Constable Shakeela was heard in-person on 06-10-2023, during which, she could not present any cogent reasons against the allegations, therefore, awarded her major punishment of compulsory retirement from service with effect from 09-07-2023 with immediate effect, in exercise of the power vested in me under P.R-1975.

ORDER.

This order will dispose-off the departmental appeal preferred by Ex-Sub Constable Shakeela No. 1418 of Mardan District Police against the order of the then District Police Officer, Mardan, whereby she was awarded major punishment of compulsory retirement from service vide OB No. 1977 dated 09.10.2023. The appellant was proceeded against departmentally on the allegations that she while posted at Police Lines, Mardan, remained absent from lawful duty without any leave/permission of the competent authority vide daily diary No. 40 dated 09.07.2023 till date of her compulsory retirement from service.

Therefore, proper departmental enquiry proceedings were initiated against her. She was issued Charge Sheet alongwith Statement of Allegations and Reserve Inspector, Mardan was nominated as Enquiry Officer. The Enquiry Officer after fulfilling codal formalities submitted his findings to the then District Police Officer, Mardan, wherein he found her guilty of misconduct and recommended for awarding major punishment.

She was also provided opportunity of self defense by summoning her in the Orderly Room by the then District Police Officer, Mardan on 06.10.2023. She failed to advance any cogent reasons in her defense. Hence, she was awarded major punishment of compulsory retirement from service with effect from 09.07.2023 vide OB No. 1977 dated 09.10.2023.

Fearing aggrieved from the order of the then District Police Officer, Mardan, the appellant preferred the instant appeal. She was summoned and heard in person in Orderly Room held in this office on 21.05.2024.

From the perusal of the enquiry file and service record of the appellant, it has been found that allegations leveled against the appellant have been proved beyond any shadow of doubt. As she has bitterly failed to produce any cogent reasons to justify her absence because the same clearly depicts her casual and lethargic attitude towards her official duties. The very conduct of appellant is unbecoming of a disciplined Police Officer. On perusal of previous service record of the appellant, it was noticed that she is habitual absentee and prior to this, she was also dismissed from service for her disinterest in her official duties. It is noted while that the appellant approached this forum yet she was away for 07 months and 02 days without advancing any cogent reason, hence, strictly time barred. Therefore, orders passed by the competent authority does not warrant any interference.

Keeping in view the above, I, Najeeb-Ur-Rehman Bugvi, PSP Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, therefore, the same is rejected and filed, being devoid of merit as well as badly time barred for 07 months and 02 days.

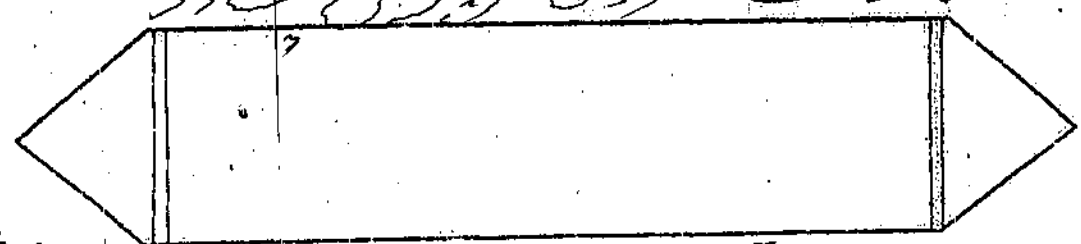
