 TRIBUNAL ACT, 1974 AGAINST SENIORITY LIST  
 NO. 193-E / 534 / CEC / C & W D AND NO. 192-E /  
 542 / CEC / C & W D BOTH DATED 01-04-2024 AND  
 02-04-2024 RESPECTIVELY OF R. NO. 01 WHEREBY  
 2 SEPARATE SENIORITY LISTS OF ACCOUNTS  
 CLERKS AND SENIOR CLERKS WERE CIRCULATED  
 FOR NO LEGAL REASON.**

**Respectfully Sheweth:**

1. That appellant being qualified, was appointed as Junior Clerk now B-11 and with the passage of time and hard work he was promoted as Senior Clerk B-14 and now are suitable and fit for promotion to the post of Assistant B-16, as per service rules.

2. That on 25-03-2010, C & W department issued Notification wherein method of recruitment, qualification and other conditions were specified. At S. No. 21 post of Assistant B-16 was to be filled up:-
  - a. 25% by initial recruitments, and 75% by promotion on the basis of seniority cum-fitness, from amongst the Accounts Clerks / Senior Clerks, with at least five years' service as such,  
**Note:** - for the purpose of promotion a joint seniority list of Accounts Clerks and Senior Clerks shall be maintained. (Copy as annex "A")
3. That in disregard of the aforesaid rules / law, the department issued double separate seniority lists on 01-04-2024 and 02-04-2024 respectively, wherein both the categories i.e. Accounts Clerks B-14 and Senior Clerks B-14 of the department was circulated for promotion to the post of Assistant B-16. No distinction was drawn as to whether the authority shall utilize seniority list of Accounts Clerks or Senior Clerks. (Copies as annex "B" & "C")
4. That the department adopted a unique procedure by promoting Senior Clerks to the post of Account Clerks but such procedure as nullity in the eyes of law as how a same scale B-14 i.e. Senior Clerk be promoted as Account Clerk B-14.
5. That to further clarify the position in the rules ibid, the post of Superintendent B-17 was to be filled amongst Assistant / Senior Scale Stenographers B-16 at joint seniority list and not a separate list and the department is issuing joint seniority list for the purpose of promotion.
6. That on 24-04-2024, appellant came to know about the issuance of seniority lists dated 01-04-2024 and 02-04-2024, so on 10-05-2024, he submitted representation before R. No. 02 by stating therein facts and circumstances of the case regarding earlier joint seniority list of the Accounts Clerks and Senior Clerks and separate seniority lists of the two categories but in vain. (Copy as annex "D")


Hence this appeal, inter alia, on the following grounds:-

**GROUND S:**


- a. That issuing joint seniority list for both the categories of Accounts Clerks and Senior Clerks, promotion to the post of Assistant was to be made in joint seniority list of the both the categories and not separate seniority lists.
- b. That career progression is the right of the petitioners but the respondents by adopting the illegal practice of issuing separate seniority list is depriving the petitioners from their due right of promotion to the higher post / grade.
- c. That in presence of Notification dated 25-03-2010, the authority is not empowered to issue two separate seniority lists unless and until the said rules are not amended.
- d. That in the said Notification, note was given which provided joint seniority list of the Account Clerks and Senior Clerks was to be maintained for further promotion to the next higher post / grade.
- e. That no bifurcation was made in the two seniority lists as to which one shall act upon earlier and to what extent. This creates ambiguity amongst the employees of both the categories which requires worth consideration.
- f. That respondents has adopted a unique, illegal and against law and rules by issuing two separate seniority lists for the post of Accounts Clerks and Senior Clerks.
- g. That appellant being Senior Clerk would suffer a lot from illegal and unwarranted practice of the department requested the authority time and again to follow the rules in letter and spirit but in vain.
- h. That process of promotion to the further post is carried out on the two separate seniority lists the same would be null and void as per the rules *ibid*.

1. That no reason whatsoever was given to adopt and separate the categories of Accounts Clerks and Senior Clerks so the double seniority lists are of no legal effect, rather based on ulterior motive.


It is, therefore, most humbly prayed that on acceptance of the Appeal, Notifications dated 01-04-2024 and 02-04-2024 (both) be set aside and Notification dated 25-03-2010 be implemented / restored by issuing combined seniority list of both the categories i.e. Accounts Clerks and Senior Clerks and promotions be made from the combined seniority list, with such other relief as may be deemed proper and just in circumstances of the case.

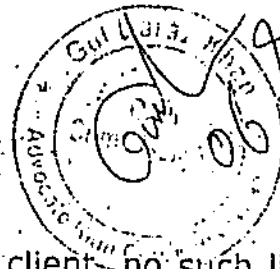




1. That, Appellant was appointed by the competent authority in department as junior Clerk in the year 2010 and is now performance duty as Senior Clerk (BPS-14).

  7. That, according to the mandate of the rules of the subject, the Appellant does not want to be promoted to the post of Accounts Clerk rather he wants to be treated in accordance with law by considering him for the promotion of the post of Office Assistant (BPS-16), subject to issuance of joint Seniority list and on the basis of Seniority-Cum-Fitness.

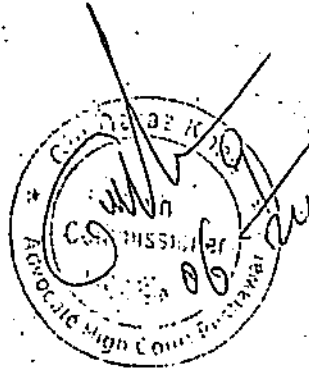
