APPEAL UNDER SECTION 4 OF THE <u>KHYBER</u> **PAKHTUNKHWA** SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER DATED 16-05-2024 PASSED BY THE DEPUTY INSPECTOR GENERAL **O**F POLICE, <u>(C</u>TD) KHYBER <u>P</u>ESHAWAR (RESPONDENT NO.1) WHEREBY THE <u>APPELLANT WAS AWARDED MAJOR</u> PENALTY OF REDUCTION FROM SUBSTANTIVE RANK of (DSP) INTO <u>THAT OF LOWER</u> RANK BUT NOTWITHTANDING THE BASIC LEGAL <u>MENDATE,</u> NO **SPECIFICATION** WHATSOEVER WAS MADE ABOUT THE PENALTY IN LOWER RANK. BESIDES,  $\underline{IT}$ WAS FURTHER ORDERED TO <u>RECOVER</u> RS. 01 MILLION FROM APPELLANT'S GENERAL PROVIDENT

FUND, THE LEGALITY OF SAID ORDER WAS NONETHELESS CHALLEGNED BY **FILING** DEPARTMENTAL APPEAL WITH THE PROVINCIAL **POLICE** OFFICER, **PAKHTUNKHWA** KHYBER (RESPONDENT NO.02) ON 22-05-2<u>024.</u> HOWEVER, THE SAME WAS NOT <u>RESPONDED WITHIN THE STATUTORY</u> PERIOD OF LAW.

# <u>Prayer in Appeal</u>

On acceptance of this appeal, the impugned order dated 16-05-2024 may very graciously be set-aside and the appellant may kindly be restored against his original post of Deputy Superintendent of Police alongwith all consequential back benefits.

Any other relief deemed appropriate in the circumstances of the case, not specifically asked for, may also be granted to the appellant.

# Short facts giving rise to the present appeal are as under:

# <u>FACTS</u>

That the appellant joined the services of Police Department incapacity as Assistant Sub-Inspector (BS-09) on 27-02-2006 and then rose up to the post of Deputy Superintendent of Police (BS-17) on account of dedication, devotion and meritorious service. He has 18 years unblemished service record to his credit.

That the appellant was transferred to various posts across different stations and units throughout his service. Lastly, his services were placed at the disposal of Commandant, Special Security Unit (CPEC) Khyber Pakhtunkhwa vide order dated 30-03-2023 who further assigned him the duty to ensure the security of foreign national/Chinese engineers, as part of the (Remodeling Canal System Project Malaguri, Tribal District, Khyber).

(Copy of transfer order is appended as Annex-A)

3.

That the appellant was performing his duty with great zeal, zest and devotion but strangely, one Amanullah, Assistant Sub-Inspector, CTD, Bannu Region-II moved an application that he was not paid of the **Head Money Share** for the arrest of proclaimed offender namely Usman s/o Rooh Niaz r/o Irmaz Tehsil Mirali District North Waziristan, involved in case FIR No. 49 dated 30-07-2020 u/s 324/148/149/109 PPC, 3/4ESA, 7ATA PS CTD Bannu Region.

# (Copy of application is appended as Annex-B).

That on the basis of above application, Superintendent of Police (Admin) CTD was nominated to conduct preliminary inquiry in the matter. He finalized the inquiry and held the appellant guilty and recommended him to be proceeded against departmentally by issuing him charge sheet and statement of allegations to fulfill all legal requirements. However, copy of such report was not provided to him being the mandatory requirement of law.

That as per recommendation of above report of inquiry officer, appellant was served with a charge sheet alongwith statement of allegations for misconduct. He submitted an elaborate and exhaustive reply, denied the allegations and also termed it as fallacious, malicious and misconceived. He besides other submissions also specifically emphasized that "shares in the disputed Head Money were duly distributed amongst the officials/informers who were legally entitled for the same and none of the objection was raised by any official at the relevant time", therefore, question of misappropriation of said money was not justified at all. He also termed the application filed by Amanullah, Assistant Sub-Inspector as frivolous and baseless one and categorically added that the appellant had initiated disciplinary proceedings against him in the past. Wherein, not only charge sheet alongwith statement of allegations were issued but enquiry was duly conducted and on the basis of report of inquiry officer as well as letter of appellant addressed to Deputy Inspector General of Police, CTD, Khyber Pakhtunkhwa he was repatriated from CTD, Khyber Pakhtunkhwa to his parent region Bannu vide order dated 29-12-2022. Similarly, the appellant also issued adverse remarks in the Annual Confidential Report "ACR" for the period from 01-01-2022 to 31-12-2022, which were formly countersigned and endorsed by the Deputy Inspector General of Police, CTD Khyber Pakhtunkhwa. Thus, the instant application was filed solely as a retaliatory measure, intended to undermine, discredit, and tarnish the appellant's reputation

before his 'superiors, and also to seek retribution for the aforementioned disciplinary actions and adverse remarks. Moreover, he filed such application after lapse of a long period of one and a half years, at belated stage which also creates doubt in the prudent mind that when he was entitled for such share of (Head Money) then why he slept over it for a sufficient long time and failed to make any demand. Moreover, the application was filed after a considerable delay of one and a half years ,which act alone raises serious concerns about its credibility. This prolonged inaction clearly suggests that if he was indeed entitled to the Head Money, his inordinate delay in asserting this claim and failing to make any timely demand seriously undermines the legitimacy of his current request.

6. That the above reply submitted by the appellant was not found satisfactory and as such, Mr. Najam-ul-Hussain Laiqat, Senior Superintendent of Police, CTD, Peshawar was appointed as Inquiry Officer to dig out the truth and submit report. He concluded the inquiry and found the appellant guilty of the allegations nevertheless, in clear contravention of legal procedures. Furthermore, despite the appellant's requests for the report and other relevant documents under the Right to Information "RTI" Act, 2013, neither the reports nor the requested documents were provided, rendering the process both opaque and unjust.

(Copy of applications and letter of RTI are appended as Annex-J, K & L).

7. That thereafter the appellant was served with a final show cause notice on 06-05-2024. He submitted reply on 14-05-2024 but the same was also not deemed satisfactory and ultimately, he was awarded major penalty of reduction from substantive rank of DSP into that of lower rank but

no specification whatsoever was made about penalty in lower rank as required under the law. It was further ordered to recover Rs. 01 Million from his GP Fund vide order dated 16-05-2024.

8. That the appellant felt aggrieved by the aforesaid order, filed a departmental appeal with the Provincial Police Officer (respondent No.02) on 22-05-2024 but the same was also not responded.

# (Copy of departmental appeal is appended as Annex-P).

**9.** That the appellant now files this appeal before this Hon'ble Tribunal inter-alia on the following grounds within the statutory period of law.

# <u>GROUNDS</u>

**B.** .

A. That the respondents have not treated the appellant in accordance with the mandate of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 which has unequivocally laid down that it is the inalienable right of every citizen to be treated under the law, rules and policy. Therefore, the impugned order is not sustainable in the eye of law.

That Preliminary Inquiry was not conducted in a manner prescribed by law as neither any witness was examined in the presence of appellant nor he was provided any opportunity of cross-examination in order to impeach the credibility of the witnesses, if any, appeared against him. Similarly, he was also not provided any chance to produce his defence in support of his version. The above defect in inquiry proceeding issufficient to declare entire process as unlawful and distrustful. Right of fair trial is a fundamental right by dint of which a person is entitled to a fair trial and due process of law. The appellant has been deprived of his indispensable fundamental right of fair trial as enshrined in Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973. Besides, the Deputy Inspector General of Police, CTD, Khyber Pakhtnkhwa (respondent No.01) was not competent under Rule-5(4) read with Schedule-I of Khyber Pakhtunkhwa Police Rules, 1975 (amended 2014) to initiate disciplinary proceedings against the appellant by constituting

preliminary inquiry as well as regular inquiry and the Provincial Police Officer, Khyber Pakhtunkhwa (respondent No.02) was alone competent to exercise such powers under the above referred provision of rules. It is also well settled law that when initial order or act relating to initiation of proceedings is illegal and without lawful authority then, all subsequent proceedings and actions taken thereon would fall on the ground automatically. Reliance can be placed on the judgment of august Supreme Court of Pakistan reported in 2009-SCMR-339. The relevant citation is reproduced as under:-

#### 2009-SCMR-page-339 (citation-c)

----When initial order or act relating of initiation of proceedings was contrary to law and illegal, then all subsequent proceedings and actions taken thereon would have no basis and would fall.

Akin, the impugned order was issued by the Deputy Inspector General of Police, CTD, Khyber Pakhtunkhwa (Respondent No. 01), who lacked the requisite authority to issue such an order and according to Schedule-I of the Khyber Pakhtunkhwa Police Rules, 1975, only the PPO (Respondent No. 02) is authorized to issue such an order. It is well established principle of law that when the basic order is without lawful authority and void ab-initio then the entire superstructure built on it would fall on the ground automatically as per law laid down by august Supreme Court of Pakistan reported in PLD-2008-Suprme Court-663 (citation-b) and 2024-SCMR-527 (citation-g). It would be advantageous to reproduce herein the relevant citations for facility of reference:

> P L D 2008 Supreme Court 663 (citation-b) (b) Void order---

> ----When the basic order is

without lawful authority and void ab initio, then the entire superstructure raised thereon falls on the ground automatically.

# 2024 S C M R 527 (citation-g) (g) Void order---

----When the basic order is without lawful authority, then the entire superstructure raised thereon falls to the ground automatically. Hence, the impugned order is liable to be set aside on this count alone.

That likewise, the regular inquiry was also conducted in manifest violation of legal standards, as the same irregularities, procedural errors, and lapses carried out by the Inquiry Officer during the preliminary inquiry were repeated. Consequently, the appellant was denied his basic fundamental right to a fair trial and due process. Both Inquiry Officers' reports are therefore based on conjecture and unsubstantiated assumptions. As a result, the findings against the appellant are manifestly erroneous and unsupported by any legal evidence, rendering them untenable under the law. The entire process, from initiation to conclusion, fails to uphold the principles of justice, making the impugned order legally untenable and as such liable to be reversed.

That the respondent No.1 was under statutory obligation to have considered the case of appellant in its true perspective and also in accordance with law besides to see whether both the inquires were conducted in consonance with law and that the allegations thereof were proved against him without any shadow of doubt or otherwise. Nevertheless, he has overlooked this important aspect of the case without any cogent and valid reasons and awarded him major penalty of reduction from substantive rank of DSP into that of lower rank but no specification whatsoever was made about penalty in lower rank as required under the law. Hence, the impugned order is not tenable under the law.

Ε.

That the respondent No.2 was legally bound to have decided the departmental appeal filed by the appellant after application of mind with cogent reasons within reasonable time as per law laid down by august Supreme Court of Pakistan reported in **2011-SCMR-1 (citation-b).** The relevant citation is as under:

2011-S C M R-1 (citation-b)

----S. 24-A---Speaking order-Public functionaries are bound to decide cases of their subordinates after application of mind with cogent reasons within reasonable time.

But the above Authority failed to comply with the supra legal principle. Therefore, the impugned order is not warranted by the law.

D.

C.

That the appellant was not provided with any of the inquiry reports to address or respond to the adverse findings against him, which is a clear legal requirement. This omission undermines the appellant's right to a fair opportunity to contest the findings, thus violating procedural fairness and due process. Reliance can be placed on PLD-1981-SC-page-176citation (f) and 1987-SCMR-1776-(b). Hence, the impugned order is against the spirit of administration of justice.

That the impugned order is against law, facts of the case and norms of natural justice. Therefore, the same is not warranted by the law.

That the respondent No.1 has passed the impugned order in mechanical manner and the same is perfunctory as well as non-speaking and also against the basic principle of administration of justice. Thus, the impugned order is bad in law.

That the impugned order is based on conjectures, surmises and suppositions. Hence, the same is against the legal norms of justice.

That the appellant would like to seek the permission of this Hon'ble Tribunal to advance some more grounds at the time of arguments.

# <u>PRAYER</u>

In view of the above narrated facts and grounds, it is, therefore, humbly prayed that the impugned order dated 16-05-2024 may very graciously be set-aside and the appellant may kindly be restored against his original post of Deputy Superintendent of Police along with all consequential back benefits.

Mr. Imran Shahid, Deputy Inspector General of Police, CTF & EC, CTD. Khyber Pakhtunkhwa, as competent authority, under rule 06 of the KPK Police Rules, 1975, hereby charge you Arraad All Shat presente paster as DSP Statements and the test of test of the test of posted on basis of look after charge as SP C(D) Bannu Region (BPS-16), for the allegations mentioned below .

You, while posted on basis of look after charge as SP CTD Bannu Region (BPS-16), claimed & received reward 01 million rupces as head money for disbursement amongst the members of raiding team who participated in conducting raid vide DD No. 18 dated 20.06,2022 PS CTD Hannu Regiou, total 13 officials in which an ASI namely Haji Aman Ullah was also included and arrested Proclaimed (Afender (P.O) namely Usman s/o Rooh Niaz r/o Irmaz Tehsil Mirali, District North Waziristan involved in case vide FIR No. 49 dated 30.07.2020 u/s 324/148 149/109 PPC, 3/41/SA, 7ATA PS CTD Bannu Region, but as per preliminary enquiry report you misappropriated the whole amount of 1 million fixed as head money for the artest of s above named P.O instead its disbursement upon the participants raiding team.

That, ASI Haji Aman Ullah, submitted application/complaint through Police Jawan App vide No. 1952 dated 29,08,2023 against you, wherein he alleged that you deprived him from his legal right (head money reward share) as you had already received the same from CTD HQrs; and did not disburse his due share to him as well as to the other team members.

Upon complaint of ASI Haji Aman Ullah, a fact finding enquiry was carried out. During the ш. course of enquity, team members were associated with enquiry proceedings and their statements were recorded which are placed on enquiry file, except former Insp: Javed Igbal the then SHO PS CID Bannu, as he got martyred while one HC Irfan Ullah, as he got injured during an encounter. All the members of raiding team denied in their statements to have received their due share from head money and fixed for the arrest of above pamed P.O which causes resentment in the Force.

You, during preliminary enquiry admitted, that you have received 01 million rupees as reward ñ. of head money for above named P.O and showed that you distributed 60% to the informer, 10% received as your own share while showed remaining 30% amount to be handed over to former. Inspector Javed lqbal the then SHO PS CTD Bannu now martyred but you could not produce any proof in this regard.

Yon, could not prove yourself innocent & was found guilty of misconduct during the course of preliminary enquiry, hence you are formally charge sheeted for the allegations mentioned above. Its reason of the above, you appear to be guilty of misconduct under the KP Police Rules, 1975.

and have rendered yourself liable to all or any of the penalties specified in the said Rules. You are, therefore, directed to submit your written defense within seven (07) days of the receipt of 3: this Charge Sheet to the Enquiry Officer.

But not provided, reasons best known to the Authority, although I went from post to pillar and knock every door to get the desired essential documents but all my cries fell on deaf ear, evident from RTI Application dated: 12.02.2024 & complaint dated: 22.02.2024 to KP-RTI Commission, Peshawar.

That I left with no other option but to invoke constitution jurisdiction of the Hon'ble Peshawar High Court, Peshawar through Writ Petition No.1401-P/2024, which was disposed of vide Judgment dated: 28.03.2024; in presence of the representative of the department, with the following directions,

"When we confronted the learned counsel for the petitioner with Rule-12 of the " Khyber-Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 in terms of which any document that relates to the merits of the inquiry and is relevant can be regulsitioned by the inquiry committee or the inquiry officer as the case may be. He on giving second thought stated that during the course of inquiry, it any document is required, he will submit on application to the inquiry Officer in terms of the relevant rules. The inquiry committee having the powers of the civil court has ample powers to decide the said application and regulsition the required documents which are relevant for the purpose of inquiry. This petition is disposed of in the above terms".

The Judgment dated: 28.03.2024 ibid was properly communicated to the concerned quarters alongwith opplication for providing of desired essential documents mentioned in preceding Para-2,

That astonishingly the Inquiry Committee/Officer, instead to provide the desired essential documents, has unilaterally submitted final inquiry report, reflecting from the final show cause notice, hence the instant application.

5. That I neither in possession of the relevant documents, mentioned in preceding para No.2, nor the final inquiry report alongwith ancillary document/ evidence was provided alongwith subject mentioned final Show Cause Notice, nor I was ever associated with the so-called unilateral inquiry proceedings, hence has been condemned unheard, which attracts the doctrine of audi alteram partem.

6. That I have been compelled to answer the queries either put forward in shape of statement of allegation/charge sheet or the subject mentioned final Show Cause Notice, without providing the desired essential documents, in compliance of the Judgment dated: 28:03:2024 of the Hon'ble Peshawar High Courl. Peshawar and law/rules governing the subject, which has caused grave miscarriage of justice.

 Indi Lindve neither been treated in accordance with law nor Lindve been provided equal protection of law, enshined in Articles 4 & 10-A of the Constitution of Islamic Republic of Pakistan, 1973;

 That any other additional ground / documentary proof, with the permission your esteemed office, will be taken/produced at the time of personal hearing; if granted.

## ORDER

5

This order will depose off the enquiry in hand initiated against acting DSP Asad Ali Shah BPS-16 (the accused official), then posted/assigned took after charge as Acting SP CTD, Bannu Region (BPS-16) on complaint of ASI Aman Ullah (the Complainant), of District Police Bannu, lodged on Police Jawan App. He stated that he was posted in operation wing CTD Bannu Region during the year 2022 under the command of the accused officer Asad Ali Shah, Inspector Javed Iqbal (now martyred) was SHO PS CTD, Bannu, who had conducted a raid on the information provided by the Complainant, along with other Police officials near New Bus Stand Bannu. They effected arrest of a PO namely Usman s/o Rooh Niaz r/o Imruz, Mir All, District North Waziristan, who was wanted in a case vide FIR No. 49 dated 30.07.2020 u/s 324-148-149-109 PPC-3/4 EXP-7ATA PS CTD Bannu Region. Rs. 01 million Head Money was fixed for his arrest and he was listed at S. No. 264 vide Notification No. SO/ (Police-1)/ HD/1-3/2022 dated 08.03.2022 of Provincial Government, Khyber Pakhtunkhwa.

2. After his arrest, the accused officer, Asad Ali Shah, moved a case for release of Head Money reward vide his letter No.2527/Reader dated 22.06.2022 in favor of those Police Officers/ Officials who had taken active part in the arrest of above-named PO. The reward money Rs. 01 million was released on the request of the accused officer Asad Ali Shah who received the amount for further disbursement amongst the members of the abovementioned raiding learn. The Complainant alleged that the accused officer Asad Ali Shah misappropriated the above-mentioned Head Money and deprived him (the Complainant) from his due share in that reward.

The subject complaint was marked to SP Admin CTD for preliminary enquiry and report. He conducted the 3. enquiry of allegations of embezzlement and associated 11 officials/ officers including AD Head Money CTD, HQrs as PWs (list attached). He also summoned the accused officer Ased Ali Shah who did not attend the enquiry proceedings. It was reported that the their SHO Inspector Javed Iqbal has been martyred in 2023 and HC Irfan Ullah was reportedly bed-ridden after receiving injuries during an encounter with militants. All the 11 officials mentioned in the list above including Complainant stated in their statements that no one has received his due share from Rs. 01 million reward money fixed for the arrest of above-named PO.

Accused officer Asad Ali Shah appeared on 27.09.2023 before the Enquiry Officer and provided a written 4. statement to him which revealed that he had received Rs. 01 million reward of Head Money in connection with arrest of PO Usman in the year 2022 and he had paid 60% share to the informer, kept Rs. 01 lac as his share from Head Money amount and handed over remaining 30% amount Rs. 03 lacs to Javed Iqbal the then SHO PS CTD Bannu Region (now martyred) for further disbursement among the members of raiding team. He could not produce any proof in support of his claim or receipt of any member of the raiding party while taking plea that all his belongings were burnt in the militants' attack on CTD Compound Bannu. The Enquiry Officer recommended in his report that accused officer Asad Ali Shah may be proceeded against departmentally by issuing him a formal charge sheet and statement of allegations to fulfill all the legal requirements.

In the light of recommendations, the undersigned served him with a charge sheet and statement of allegations for the charges mentioned in the above complaint of ASI Aman Ullah (the Complainant), District Police Bannu and enquiry was entrusted to the then SSP Operations CTD, HQrs, Peshawar. He initiated a formal departmental enquiry into the allegations and again summoned the PWs connected with the issue including the accused officer Asad Ali Shah, who submitted that he may be provided with the copies of some documents which request was accepted and SP Admin was directed to provide him with the relevant documents. SP Admin directed the accused officer Asad Ali Shah to collect the same from his office on 16.02.2024 when accused officer was present in CTD, HQrs, Peshawar but the accused officer Asad Ali Shah disappeared without any information and avoided receiving the requisite documents. Note on diary No. 1692 dated 13.02.2024 office of the Addi: IGP CTD, KP is self-



6. Perusal of the enquiry file revealed that the accused officer used tacties to delay the enquiry proceedings on the pretext of providing him with documents and he tried his best to linger on the enquiry proceedings. He always avoided to attend/ join the enquiry proceedings in the presence of PWs intentionally so that he does not has to face or e \_\_\_\_\_\_s examine them in self-defense to later claim that he was deprived of the opportunity. He was given ample opportunity by both the Enquiry Officers to defend himself by providing any proof or evidence in his defense, but he always failed.

7. During the course of formal departmental enquiry, he was provided with copies of all relevant documents for which he had applied. The enquiry report is self-explanatory in this regard. All the PWs again corroborated their previous statements which they recorded during the course of preliminary enquiry before the enquiry officer.

8. It is worth mentioning here that only ASI Aman Ullah of District Police Bannu made a complaint of not receiving share from Head Money amount but during the course of formal departmental enquiry it was established that the accused officer Asad Ali Shah had deprived all the 12 members of raiding party from their due share including his own gunman and driver who also supported the allegations levelled by ASI Aman Ullah. It has also been established that information regarding presence of PO Usman at New Bus Stand Bannu was provided by him (the Complainant) to the accused officer.

9. Consequent upon receiving enquiry report, accused officer Asad Ali Shah was served with Final Show Cause Notice in response to which he submitted his written explanation in which he also did not defend himself but demanded provision of irrelevant documents. In this connection he also filed a Writ Petition No. 1401-P/2024 before the Honorable Peshawar High Court, Peshawar, which was disposed off accordingly on 28.03.2024. In compliance, he already received the documents for which he had applied. He was heard in OR. His explanation in response to the allegations was not satisfactory and the allegations of non-payment of head money reward share to the members of raiding party have been proved.

10. After completion of all the legal requirements and giving patient hearing to the accused officer acting DSP Asad Ali Shah (BPS-16), now DSP SSU KP, he has failed to prove himself innocent in the enquiry at hand, keeping in view the sufficient evidence available at enquiry file in the form of statements of 11 witnesses who all have corroborated the charges levelled by ASI Aman Ullah in the statements. Thus, the undersigned, being the competent authority, am constrained to award him major punishment of reduction from substantive rank to lower rank under rule 5 (5) of Khyber Pakhtunkhwa Police Rules (1975) and recovery of Rs. 01 million be made from his GP Fund for further disbursement amongst the concerned Police Officers/Officials who had effected the arrest of head money PO Usman.

#### Prayer in Appeal

On acceptance of Instant Departmental Appeal, order dated: 16.05.2024 of the Deputy Inspector General of Police, CTD Khyber Pakhtunkhwa Peshawar may be declared as Illegal, unlawful, without lawful authority, vold ab-initio, coram non judice and of no legal effect, hence be set at naught and Appellant may be exonerated from the charges leveled against him, so as to secure the ends of justice and equity.

#### Respected Sir,

1. That Appellant, being qualified i.e. Bachelor of Arts, was appointed as Assistant Sub Inspector (ASI), in Khyber Pakhtunkhwa Police, on the recommendations of Khyber Pakhtunkhwa Public Service Commission, vide Notification dated: 28.02.2006, was promoted from time to time, lastly promoted to the rank of Deputy Superintendent of Police (DSP-BS17), vide Notification dated: 01.03.2023 and presently posted as DSP, Special Security Unit / SSU Khyber Pakhtunkhwa Police, ensuring the security of Foreign Nationals/ Chinese Engineers, as part of the Remodeling Warsak Canal System Project in District Khyber.

That Appellant was served with charge sheet/statement of allegations Deputy Inspector General of Police CTF & CE CTD Khyber Pakhtunkhwa Peshawar, through letter No.18733-35/PA/CTF dated: 24.10.2023, with the following allegations:

You, while posted on basis of look after charge as SP CTD Bannu Region, claimed and received reward 01 Million Rupees as head money for disbursement amongst the members of raiding team who participated in conducting raid vide DD No.18 dated: 20.06.2022 PS CTD Bannu Region, fotal 13 officials in which an ASI namely Haji Aman Ulah was also included and arrested Proclaimed Offender (P.O) namely Usman S/O Rooh Niaz R/O Irmaz Tehsil Mirail, District North Wazikitan Involved in case vide FIR No.49 dated: 30.07.2020 u/s 324/148/149/109 PPC, 3/4 ESA, 7 ATA PS CTD Bannu Region, but as per preliminary enquiry report you misappropriated line whole amount of 1 Million fixed as head money for the arrest of above named P.O Instead its disbursement upon the participants raiding feam. That, ASI Haji Aman Ulah, submitted application/complaint through Police Jawan App vide No.1952 dated: 29.08.2023 against you, wherein he alleged that you deprived him from his legal right (head money reward share) as you had already well as to the other team members.

Upon complaint of ASI Haji Aman Ullah, a fact finding enquiry was carried out. During the course of enquiry, team members were associated with enquiry proceedings and their statements were recorded which are placed on enquiry file, except former insp: Javed igbal the then SHO PS CTD Bannu, as he got martyred while one HC Infan Ullah, as he got injured during an encounter. All the members of radding team denied in their statements to have received their due share from head money and fixed for the arrest of above named P.O which causes resentment in the force.

You, during preliminary enquiry admitted, that you have received 01 Million Rupees as reward of head money for above named P.O and showed that you distributed 60% to the informer, 10% received as your own share while showed remaining 30% amount to be handed over to former inspector layed labal the then SHO PS CTD Bannu now mariyied but you could not produce any proof in this regard.

You, could not prove yourself innocent & was found guilty of misconduct during the course of preliminary enquiry, hence you are formally charge sheeted for the allegations mentioned above."

- That Appellant, on receipt of charge sheet/statement of allegations 3. dated: 24.10.2023 supra; approached DIG CTD Peshawar through application dated: 26.10.2023 and requested for the following documents to submit proper reply to the charge sheet supra:
  - Preliminary enquiry into the matter conducted by SP Admin CID i. Headquarters Peshawar, İi.
  - Claim of head money submitted by Appeliant to CTD Headquarters Peshawar alongwith relevant documents. íii.
  - Standing Operating Procedure (SOP) dated: 2016, for fixation / release of head money / reward money. iv,
  - Receipts of disbursement of head money amongst the raiding party in other regions of CTD Khyber Pakhtunkhwa.
- That DIG CTD Peshawar directed Appellant, vide letter No.21308/HM/CTD, 4. dated: 12.12.2023, to collect the desired documents from the concerned section of his office accordingly.
- That Appellant tried his best to collect the desired documents in 5. compliance of letter dated: 12.12.2023 supra, however, not relieved from duty by the Commanding Officer due to serious threats to the Foreigners/ Chinese Engineers, resultantly he requested through application dated: 14.12.2023 to provide the desired documents through proper channel,
- That DIG CTD Peshawar directed Appellant, vide letter No.874/HM/CTD, 6. dated: 11.01.2024, to personally or through his messenger or his relative collect the desired documents from the concerned section on any working day accordingly.

That Appellant, in compliance of directions dated: 11.01.2024 supra went from post to pillar and exhausted all possible measures to collect the desired documents from the concerned quarters but failed. SSP CTD Peshawar issued letter No.394/EC/CTD/Peshawar-I, dated: 25.01.2024, vide which Appellant was directed to personally or through his messenger collect the desired documents from his office at the earliest and submit reply to charge sheet supra to proceed further into the matter.

That Appellant, in compliance of letter dated: 25.01.2024 supra, visited office of the SSP CTD Peshawar/ Enquiry Officer and was handed over the following documents:

Photocopies of complete head money case (21 pages) î. Photocopies of SOP 2016 regarding head money (6 pages) ii.

However, rest of the documents i.e.

- i. Committee report
- Recommendations of the committee ii.
- ΪĬ. Contingent bill

- iv. Vouchers of head money
- v. Preliminary enquiry with complete documents and
- vi. Other regions (CTD) receipts of head money documents having receiving signatures by all relevant officers / officials.

Were not provided, resultantly appellant preferred application dated: 29.01.2024, Through Proper Channel, and requested for the aforementioned lift over documents.

- That the Inquiry Officer/SSP CTD Peshawar, instead to provide the requisite documents, issued letter No.552-53/SSP Ops, dated: 02.02.2024, vide which Appellant was directed to submit reply to the charge sheet supra by 06th day of February, 2024 positively.
- 10. That Appellant approached DIG CTD Peshawar through application dated: 06.02.2024 for providing attested copies of the desired documents mentioned in preceding Para No.8.
- 11. That inquiry Officer/SSP CTD Peshawar warned Appellant, vide letter No.726-30/SSP Ops dated: 12.02.2024 and alleged that he is playing a shady role and resorting to delay factics to avoid the procedure, therefore, directed him to be careful in future and submit reply to the charge sheet supra within three days positively, irrespective of the fact that Appellant was neither provided the requisite documents nor his repeated applications were considered.
- 12. That Appellant approached Additional Inspector General of Police Khyber Pakhtunkhwa Peshawar through application dated: 12.02.2024 by invoking his jurisdiction under the Right to Information Act, 2013 and simultaneously submitted reply dated: 13.02.2024 to the warning letter dated: 12.02.2024 supra. It is worth to mention that Additional Inspector General of Police Peshawar, while considering application dated: 12.02.2024 lbid, directed Appellant, vide letter No.3033/EC/CTD/HQrs dated: 13.02.2024, to appear in Orderly Room / OR on 14.02.2024, resultantly Appellant appeared before Additional Inspector General of Police and the date time fixed, however, refused to provide the desired documents.
- 13. That Appellant left with no other option but to approach Khyber Pakhtunkhwa RTI Commission, through complaint, received vide Diary No.12153, dated: 22.02.2024 for appropriate directions to the Inquiry Officer/ SSP CTD Peshawar to provide the following documents related to the case of Appellant:
  - i. Committee Report
  - ii. Recommendations of committee
  - iii. Contingent bill
  - iv. Voucher of head money
  - v. Audit report for the year 2022
  - vi. Preliminary enquiry report conducted by Respondent No.5 alongwith relevant documents
  - vii. Head money receiving / receipts of other ranges of CTD Khyber Pakhtunkhwa.

- 14. That Inquiry Officer/SSP CTD Peshawar directed Appellant, vide Notice No.824-27/SSP Ops, dated: 22.02.2024, to appear before him on 26.02.2024 at 10:00 a.m., resultantly, Appellant attended the office of Inquiry Officer/SSP CTD Peshawar, on the time & date fixed, however, the Inquiry Officer Instead to provide the requisite documents, directed Appellant to submit written defense to the charge sheet supra, eventually, Appellant submitted yet another application dated: 26.02.2024 and requested to first provide the requisite documents and thereafter reply to the charge sheet would be submitted.
- 15. That Appellant, keeping in view peculiar facts and circumstances of the case coupled with strange attitude displayed by Inquiry Officer by way of compelling him to submit reply to the charge sheet supra without providing the essential documents, approached your esteemed office, through application dated: 26.02.2024, for transfer pending departmental enquiry outside CTD to an impartial / unblased inquiry officer/ department, however, regretted vide letter No.387-88/CPO/IAB dated: 07.03.2024, with the following remarks:

"As enquiry is already been conducted at CTD and the DSP Asod All Shah has still not joined that and rather employing delaying factics. He may as will be directed to join the enquiry proceedings vide SSP Operations CTD letter No.824-27/SSP Ops dated: 22.02.2024, so the matter may be finalized, please."

16. That Appellant, being aggreved of the aforementioned inactions of the Inquiry Officer/SSP CTD Peshawar, by way of not providing documents pertaining to the alleged charges, requested by Appellant through numerous applications dated: 26.10.2023, 14.12.2023, 29.01.2024, 06.02.2024, 26.02.2024, DIG CTD Peshawar, by way of not providing the requisite documents requested through application dated: 12.02.2024, KP RTI Commission by way of not considering complaint dated: 22.02.2024, for issuing appropriate directions to Inquiry Officer to furnish the requisite documents & your esteemed office by regretting application dated: 26.02.2024, vide order/letter dated: 07.03.2024, for transfer of departmental inquiry in CTD to an impartial Inquiry Officer outside CTD and, had no other efficacious and alternate remedy, approached the Hon'ble Peshawar High Court, Peshawar through Writ Petition No.1401-P/ 2024, with the following prayer:

The petition is disposed of in the above terms."

- That Appellant approached the Inquiry Officer through application dated: 02.04.2024 and requested for providing the desired documents, in compliance of Judgment dated: 28.03.2024 supra of the Hon'ble Peshawar High Court, Peshawar, however, to no avail so far. (Copy of application dated: 02.04.2024 is attached as Annexure-B)
- That DIG CTD Peshawar, issued final Show Cause Notice No.8769/PA/ CTF&EU CTD HQrs dated: 06.05.2024, operative part whereof is reproduced as under;

"The Enquiry Officer initiated departmental inquiry in the mater who carried out an impartial enquiry, without any favour, collected all evidences and recorded the statement of witnesses in the matter. After going through all the available record, you badly failed to defend yourself and to produce any evidence in your support. The inquiry Officer thus found you guilty of the allegations levelled in the charge sheet and recommended you for awarding "Major Punishment.

The finding report of the inquiry officer are much clear and sufficient enough to award you any punishment mentioned in Police Rules-1975 of Khyber Pakhtunkhwa Police (Amended in 2014) but the undersigned, however, give you another last opportunity of personal hearing and production of evidence in your defense proving yourself innocent in the allegations levelled against you.

By reason of the above, you appear to be guilty of misconduct under the Police Rules 1975 of the Khyber Pakhlunkhwa (amended in 2015) and thus calls upon you this final Show Cause Notice. You are therefore directed to submit your written reply before the Competent Authority in your defense within seven days of the receipt of this final Show Cause Notice failing which it shall be presumed that you have no defense to put in and in that case ex-parte action shall be taken against you."

19. That, admittedly, Appellant was not in position of the requisite/essential document, therefore, preferred yet another application dated: 08.05.2024, with the following prayer:

"It is, therefore, most respectfully requested that on acceptance of Instant application, the desired essential documents mentioned in preceding para-2 and findings of final inquiry report alongwith anciliary documents / evidence, may be provided in compliance of Judgment dated: 28.03.2024 supra of the Hon'ble Peshawar High Court, Peshawar, so as to enable me / appellant to submit proper reply to the subject mentioned final Show Cause Notice and to avoid untoward situation and further complications."

(Copy of application dated: 08.05.2024, diary number/receipt alongwith covering letter is attached as Annexure – D)

20. That DIG CTD Khyber Pakhtunkhwa Peshawar, instead to provide the regulsite/essential documents, proceeded Appellant exparte and awarded major punishment of reduction from substantive rank to lower rank, vide impugned order dated: 16.05.2024, operative whereof is reproduced as under:

"Consequent upon receiving anguly report, accused Officer Asad Ail Shah was served with final Show Cause Notice in response to which he submitted his written explanation in which he also did not defend himself but demanded provision of irrelevant documents. In this connection he also filed a Writ Potition No.1401-P/2024 before the Hon'ble Peshawar High Court, Peshawar, which was disposed off accordingly on 28.03.2024. In compliance, he already raceived the documents for which he had applied. He was heard in OR. His explanation in response to the allegations was not satisfactory and the allogations of non-payment of head money reward share to the members of raiding party have been proved.

After completion of all the tegal requirements and giving patient caring to the accused officer acting DSP Asad All Shah (BPS-16), now DSP SSU KP, he has failed to prove himself innocent in the inquiry at hand, keeping in view the sufficient evidence is available at the inquiry file in the form of statements of eleven witnesses who all have corroborated the charges leveled by ASI Aman Ullah in the statements. Thus the undersigned being the Competent Authority constrained to award him major punishment of reduction from substantive rank to lower rank under Rule 5(5) of the Khyber Pakhfunkhwa Police Rules, 1975 and recovery of Rs. 01 Million be made from his GP Fund and further disbursement amongst the Police Officers/Officials who had effected the arrest of head money PO Usman."

Hence the instant appeal. (Copy of Impugned order dated: 16.05.2024 is attached as Annexure – E)

- 21. That impugned order dated: 16.05.2024 is against the law, facts and material available on file, hence untenable.
- 22. That regular inquiry into the guilt of Appellant has not been conducted, rather Appellant and major punishment of reduction from substantive rank to lower rank alongwith recovery of Rupees 1 million has been imposed upon him, which has caused grave miscarriage of justice.

That the entire departmental proceedings have unilaterally been carried out, neither statements of the so-called eleven witnesses were recorded in presence of Appellant nor he was allowed to cross examine them nor he was confronted with the so-called witnesses/documentary evidence, hence has been condemned unheard, which attracts the doctrine of audi alteram partem.

- 24. That Appellant has neither been treated in accordance with law nor has been provided equal protection of law, enshrined in Articles 4 & 10-A of the Constitution of Islamic Republic of Pakistan, 1973.
- 25. That, admittedly, Appellant is performing dutles as DSP in 8PS-17 and in Schedule-1 of the Police Rules, 1975 (with amendments in 2014), the Competent Authority to award major punishment i.e. reduction from substantive rank to lower rank, to Appellant, as your esteemed office/ the worthy PPO Khyber Pakhtunkhwa, but astonishingly the impugned order has been issued by DIG (Imran Shahid 8PS-19) CTD Peshawar, thus acted without jurisdiction which makes the impugned order coram non judice, hence nullity in the eye of law.

- 26. That Appellant served the KP Police Department for more than 18 years and never been involved in any type of non-professional activities rather he enjoying excellent reputation in the department, however, he has been subject to unprecedented abuse of authority, for ulterior motives and matafide intentions, hence indulgence of your esteemed office is solicited for smooth administration of justice.
- That any other grounds/documentary evidence, with the permission of your esteemed office, will be taken/produced at the time of personal hearing, if granted.

It is therefore, most humbly prayed, that on acceptance of instant Departmental Appeal, order dated: 16.05.2024 of the Deputy Inspector General of Police. CTD Khyber Pakhtunkhwa Peshawar may be declared as illegal, unlawful, without lawful authority, vold ab-initio, coram non judice and of no legal effect, hence be set at naught and Appellant may be exonerated from the charges leveled against him, so as to secure the ends of justice and equity.
