On acceptance of the instant service appeal, the impugned notification bearing No.SOH(E-V)/2-2/2024 dated 27.05.2024 issued by the respondents whereby the appellant was transferred from the post of Medical Superintendent King Abdullah Teaching Hospital, Tehsil Headquarter Mansehra to Hospital Takht bai Mardan may please be set aside and the appellant may graciously be restored to its position Medical previous i.e. Superintendent, King Abdullah Teaching Hospital, Mansehra or any other order or relief as this Honourable Tribunal deems fit and appropriate in the circumstances of the case, may also be issued/passed.

 That, the appellant is a bonafide resident of Fareed Bagh Mandian Kotkay, Tehsil and District Mansehra.

(Copy of the CNIC of the appellant is annexed as annexure "A").

That, the appellant is a qualified
 Doctor and is performing his duties

in the Management Cadre of the respondents' department.

(Copies of the educational testimonials of the appellant along with service record are annexed as annexure "B" & "C").

3. That, the appellant was initially inducted in the Health Department, Government of Khyber Pakhtunkhwa who was later on transferred and lastly posted as Medical Superintendent, King Abdullah Teaching Hospital, Mansehra vide notification bearing No.SOH(HD)/E-V/4-4/2020; dated 18.03.2020.

(Copy of the notification is annexed as annexure "D").

8. That, the appellant was working against the impugned post with great zeal and zest but the respondents illegally and unlawfully transferred the appellant by way of notification dated 09.07.2021.

(Copy of the impugned notification is annexed as annexure "E").

7. That, the appellant being aggrieved from the impugned notification,

submitted departmental appeals before the respondents but the same were not been adhered to by the respondents.

(Copies of the departmental appeals are annexed as annexure "F").

That, the appellant being aggrieved 8. from the impugned notification duly filed a service appeal before the Honourable Service Tribunal, KPK Peshawar which was accepted vide 09.11.2021 dated and order the directions were issued to respondents to do further needful to bring the position in place as per accepted prayer of the appellant.

(Copies of the service appeal alongwith order are annexure as annexure "G").

9. That, the order of the Honourable Service Tribunal was not complied with by the respondents, therefore, the appellant being aggrieved from the actions/in-actions of the respondents filed an application for implementation of the order before the Honourable Service Tribunal, KPK Peshawar and the Honourable

Service Tribunal ordered for posting the appellant against the impugned post.

(Copies of the application for implementation alongwith order are annexed as annexure "H&I").

10. That, after hectic efforts by the appellant as well as upon the strict directions of the Honourable Service Tribunal, KPK Peshawar, the appellant was ordered to be posted on the post of Medical Superintendent, King Abdullah Teaching Hospital, Mansehra on 18.05.2022.

(Copy of the order dated 18.05.2022 is annexed as annexure "J").

That, after obtaining charge of the 11. post of Medical Superintendent, King Abdullah Teaching Hospital, Mansehra disposal" of the and after implementation application of the appellant, the respondents unlawfully impugned issued illegally and notification dated 30.05.2022 whereby the appellant was again transferred Medical of post the from Abdullah Superintendent, King Teaching Hospital, Mansehra

Directorate General, Fealth Service Khyber Pakhtunkhwa, Peshawar.

(Copy of the impugned order dated: 30/05/2022 is annexed as annexure "K").

That, the appellant being aggrieved from the impugned order dated: 30.05.2022 submitted s departmental appeal before the respondents which was not attended to by the respondents against which the appellant filed Writ Petition before this Hon'ble Peshawar High Court as well as Service Appeal before the Ho1'ble Service Tribunal, Khyber Pakhtunkhwa Peshawar, which was allowed by the Hon'ble Service Tribunal, Peshawar.

(Copies of the Writ Petition and Departmental Appeal are attached as annexures "L & L/1").

13. That, the respondents later on refused to restore the services of the appellant in the light of the order of Khyber Pakhtunkhwa Service Tribunal, Peshawar hence the appellant submitted application for contempt of court before the Hon'ble

Service Tribunal, Peshawar which was listed before the Honourable Tribunal on 04.05.2023 and the respondents handed over the notification bearing No.SOH(E-V/4-4 / 2023 dated 02.05.2023 and thus the appellant's services have been restored as Medical Superintendent King Abdullah Teaching Hospital, Mansehra.

(Copies of the petition for contempt of court alongwith order are annexed as annexure "M").

started appellant the 14. That, perform his duties in the light of the order dated 04.05.2023 and never remained negligent in performance of his duties but after lapse of only one year, the respondents issued the impugned notification bearing No. SOH(E-V)/2-2/2024 dated 27.05.2024 the appellant transferred from the post of Medical Superintendent Abdullah King Teaching Hospital, Mansehra to Tehsil Headquarter Hospital Takht bai Mardan.

(Copy of the notification dated 27.05.2024 is annexed as annexure "N").

That, the appellant time and again 15. visited the offices of the respondents for the cancellation of the impugned notification but in vain hence the appellant being aggrieved from the seeks the notification impugned of this gracious indulgence Honourable Tribunal by way of instant service appeal, inter alia on the following grounds: -

GROUNDS

No.SOH(E-V)/2-2/2024 dated 27.05.2024 issued by the respondents whereby the appellant was transferred from the post of Medical Superintendent King Abdullah Teaching Hospital, Mansehra to Tehsil Headquarter Hospital Takht bai Mardan is wrong, illegal, against the law and facts, arbitrary, fanciful, perverse hence being unconstitutional liable to be set aside.

- ii. That, admittedly, the appellant was given the charge of the impugned post in the light of the order of Honourable Service Tribunal, Peshawar dated 04.05.2023 by way of order dated 02.05.2023 and since then the appellant is serving against the impugned post with great zeal and zest and there is not even a single departmental or public complaint against the appellant hence no legal justification rests with the respondents to transfer the appellant from the impugned post.
- iii. That, the appellant has obtained the initial charge of the impugned post by way of notification SOH(HD)/E-V/4-4/2020 dated 18.03.2020 and since the passage of said order, the respondents have transferred the appellant 3/4 times and all the times, the said transfer notifications back this reverted by were Honourable Tribunal which speaks volume of malafide on the part of the respondents.
- iv. That, the appellant has been politically victimized by the respondents and the respondents

while making themselves as pawn in the hands of the local political figure of the locality have issued the impugned notification just to facilitate their blue eyed chap.

- v. That, it is well settled by now that the political figures have nothing to do with the transfer or posting rather the same is the pure domain of the relevant department but in the matter in hand, all the proceedings have been carried out at the behest of the political figure of the area which is not warranted under the law.
- vi. That, the impugned notification is against the norms of fair play, good conscious, equity as well as against the fundamental rights of the appellant hence the same is liable to be brushed aside.
- respondents to disturb the services of any employee but the respondents while considering them above the law have issued the impugned notification mere on the basis of political influence of the respondent

and the second

No.6 and that too without completion of the tenure of the appellant hence the impugned notification being, hit by the relevant law, rules and policy on the subject have no legal sanctity in the eyes of law.

- and law, rules relevant viii. That, regulations have blatantly bypassed/ violated by the respondents and the relevant law, rules and regulations been taken into have never consideration by the respondents and thus the notification so passed by the respondents have no legal sanctity in the eyes of law.
- ix. That, no solid, valid, concrete or confidence inspiring reasons/ justification has been given by the competent authority while transferring the appellant from King Abdullah Teaching Hospital, Mansehra.
- flouted and violated the provisions of spouse policy on the subject whereas spouse policy is also in favour of the appellant as his wife is serving in District Mansehra and the spouse policy duly supports the version of

the appellant that husband and wife must be adjusted in the same District.

(Copy of the order of the wife of the appellant is annexed as annexure "O").

- regulations have completely been bypassed by the competent authority while carrying out the impugned proceedings regarding transfer of the appellant.
- xii. That, the competent authority failed to exercise its powers in accordance with the relevant law, rules and regulations rather travelled beyond the powers so vested in it under the law.
- xiii. That, the appellant has unblemished service career as the appellant so performing his duties with great zeal and zest and never remained negligent in performance of his assigned duties. Similarly, neither any departmental nor any public complaint is available against the appellant.

- xiv. That, it is an inalienable right of the appellant to enjoy the protection of law and to be treated in accordance with law, rules and regulations but such right of the appellant has been infringed in a sheer malafide manner.
- xv. That, the impugned transfer order has neither been in the best interest of public service nor in exigencies of service, hence, not tenable and liable to be set aside.
- xvi. That, the impugned transfer order is nothing but to harass the appellant and to accommodate their blue eyed person.
- xvii. That, the impugned transfer order is violative of clause-I, IV and XIII of the transfer/ posting policy of the Government of Khyber Pakhtunkhwa as the appellant has been transferred prematurely from his current post.
- xviii. That, the powers or jurisdiction are vested in authority to exercise it justly, fairly, honestly, judiciously and in accordance with law, rules and regulations but the respondents

have transgressed upon their powers while dealing with the matter in hand.

It is, therefore, most humbly

<u>JUDGMENT</u>

Rozina Rehman, Member(J); Brief facts of the case are that appellant is a qualified Doctor and is performing duties in the Management Cadre of the respondents' Department. He was posted as Medical Superintendent, King Abdullah Teaching Hospital Magsehra. He was performing his duties, when in the meanwhile he was transferred vide Notification dated 09.07.2021. Being aggrieved from the impugned notification, he submitted departmental appeal but to no avail, hence, the present service appeal.

We have heard Junaid Anwar Advoçate learned counsel for appellant and Muhammad Rasheed learned Deputy District Attorney

for the respondents and have gone through the record and the proceedings of the case in minute particulars.

Junaid Anwar Advocate, learned counset for appellant submitted that impugned Notification dated 09.07.2021 whereby the appellant was transferred from the post of Medical Superintendent King Abdullah Teaching Hospital Mansehra to the post of Deputy District Health Officer is wrong, illegal, arbitrary and against the relevant law and rules being politically motivated and against the fundamental rights of the appellant. He submitted that relevant law and rules were blatantly bypassed by the respondents and relevant rules and regulations were not taken into consideration by the respondents. He contended that no solid and confidence inspiring reasons were given by the competent authority while transferring the appellant. He submitted that the appellant has been politically victimized by the competent authority as all the proceedings were carried out at the back of the appellant mere on behest of the political figures of the area and that the appellant was not afforded any opportunity of personal hearing, hence, all the proceedings are against the settled principles of natural justice. Lastly, he submitted that the transfer order of the appellant was communicated to the Minister for Health Department which has shaken the veracity of the impugned order and speaks loudly that the transfer was made on the basis of political motivation. He, therefore, requested that the impugned notification may kindly be set aside and the appellant may be restored to his previous position.

4. Conversely, learned D.D.A submitted that according to Section19 of the Khyber Pakhtunkhwa Civil Servants Act, 1973, a civil servant
has to serve anywhere and he is not entitled to be posted in

accordance with his whims & wishes. He contended that the appellant failed to manage even a single bed for COVID-19 affected. No centralized Oxygen was available despite ample funds available in H.M.B and he was directed time and again by the higher authority to award the work for Oxygen gas piping on top priority basis. That the officer never participated in daily online meetings which shows inefficiency and lack of interest towards his responsibilities. He submitted that due to poor performance of the appellant, during Health Emergency due to COVID-19, he was not allowed by the competent authority to serve against the key position in the hospital at the cost of public health and it is the power of the competent authority to transfer a civil servent even before completion of his normal tenure under the Khyber Pakhtunkhwa Civil Servants Act, 1973.

and posted as Medical Superintendent, King Abdullah Teaching Hospital Mansehra vide Notification dated 18th March, 2020. It was on 9th July, 2021 when he was transferred from King Abdullah Teaching Hospital Mansehra to the post of Deputy District Health Officer. Mansehra Principles of posting and transfer are based upon the criteria that it is within the domain of Government to utilize services of a civil servant anywhere it deemed fit in public interest. Even according to Civil Servants Act, 1973, right of posting vests in the exclusive jurisdiction of the competent authority and the said posting cannot be challenged unless it is against the law and rules or malafide. Section-10 of the Act also stipulates that every civil servant shall be liable to serve anywhere within or outside the province in any post under the Federal Government or in Provincial Government or local authority or a corporation or bodies setup or established by any

such Government. In the instant case, the appellant was transferred vide Notification dated 9th July, 2021 but no convincing reasons have been given by the authority in the impugned notification. According to transfer posting policy, normal tenure for posting is two years but the appellant was transferred before completion of normal tenure which is total violation of the Government Transfer/Posting Policy, Moreover, having the clue from the events brought into our notice through an interlocutory applications by the appellant complaining about the mistrealment of him to oust him from the office for accommodation of co-transferee in his place despite suspension of the impugned order, we cannot be oblivious of the hot pursuit of the respondents ridden with some hidden agerida. When the respondents after suspension of the impugned order did not wait for disposal of the appeal, in their pursuit against the appellant, their bias in dealing with him has pecome evident, which in particular circumstances of the case is not indicative of any public interest in transfer of the appellant.

6. For what has been discussed above, this appeal is allowed as prayed for with direction to the respondents No.1 & 2 to do further in needful to bring the position in place as per accepted prayer of the appellant. There is no order as to costs. File be consigned to the record foom.

dated 02.05.2023 and since then the appellant is serving against the impugned post with great zeal and zest and there is not even a single department all or public complaint against the appellant hence no legal justification rests with the department to transfer the appellant from the impugned post.

- That, the appellant has obtained the iii. initial charge of the impugned post by way of notification SOH(HD)/E-V/4-4/2020 dated 18.03.2020 and since the passage of said order, the department have transferred appellant 3/4 times and all the times, the said transfer notifications by / the back reverted were Honourable Service Tribunal which speaks volume of malafide on the part of the respondents.
- iv. That, the appellant has been politically victimized by the department and the department while making themselves as pawn in the hands of the local political figure of the locality have issued the

impugned notification just to facilitate their blue eyed chap.

- v. That, it is well settled by now that the political figures have nothing to do with the transfer or posting rather the same is the pure domain of the relevant department but in the matter in hand, all the proceedings have been carried out at the behest of the political figure of the area which is not warranted under the law.
- vi. That, the impugned notification is against the norms of fair play, good conscious, equity as well as against the fundamental rights of the appellant hence the same is liable to be brushed aside.
- vii. That, the law does not permit the department to disturb the services of any employee but the department while considering them above the law have issued the impugned notification mere on the basis of political influence of the respondent No.6 and that too without completion of the tenure of the appellant hence

the impugned notification being hit by the relevant law, rules and policy on the subject have no legal sanctity in the eyes of law.

- viii. That, relevant law, rules and regulations have blatantly bypassed/violated by the department and the relevant law, rules and regulations have never been taken into consideration by the department and thus the notification so passed by the department have no legal sanctity in the eyes of law.
- ix. That, no solid, valid, concrete or confidence inspiring reasons/ justification has been given by the competent authority while transferring the appellant from King Abdullah Teaching Hospital, Mansehra. Similarly, spouse policy is also in favour of the petitioner as his wife is serving in District Mansehra.
- x. That, relevant law, rules, and regulations have completely been bypassed by the competent authority while carrying out the impugned proceedings regarding transfer of the appellant.

- xi. That, the competent authority failed to exercise its powers in accordance with the relevant law, rules and regulations rather travelled beyond the powers so vested in it under the law.
- xii. That, the appellant has unblemished service career as the appellant is performing his duties with great zeal and zest and never remained negligent in performance of his assigned duties. Similarly, neither any department al nor any public complaint is available against the appellant.
 - xiv. That, the impugned transfer order has neither been in the best interest of public service nor in exigencies of service, hence, not tenable and liable to be set aside.
 - xv. That, the impugned transfer order is nothing but to harass the appellant and to accommodate their blue eyed person.
 - xvi. That, the impugned transfer order is violative of clause I, IV and XIII of

the transfer/ posting policy of the Government of Khyber Pakhtunkhwa as the appellant has been transferred prematurely from his current post.
