CONSOLIDATED JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: Through this single judgment, both the above appeals, are jointly taken up as both are similar in nature and almost with the same contentions, therefore, can be conveniently decided together.

2. The appellants' cases in brief are that they were serving in the Education Department (Nasir Iqbal as Junior Clerk and Nasir Khan as Sweeper) in Government Girls High Scool Qasab Khana, Peshawar; that appellants were charge sheeted on the allegations of involvement of immoral activities, complained by the students; that inquiry was conducted and resultantly, vide impugned orders dated 24.03.2022 they were removed from service.

3. They filed departmental appeals, but the same were regretted. Therefore, they filed the instant service appeals.

4. On receipt of the appeals and their admission to full hearing, the respondents were summoned, who put appearance and contested the appeals by filing written replies raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellants.

5. We have heard learned counsel for the appellants and learned Deputy District Attorney for the respondents.

6. The learned counsel for the appellants reiterated the facts and grounds detailed in the memo and grounds of the appeals while the learned District Attorney controverted the same by supporting the impugned order(s).

In the absence of any material against the appellants, imposition of major penalty upon them is not justified.

Keeping in view the above situation, instant service appeals are accepted. Impugned orders are set aside and the appellants are reinstated into service with all back benefits. Costs shall follow the event. Copy of this judgment be placed in the file of the connected service appeal. Consign.

Respectfully Sheweth,

1. That the Appellant is a bona-fide citizen of Islamic Republic of Pakistan and hails from a respectable family.

2. That after going through the mandatorily required criteria, the Appellant got onto the rolls of the Respondent Department years back.

- 3. That since induction into service and after getting onto the rolls of this extremely humane and prestigious Department, the Appellant has remained the most pragmatic, devoted and dutiful fellow, who never left any stone unturned in performance of his duties and importing any responsibility that has been entrusted to the Appellant.
- 4. That it was in the backdrop of November 2021 that a complaint/FIR was registered by Mst. Kalsoom Bibi w/o Ijaz Hussain bearing FIR No. 1604 dated 12-11-2021 U/S 377-B PPC and 53 CPA at Police Station Agha Meer Jani Shah Peshawar against one Mr. Mian Arshad s/o Mian Khadim Shah for involvement in sexual abuse / immoral activities at Government Girls High School Qassab Khana, Peshawar. (Copy of FIR is annexed herewith as annexure "A")
- 5. That thereafter the District Education Officer (female) Mr. Abdul Saeed Principal of Govt. Shaheed Syed Afaq Ahmed High School No. 3, Peshawar Cantt and Mst. Bibi Tasleem Principal of Govt. Girls High School, Quid abad, Peshawar were appointed as inquiry officers with strict instructions to conduct inquiry regarding the above-mentioned FIR. Incident, which was accordingly carried out.

- 6. That in consequence to the inquiry conducted by the inquiry officers the service of the Appellant was suspended from the rolls of Respondent Department vide Office Order No. 362-67Dated 01-01-2022 on the alleged ground of his involvement in immoral activities at Government Girls High School Qassab Khana which is against the facts and circumstances as the name of the Appellant was not mentioned anywhere in the said FIR.(Copy of suspension order is annexed herewith as annexure "B").
- 7. That there after the charge sheet and statement of allegation dated 01-010-2022 was issued to the Appellant without any reason along with immoral activities which is why he was charged in the FIR No. 1604 dated 12-11-2021 U/S 377-B PPC and 53 CPA at Police Station Agha Meer Jani Shah Peshawar. (Copies of charge sheet and statement of allegation are annexed herewith as annexure "C" & "D").
- 8. That the appellant move serval application to the response of charge sheet to the officers of inquiry Commission, conducted by the Office of Discrict Education Officer (Female) Peshawar but no response from the inquiry officers and futile.(Copy of response to the charge sheet application is annexed as annexure "E")

That eventually the Appellant was removed from the rolls of the respondent department vide impugned Office Notification No. 4454-60/Special File/GGHS Qassab Khana dated 24-03-2022 without conducting proper inquiry against'the Appellant, on a plea that complaints have been received against the Appellant from most of the school girls at Government Girls High School Qassab Khana, Peshawar which were fake, wrong and fabricated. (Copy of impugned Office Notification dated 24-03-2022 is annexed herewith as annexure "F")

- 10. That soon after receiving the charge sheet and statement of allegation, the Appellant preferred a Departmental Appeal Dated 28-03-2022 for his reinstatement into service but there was no light to the end of the tunnel and the Departmental Appeal of the Appellant was turned down vide Office Order No. 6307/ F.No./A-21/C/IV/ Nasir Khan Sweeper Dated06-04-2022.(Copies of Departmental Appeal and impugned Office Order Dated 06-04-2022 are annexed herewith as annexure "G" & "H")
- 11. That no proper show cause or final show cause notice was ever issued to the Appellant, nor he was personally heard or given the opportunity to explain himself.
- 12. That feeling aggrieved from the supra-mentioned episode, the grievances, that come into existence,



having no other adequate remedy available elsewhere, and forum to be addressed at, the Appellant approaches this Hon'ble Tribunal for his re-instatement into service, upon the following grounds, inter-alia;

<u>Grounds:</u>

- A. That the impugned removal Notification is wrong, illegal, unlawful, void-ab-initio and is not sustainable at all.
- B. That all the impugned notification is unwarranted, illogical and against the Rules so therefore not tenable in the eyes of law.
- C. That no proper inquiry was ever conducted in case of the Appellant, nor the Appellant was ever heard in person, thus the appellant was condemned unheard which is illegal, unlawful, which is not justified in any canon of law.
- D. That the name of the Appellant was not mentioned in the above-mentioned FIR nor he was ever involved in immoral activities.
- E. That, there is no proof / written record of the complaints made by the school girls against the Appellant and plea taken by the Respondent

department is completely fake, fabricated and based on assumptions.

- F. That even the departmental appeal of the appellant was turned down on, regardless of looking into the facts and was source from the service.
- G. That the appellant has served the respondent department for a couple of years and that too unblemished, without any complaint ever against, on part of the Appellant.
- H. That from every angle the Appellant is liable to be re-instated into service with all back benefits.
- I. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.



5. That in reply to para No. 5, 6, 7 &8. Their recommendation are as following.

As per first inquiry report recommendation that "According to the first inquiry recommendation "Mr. Nasir sweeper GGHS Qasab Khan's Peshawar may be removed from service as per written complaints from most is the girls student about his characterless attitude "According to second inquiry recommendation that "Mr. Nasir is not fit for government service because of his characterless

nature. He may be removed from service for having bed-eyes on the girl's students in the school".

On the basis of aforesaid inquiries proper charge sheet_and statement of allegation was issued to Mr. Nasir sweeper but reply of charge sheet was found unsatisfactory therefore according to E&D rules 2011 major penalty was imposed on Mr. Nasir and he was removed from service.

Enquiry Report about Mr. Mian Arshad Khan Naib Qasid, Govt; girls High School Qasab Khana Peshawar.

Objectives of the Enquiry:

The competent authority appointed Mst Farzana Lal Sher Principal GGHSS Chamkani and Mr. Ihtiram Khan Principlal GHSS Urmar Bala Peshawar to conduct a formal inquiry about Mr. Mian Arshad Khan Naib Qasid, Govt; girls High School Qasab Khana Peshawar regarding complaint/FIR lodged against him in Police Station Yakatoot by one of the parents for raping/sexually harassing her daughter, a student of class 7th GGHS Qasab Khana Peshawar and to submit a report to the competent authority with recommendations.

Problem Review:

As per information from a fact finding enquiry into the matter by Abdul Saeed Principal Government Shaheed Afaq Ahmad high School Cantt Peshawar (Cantt No 3) a student named Hira Batool, the student of class 7th B GGHS Qasab Khana Peshawar whose attendance register record shows her last class attendance on Nov 6th, 2021 and her mother Mst Kalsoom who is also a member of the school Parents Teachers Council, on Nov 10th 2021 called on Mst Ambreen, the school headmistress, and told her that her daughter Hira Batool is not feeling well and that they (her parents) are quiet anxious about her and that they are treating her by a doctor. On Nov 12th 2021 she lodged an FIR in the local Police Station Yakatoot that Mr. Mian Arshad Khan Naib Qasid (who was appointed as Naib Qasid on Feb 22nd 2012 under Office Order No:4106 date 21-2-2012 (Annexure A)) raped her daughter on Nov 6th 2021 in the school canteen (illegally run by Mian Arshad for eight years in a portion of a class room separated by a kachaa wall from the rest which was used as clerk office by the junior clerk Mr. Nasir Iqbal) after school timing. (Annexure B)

Nov 13th 2021 the local police came to the school with the victim and her parents and arrested the accused Mr. Mian Arshad Khan N/Q of the concerned school. The mother of the victim started beating Raheela, the head girl of class 9th A, shouting that she took her daughter Hira Batool in the room (canteen) of Mian Arshad Khan where the incident took place. The accused was produced before the court of law, who was later on sent to Jail and the case is under trial in the court of law.

Information received from the fact finding enquiry into the matter by Abdul Saced Sb Principal GHSS No 3 Cantt Peshawar, Interview, Questionnaire, Openionnair, FIR, Observation of the school canteen, class 7th B, Headmistress Office and the junior clerk office. : Government Girls High School Qasab Khana Peshawar.

Method and Procedures:

As the enquiry committee discussed the matter with the DEO (F) Peshawar in detail, getting the full information, added by the enquiry report of Mr. Abdul Saeed Principal Cantt 3. The committee then moved to the school concerned. Mst Farzana Lal Sher principal GGHS Chamkani visited the home of Hira Batool as it was considered by the committee not to call her to the school in this scenario. Hira Batool and her mother were interviewed in detail. And written statement was also taken from Hira Batool (G1). After that the mother of Hira Batool accompanied Mst \sim Farana Ial Sher to the school to see the other member (Ihtiram Khan • principal GHSS Urmar Bala) of the enquiry committee and to discuss the situation with him. Both the Ladies were accompanied by Mst Saima Yousaf CT. All the three ladies in the presence of the school incharge Mst Nargas Parveen SST G gave detailed information to the enquiry committee. Each and every aspect of the case was discussed in detail? After that the Junior Clerk Mr Nasir lqbal and Mr.Nasir sweeper were called to the office of HM and were interviewed in details and written statements were also taken from them(H1, H2). Both these fellows were not cooperating. They did not furnish any information. Their behavior and attitude was suspicious as if they were hiding something. But their

statements were matching. It was clear that they had made up their minds not to disclose anything relying just on saying that they knew nothing. The committee in presence of the in charge then visited class 7th B and the place where canteen existed and the clerk s office.

In her statement Hira Batool complained of Raheela, the head girl of class 9th who had taken Hira Batool to the canteen and acted as supplier in this case. This provides a proof that this Mian Arshad had prepared a network for his heinous acts. But this Raheela, we were told, does not respond to any question in this regard and has been guided by her father not to respond to any one in this regard and to ask them to contact her father. We avoided this to keep the matter confined and not to involve others thereby making it further problem for the department. On our return it was recommended to the worthy DEO (F) to immediately ban the junior clerk Nasir Iqbal and Nasir sweeper from the school as their presence is not good in this situation. Later on the committee was called to conduct personal hearing of the two fellows Nasir Iqbal Junior Clerk and Nasir sweeper who had been issued with charge sheets. Both of them were called to the DEO (F) office and were heard in the presence of the office superintendent. But today again their statements were the same not ready at any cost to disclose anything may be because of the fear that if they disclose anything about the situation in the school their own misdeeds will, also be disclosed.

Back to the fact finding enquiry report of Saeed sb enquiry who had called this junior clerk Nasir Iqbal to his office GHSS No3 cantt Peshawar where he was questioned about the complaint lodged against him in the school by a family of a primary school students to whom he has shown nude pictures a few months back. On this occasion Nasir Iqbal tod Saeed sb that not only Canteen but the school IIM office was also frequently used by this Mian Arshad for his heinous activities after school off time. When Saeed sb asked him to give it in written Nasir Iqbal J/C refused asking that by doing so he is endangering his own life and service. But here in front of us he is totally oblivious of these and such other activities thereby proving himself to be a liar and not trustworthy. Furthermore the statements of the students also do not present Mr. Nasir Iqbal to be a man of character.

(The statements of the students clearly show that Nasir sweeper has clearly been involved in the immoral activities in the school. It suspicious looks and his suspicious movements is a proof to that or the vice versa. The statements of the students describe him a characterless man.)

Wajid chowkidar was also questioned in this regard. He also submitted a written statement. He on a number occasions raised objections to the activities of Mian Arshad N/Q but could not afford to go further because he probably could not afford enmity with other class IV staff:

Findings.

Utilizing the above mentioned tools, methods and procedures the investigators reached at the following findings that;

• Mst Ambareen the HM of the school has committed a negligence in her duty by allowing herself to be guided by this Mian Arshad thereby hiding his evil and heinous activities and using the institution (HM office and its furniture was used by the culprit for his immoral activities after the school time where he forced girls students to stay with him. He has the key of this office. He usually stayed here till evenings) for his vicious acts. With this negligence she became a source of torture and disgrace for respectable families and innocent girls' students and also a source of shame and defame for the whole department:

She allowed Mian Arshad N/Q to run an illegal Canteen in the school premises which was used for illegal and immoral activities turning it into a dark room. Illegal: financial benefits were also gained from it, some of which were even given to her in the form of gifts and takeaway food items in the form of lunch boxes.

 The HM usually left the school an hour earlier encouraging illdiscipline in the school thereby allowing everyone to go for their own mean activities.

Making Mian Arshad a special man encouraged other male supporting staff to go for their own ill wishes spoiled them and

they started taking benefits from this situation in the school. The junior Clerk Mr. Nasir Iqbal who has been involved in showing nucle pictures to the students.

showing nude pictures to the students on one hand and neglecting his duties on the other hand has not done justice with his position, age and stature. As a clerk he should have warned the HM of the situation or should have reported the situation to the high ups in the district administration. He even tried to mislead the enquiry committees by not providing the facts. It has been a criminal

(Mr. Nasir the sweeper can be expected anything to do in this situation. He has cashed the situation to his own benefits probably he could not do further otherwise he would have been the worst. • Of all the male supporting staff Mr. Wajid chowkidar is probably the only class IV who has done justice to his duties.

Conclusions:

The investigators reached at the following conclusions from the above findings that:


- 1. Mst Ambareen the HM has committed a criminal negligence. She has rendered herself unfit for government service.
- 2. Mian Arshad has been guilty of destroying the life of an innocent girl. He has been involved in such activities in a number of cases which remained undisclosed. He also has been involved in unlawfully making money in the school by running an illegal canteen.
- 3. Mr Nasir Iqbal J/C did not leave himself lit for this post.
- 4. Nasir sweeper is not fit to be kept as sweeper after such reports about his charcter.

Recommendations:

It is recommended that:

- 1. Mst Hira Batool case is being adjudicated in the court of law,
- 2. Mian Arshad N/Q has committed a crime by involving himself in the illegal and immoral activities in the school premises. He may straightaway be dismissed from service.
- 3. Mst Ambareen HM may be proceeded against for criminal negligence in her duty.
- 4. Nasir Iqbal J/C may be removed from service for being negligent in his duty and indulging in immoral activities.
- 5. Mr. Nasir sweeper is not fit for government service because of his characterless nature. He may be removed from service for having bad eyes on the girls' students in the school.

INTRODUCTION

The competent authority has appointed Mr. Abdul Saeed Principal (BS-19) and Mst. Bibi Tasleem (HM) GGHS Qaidabad Peshawar to conduct inquiry against Mr.Mian Arshad Khan, Naib Qasid, GGHS Qasab Khana Peshawar regarding complaint/ FIR lodged under Section 377B PPC and 53 CPA at police station Yakatoot Peshawar City.

BRIEF HISTORY OF THE CASE.

Mr. Mian Arshad Khan, Naib Qasid was appointed as a Naib Qasid on 22-02-2012, under office order No.4106-10 dt 21-02-2012 (Annexure A). His date of birth is 03-04-1977. He has a welldressed personality and took a commanding position in the school, doing all the official works like dealing with AG office, DEO office and Directorate of E&SED. He has been running an illegal canteen for the last 8 years. He fully handicapped all the employees of the school and acted as a "master key" at the girl's school. As per information a student named Hira Batool, the student of class 7th (B), whose record reflects her last class attendance on 6th November 2021. Her mother Mst. Kalsoom is the member of school PTC. As per information, Mst.Kalsoom mother of the victim was called by Mst. Ambareen HM regarding some unknown work. She came to school on 10th November and told the HM that her daughter Hira Batool is not feeling well and we are so conscious about her, trying to get her treated by doctor. On 12-11-2021, she lodged an FIR in the local police station that Mr. Mian Arshad Khan (N/Q) raped his daughter on 06-11-2021 in the cameen room after school timing (Annexure B).

On 13th November 2021, the local police came to school along with the victim and her parents and arrested the accused Mr. Mian Arshad Khan (N/Q) of the concerned school. The mother of the victim started beating the head girl Mst. Raheela of class 9th (A) and shouted that she took my daughter in the room of Mr. Mian Arshad Khan (N/Q) where the incident happened. The accused was produced before the court of law, who allow a three day remand of the accused and giving him in the custody of the local police. After three days on 17-11-2021, the accused Mr. Mian Arshad Khan (N/Q) was sent to jail and the case as under trail in the Court of Law.

INQUIRY PROCEEDINGS.

The inquiry committee received the notification of the inquiry on 15-11-2021. Keeping in view the sensitivity of the case, the inquiry committee quickly moved to the concerned school that is GGHS Qasab Khana Peshawar, where Mst. Ambareen was the HM. The committee visited the

1

tice of the IIM where she briefed about the situation and tried to show the accused Mr. Mian d_anxious/14 Arshad Khan (N/Q) as an innocent, blameless and clean handed man and blamed the victim student along with her parents as a false and cheater student. HM of the concerned school discussed the chnicalities of the case. The briefing of the HM was totally one sided and the committee seriously thought about the actual facts that why a minor student of class 7th (B) alleged the Naib Qasid and what was the connection between Mr. Mian Arshad Khan (N/Q) and such student and what were the circumstances which compelled the student to get close to Mian Arshad (N/Q) who does such immoral and criminal acts with such student.

After a thorough discussion the committee decided to have a visit of the school and specially the victim's class i.e. 7th (B). The committee visited the place of incident which was a dark room of size (6"x12") where a Charpoy and mattress was lying inside the room. The room was separated from a class room by a 9 feet high wall and such class room was converted into Clerk's Office. The HM was asked that why a separate room was given to a Naib Qasid of the school, her reply did not satisfy the committee as he had occupied the room since long even before her transfer.

The committee then visited the victim's class room i.e. 7th (B), the class room was situated on the other side of the school in front of Primary Section. The total strength of the class was 56 and the girl students were sitting on the floor of the class having no furniture. Certain questions were asked by the committee from the student of the class 7th (B), but still some alleged silence was observed from students of such class. The committee stayed about 10 to 15 minutes in the class room but no information regarding such incident came out. While coming out from the class the committee thanked the subject teacher for giving time during the class (HERE THE FACTUAL POSITON CAME OUT), which turns and deviates the direction of the inquiry into a positive and fruitful direction "A CT teacher named Mst. Saima Yousaf told slowly to the committee that when a canteen is runs, in the girls school by a male then we may expect more casualties like Hina Batool's

Here the inquiry committee used harsh tone to the HM of the concerned school that why she is hiding the actual information/ facts from the inquiry committee and trying to dodge the inquiry. committee. The HM was immediately sent to her office and then again a conversation session was conducted with the students of the victim's class. Now all the students of the class shouted that Mr. Mian Arshad Khan (N/Q) is a very bad man, he is involved in immoral practices with a lot of students. "As per statement of students, Mr. Mian Arshad Khan (N/Q) took each and every girl student inside the room for giving canteen items. He did not want to give items outside the dark room because he usually touched every girl inside the room and the HM of the concerned school supported him in criminal activities, by hiding and ignoring all such activities. These information's were very shocking and disappointing for the inquiry committee.

Keeping in view the dangerous situation of the concerned school, the inquiry committee

A security committee was constituted which is headed by Mst. Nargis Perveen SST (G) a senior most staff member and 3 more staff members were included

as members of the committee constituting of

- 1. Mst. Nargis Parveen (SST) Chairperson
- 2. Mst. Saima Yousaf (CT) Member

- 3. Mst. Chanda (CT) Member
- 4. Mst. Maria (SST) Member
- by concerned and anxious



 Direction was issued for demolishing the wall which separates the office of the Clerk, creating a dark room in such portion immediately.

 Such room was quickly handed over to the staff of the school for starting a new class room for those classes which are heavily crowded.

- 4. The back side of the school, which was totally hidden from all the staff of the school and was quite dangerous for any criminal activity was immediately blocked by developing a wall and instruction were given for the proper use of the school way.
- 5. It was noticed that the CCTV camera were out of order, direction regarding maintenance of those cameras, was issued to the authorities of school.

Instructions were given to the administration of the school that comply the issued direction in letter and spirit and the inquiry committee will again visit the school. The inquiry committee again visited the school with the gap of one day, the committee collected a lot of verbal information regarding attitude of different male Class-IV including the Clerk of the concerned school. All the

On 17-11-2021, the committee visited the school and chaired a staff meeting in the Break Timing of the school. The staff members were directed to submit a written statement regarding the recent scenario. Then statement from students of 7^{th} (B) were collected by given only two questions.

In reply of such questions almost all the students submitted adverse remarks, even many of the students admitted that Mr. Mian Arshad Khan (N/Q) touches them, but they did not tell anyone, they submitted that Arshad Mama' offered and forced the students to enter in his room and he refused to give canteen item outside the room. He always insisted to come inside the dark room. The student were asked that why they did not inform the HM of the school regarding such things?? The students replied that Arshad Mama was the special person of the HM and they were afraid of the strange nature of HM regarding Mian Arshad (N/Q) (Annexure C1,C2-----C11).

As per staff statements (teachers) they did not know about Main Arshad Khan's (N/Q) criminal activities and now after such incident in the school their respective students told a lot about the male staff of the school which are not expressed in words. They came to know about all these shameful activities of Naib Qasid very late. The inquiry committee observed the guilt feeling of the staff and most of them were found weeping after recording their statements, as most of them are also the mothers of young daughters at their homes (Annexure D1,D2-----D16).

"But only one person was not shameful and she was Mst. Ambareen HM of the concerned school. After recording the statements of the staff and students who confess and explain the criminal activities running at school, she asked the committee if Mian Arshad Khan (N/Q) gets released from the jail please allow him to come to our school." These words killed the human behavioral, norms and moral dignity of the inquiry committee that she has no concern about dozens of girl's students of the school that what happened to them? How will she face the parents of such victims. $M = \frac{10}{10}$ ing the evil acts of Mian Arshad Khan (N/Q)? But she was only concerned and anxious M in Mian Arshad (N/Q) and her utmost wish was that such person shall be released from Jail by $\frac{53}{53}$

At that moment the inquiry committee felt that the presence of Mst. Ambareen, at GGHS Qasab Khana Peshawar City as head of such institution is very dangerous and in her presence the free and fair inquiry is not possible. Then the committee quickly approached to the Worthy Director E&SED Khyber Pakhtunkhwa and briefed about the current situation, who quickly issued direction to Mst. Samina Ghani DEO (F) Peshawar to place the services of Mst. Ambareen HM at the disposal of Directorate E&SED Khyber Pakhtunkhwa and appointed Mst. Nargis SST (G) as Incharge HM till the arrival of the new HM at GGHS Qasab Khana Peshawar.

The statements of students reflect that all the Class-IV's of the concerned school are inverved in criminal activities including Mr. Nasir (Sweeper) and Mr. Nasir Idbal (J/C) of the concerned school. A few days earlier form such incident some parents came to school and complaint about the eriminal behavior of the Nasir Idbal Clerk of the school. They blamed that Mr. Nasir Idbal (J/C) showed nude pictures to one of the girl's student, but the HM Mst. Ambareen forwarded such ease to Mian Arshad Khan (N/Q) to resolve the issue and who resolved it by his own means. The case was neither reported nor even any action was taken against the concerned Clerk. Mr. Nasir Idbal (J/C) was called in the office of Mr. Abdul Saced (Principal) Govt Shaheed Syed Afaq Ahmad High School No.3 Peshawar Cantt who explained all the evils activities running in the school. He explained that such things happened not only in the dark room of Mian Arshad Khan (N/Q) but the HM's office was frequently used for such criminal activities. Because the HM has given her office keys to Mr. Mian Arshad (N/Q) who stayed late in the school premises. He told that all such evil activities usually, happened after school closing as the HM leaves the school one hour before closing time in routine. While all the teaching staff leaves the school quickly soon after school closing.

No staff member was left at school who look after the late going girls waiting in the school and in such duration Mian Arshad Khan (N/Q) does such shameful activities. But when the inquiry committee asked Mr. Nasir Iqbal (J/Clerk) to write such facts in his statement, he refused to do so which means that Mr. Nasir Iqbal is also involved in criminal and evil acts-feeling in danger that if he disclosed the facts in writing then the other Class-IV's will also disclose those facts regarding his criminal activities.

The most important is the statement of school Chowkidar Mr. Wajid Ali, who has been residing in the premises of the school room for the last eight years. He submits that usually Mian Arshad (N/Q) stay in the school till evening, observing suspicious activities which creating routine problems at school. As in the past a girl student complaint about Mian Arshad (N/Q) that he showed nude pictures in his mobile set, but no action was taken by the concerned HM. He submits that he usually use HM office where the girls student stay with him after school timings. He also submits that whenever he saw a criminal activity done by Mian Arshad Khan (N/Q) he advised him not to do such action as his wife and children are residing in such school but he always fought with me. He also submits that he had reported about such criminal events to all the HM including Mst. Neelam Qayyum, Mst. Farzana and present HM Mst. Ambareen, but no action was taken by such Head Mistresses. He also records that all the Class-IV and old staff of the school knows each and every thing regarding Mian Arshad Khan (N/Q) evil attempts (Annexure E1,E2).

The submits that I am a Chowkidar living in the premises of the school and my duty is to inform the HM of the institution about any illegal activity. Being a poor man I was not able to take enmity with Mian Arshad Khan (N/Q) even all the teaching staff make criminal silence on such activities if action was taken on proper time then such situation would not have happened as today.

VITAL POINTS.

- 1. Mst. Ambarcen the Head Mistress of GGHS Qasab Khana Peshawar has a criminal negligence over the suspicious and evil activities of Mian Arshad Khan (N/Q) and others.
- 3. Presence of dark rooms in the premises of the girls school where frequent movement of girls was allowed, creating a wide space for male officials of the school for the fulfilment of their cvil needs.

4. Autocratic attitude, Creating gap with the students and allowing certain officials as special persons of the Head of the institution results in destruction of human Norms.

- 5. When the inquiry committee used lienant and sympathetic attitude, the students expressed all their internal eatharses in front of the inquiry committee.
- 6. Allowing canteens, in the girl's school run by male stall results in creating criminal and illegal activities within the girls school.
- 7. Absent from duties, leaving the school before closing time, creating gap with the staff and adopting monarchy within the school will spoil the peaceful environment of the institution.
- 8. The behavior and attitude of Mian Arshad Khan (N/Q) spoils the habits of other class-IV's too.
- 9. (The attitude of Mr. Nasir (sweeper) of the concerned school is also quite objectionable.)
- 10. Mr. Nasir Iqbal (J/C) of the concerned school who hided the facts regarding a sensitive inquiry, is also involved in many objectionable, immoral and criminal activities within the institution.
- 11. Mr. Wajid Ali (Chowkidar) is the only male employee who slightly justified his duty seems raised objections on the evil activities of the male staff at GGHS Qasab Khona Peshawar and reported complaint about the behavior, suspicious and criminal activities to the Head of the institution because of the very fact that his family and daughters are residing in the premises of the same school. He strictly bounded his wife and children not to come out of their quarter due to dangerous and criminal environment of the school.
- 12. Honest, bold and fair teachers like Mst. Saima Yousaf (CT) are the asset of Elementary and Secondary Education Department KPK and the inquiry committee is fully thankful for his efforts and performance for tracing such black sheep's in the school.

RECOMMENDATIONS.

1. Hira Batool rape case is Sub-juiced in the Court of Law,

2. The appointment order of Mian Arshad (N/Q) may please be verified.

- Mian Arshad (N/Q) GGHS Qasab Khana Peshawar may please be dismissed from his service, due to his involvement in criminal and immoral activities with girl's student within the premises of GGHS Qasab Khana Peshawar.
- Mr. Nasir Iqbal (J/C) GGHS Qasab Khana Peshawar may be removed from service for hiding factual information and involvement in criminal and immoral activities.

As per information a student named Hira Batool, the student of class 7th (B), whose record reflects her last class attendance on 6th November 2021. Her mother Msg. Kalsoom is the member of school PTC. As per information, Mst.Kalsoom mother of the victim was called by Mst. Ambareen HM regarding some unknown work. She came to school on 10th November and told the HM that her daughter Hira Batool is not feeling well and we are so conscious about her, trying to get her treated by doctor. On 12-11-2021, she lodged an FIR in the local police station that Mr. Mian Arshad Khan (N/Q) raped his daughter on 06-11-2021 in the canteen room after school timing (Annexure B).

On 13th November 2021, the local police came to school along with the victim and her parents and arrested the accused Mr. Mian Arshad Khan (N/Q) of the concerned school. The mother of the victim started beating the head girl Mst. Raheela of class 9^{th} (A) and should that she look my daughter in the room of Mr. Mian Arshad Khan (N/Q) where the incident happened. The accused was produced before the court of law, who allow a three day remand of the accused and giving him in the custody of the local police. After three days on 17-11-2021, the accused Mr. Mian Arshad Khan (N/Q) was sent to jail and the case as under trail in the Court of Law.

INQUIRY PROCEEDINGS.

The inquiry committee received the notification of the inquiry on 15-11-2021. Keeping in view the sensitivity of the case, the inquiry committee quickly moved to the concerned school that is GGHS Qasab Khana Peshawar, where Mst. Ambareen was the HM. The committee visited the

rnee of the risk where she offered about the situation and thee to show the accused with when Arshad Khan (N/Q) as an innocent, blameless and clean handed man and blamed the victim student along with her parents as a false and cheater student. HM of the concerned school discussed the ...chnicalities of the case. The briefing of the HM was totally one sided and the committee seriously thought about the actual facts that why a minor student of class 7th (B) alleged the Naib Qasid and 582 what was the connection between Mr. Mian Arshad Khan (N/Q) and such student and what were the circumstances which compelled the student to get close to Mian Arshad (N/Q) who does such immoral and criminal acts with such student.

After a thorough discussion the committee decided to have a visit of the school and specially the victim's class i.e. 7th (B)., The committee visited the place of incident which was a dark room of size (6"x12") where a Charpoy and mattress was lying inside the room. The room was separated from a class room by a 9 feet high wall and such class room was converted into Clerk's Office. The HM was asked that why a separate room was given to a Naib Qasid of the school, her reply did not satisfy the committee is he had occupied the room since long even before her transfer.

The committee then visited the victim's class room i.e. 7th (B), the class room was situated on the other side of the school in front of Primary Section. The total strength of the class was 56 and the girl students were sitting on the floor of the class having no furniture. Certain questions were asked by the committee from the student of the class 7th (B), but still some alleged silence was observed from students of such class. The committee stayed about 10 to 15 minutes in the class room but no information regarding such incident came out. While coming out from the class the committee thanked the subject teacher for giving time during the class (HERE THE FACTUAL POSITON CAME OUT), which turns and deviates the direction of the inquiry into a positive and fruitful direction "A CT teacher named Mst. Saima Yousaf told slowly to the committee that when a canteen is runs, in the girls school by a male then we may expect more casualties like Hina Batool's case in the future.

Here the inquiry committee used harsh tone to the HM of the concerned school that why she is hiding the actual information/ facts from the inquiry committee and trying to dodge the inquiry committee. The HM was immediately sent to her office and then again a conversation session was conducted with the students of the victim's class. Now all the students of the class should that Mr. Mian Arshad Khan (N/Q) is a very bad man, he is involved in immoral practices with a lot of students. As per statement of students, Mr. Mian Arshad Khan (N/Q) took each and every girl student inside the room for giving canteen items. He did not want to give items outside the dark room because he usually touched every girl inside the room and the HM of the concerned schoolsupported him in criminal activities, by hiding and ignoring all such activities. These information's were very shocking and disappointing for the inquiry committee.

Keeping in view the dangerous situation of the concerned school, the inquiry committee immediately issued direction which are as followed;

I. A security committee was constituted which is headed by Mst. Nargis Perveen SST (G) a senior most staff member and 3 more staff members were included is members of the committee constituting of

 Direction was issued for demolishing the wall which separates the office of the Clerk, creating a dark room in such portion immediately.

3. Such room was quickly handed over to the staff of the school for starting a new class room for those classes which are heavily crowded.

4. The back side of the school, which was totally hidden from all the staff of the school and was quite dangerous for any criminal activity was immediately blocked by developing a wall and instruction were given for the proper use of the school way.

5. It was noticed that the CCTV camera were out of order, direction regarding maintenance of those cameras, was issued to the authorities of school.

Instructions were given to the administration of the school that comply the issued direction in letter and spirit and the inquiry committee will again visit the school. The inquiry committee again visited the school with the gap of one day, the committee collected a lot of verbal information regarding attitude of different male Class-IV including the Clerk of the concerned school. All the information was very shocking for the committee.

On 17-11-2021, the committee visited the school and chaired a staff meeting in the Break Timing of the school. The staff members were directed to submit a written statement regarding the recent scenario. Then statement from students of 7th (B) were collected by given only two questions.

In reply of such questions almost all the students submitted adverse remarks, even many of the -students admitted that Mr. Mian Arshad Khan (N/Q) touches them, but they did not tell anyone, they submitted that Arshad Mama offered and forced the students to enter in his room and he refused to give canteen itera outside the room. He always insisted to come inside the dark room. The student were asked that why they did not inform the HM of the school regarding such things?? The students replied that Arshad Mama was the special person of the HM and they were afraid of the strange nature of HM regarding Mian Arshad (N/Q) (Annexure C1,C2-----C11).

As per staff statements (teachers) they did not know about Main Arshad Khan's (N/Q) criminal activities and now after such incident in the school their respective students told a lot about the male staff of the school which are not expressed in words. They came to know about all these shameful activities of Naib Qasid very late. The inquiry committee observed the guilt feeling of the staff and most of them were found weeping after recording their statements, as most of them are also the mothers of young daughters at their homes (Annexure D1,D2-----D16).

"But only one person was not shameful and she was Mst. Ambareen HM of the concerned school. After recording the statements of the staff and students who confess and explain the criminal activities running at school, she asked the committee if Mian Arshad Khan (N/Q) gets released from the jail please allow him to come to our school." These words killed the human behavioral, norms and moral dignity of the inquiry committee that she has no concern about dozens of girl's students of the school that what happened to them? How will she face the parents of such victims,

and the evil acts of Mian Arshad Khan (N/Q)? But she was only concerned and anxious/ M shout Mian Arshad (N/Q) and her utmost wish was that such person shall be released from Jail by

At that moment the inquiry committee felt that the presence of Mst. Ambareen, at GGHS Qasab Khana Peshawar City as head of such institution is very dangerous and in her presence the free and fair inquiry is not possible. Then the committee quickly approached to the Worthy Director E&SED Khyber Pakhtunkhwa and briefed about the current situation, who quickly issued direction to Mst. Samina Ghani DEO (F) Peshawar to place the services of Mst. Ambareen HM at the disposal of Directorate E&SED Khyber Pakhtunkhwa and appointed Mst. Nargis SST (G) as Incharge HM till the arrival of the new HM at GGHS Qasab Khana Peshawar.

The statements of students reflect that all the Class-IV's of the concerned school are involved in criminal activities including Mr. Nasir (Sweeper) and Mr. Nasir Iqba' (J'C) of the concerned school. A few days earlier form such incident some parents came to second and complaint about the criminal behavior of the Nasir Iqbal Clerk of the school. They blamed that Mr. Nasir Iqbal-(J/C) showed nude pictures to one of the girl's student, but the HM Mst. Ambareen forwarded such case to Mian Arshad Khan (N/Q) to resolve the issue and who resolved it by his own means. The case was neither reported nor even any action was taken against the concerned Clerk. Mr. Nasir Iqbal (J/C) was called in the office of Mr. Abdul Saeed (Principal) Govt Shaheed Syed Afaq Ahmad High School No.3 Peshawar Cantt who explained all the evils activities running in the school. He explained that such things happened not only in the dark room of Mian Arshad Khan (N/Q) but the HM's office was frequently used for such criminal activities. Because the HM has given her office keys to Mr. Mian Arshad (N/Q) who stayed late in the school premises. He told that all such evil activities usually, happened after school closing as the HM leaves the school one hour before closing time in routine. While all the teaching staff leaves the school quickly soon after school closing.

No staff member was left at school who look after the late going girls waiting in the school and in such duration Mian Arshad Khan (N/Q) does such shameful activities. But when the inquiry committee asked Mr. Nasir Iqbal (J/Clerk) to write such facts in his statement, he refused to do so which means that Mr. Nasir Iqbal is also involved in criminal and evil acts-feeling in danger that if he disclosed the facts in writing then the other Class-IV's will also disclose those facts regarding his criminal activities.

The most important is the statement of school Chowkidar Mr. Wajid Ali, who has been residing in the premises of the school room for the last eight years. He submits that usually Mian Arshad (N/Q) stay in the school till evening, observing suspicious activities which creating routine problems at school. As in the past a girl student complaint about Mian Arshad (N/Q) that he showed nude pictures in his mobile set, but no action was taken by the concerned HM. He submits that he usually use HM office where the girls student stay with him after school timings. He also submits that whenever he **sh**w a criminal activity done by Mian Arshad Khan (N/Q) he advised him not to do such action as his wife and children are residing in such school but he always fought with me. He also submits that he had reported about such criminal events to all the HM including Mst. Neelam Qayyum, Mst. Farzana and present HM Mst. Ambareen, but no action was taken by such Head Mistresses. He also records that all the Class-IV and old staff of the school knows each and every thing regarding Mian Arshad Khan (N/Q) evil attempts (Annexure E1,E2).

The submits that I and a Chowkidar living in the premises of the school and my duty is to inform the IIM of the institution about any illegal activity. Being a poor man I was not able to take enmity with Mian Arshad Khan (N/Q) even all the teaching staff make criminal silence on such activities if action was taken on proper time then such situation would not have happened as today.

VITAL POINTS.

Mst. Ambareen the Head Mistress of GGHS Qasab Khana Peshawar has a criminal negligence over the suspicious and evil activities of Mian Arshad Khan (N/Q) and others. Mst. Ambareen the Head Mistress of GGHS Qasab Khana Peshawar trying to dodge and

misguide the inquiry committee, hiding facts and saving the accused Mian Arshad Khan (N/Q) from any disciplinary action.

Presence of dark rooms in the premises of the girls school where frequent movement of girls , was allowed, creating a wide space for male officials of the school for the fulfilment of their evil needs.

4. Autocratic attitude, Creating gap with the students and allowing certain officials as special persons of the Head of the institution results in destruction of human Norms.

- 5. When the inquiry committee used lienant and sympathetic attitude, the students expressed all their internal eatharses in front of the inquiry committee.
 6. Allowing canteens, in the girl's school run by publication.
- 5. Allowing canteens, in the girl's school run by male staff results in creating criminal and illegal activities within the girls school.

7. Absent from duties, leaving the school before closing time, creating gap with the staff and adopting monarchy within the school will spoil the peaceful environment of the institution.

- 8. The behavior and attitude of Mian Arshad Khan (N/Q) spoils the habits of other class-IV's too.
- 9. The attitude of Mr. Nasir (sweeper) of the concerned school is also quite objectionable. 10. Mr. Misir Jubal (105) of the concerned school is also quite objectionable.

 Mrs Masir Iqbal (J/C) of the concerned school who hided the facts regarding a sensitive inquiry, is also involved in many objectionable, immoral and criminal activities within the institution.

- 11. Mr. Wajid Ali (Chowkidar) is the only male employee who slightly justified his duty seems raised objections on the evil activities of the male staff at GGHS Qasab Khana Peshawar and reported complaint about the behavior, suspicious and criminal activities to the Head of the institution because of the very fact that his family and daughters are residing in the premises of the same school. He strictly bounded his wife and children not to come out of their quarter due to dangerous and criminal environment of the school.
- 12. Honest, bold and fair teachers like Mst. Saima Yousaf (CT) are the asset of Elementary and Secondary Education Department KPK and the inquiry committee is fully thankful for his efforts and performance for tracing such black sheep's in the school.



Enquiry Report about Mr. Mian Arshad Khan Naib Qasid, Govt; girls High School Qasab Khana Feshawar.

Objectives of the Enquiry:

The competent authority appointed Mst Farzana Lal Sher Principal GHSS Chamkani and Mr. Ilitiram Khan Principlal GHSS Urmar Bala Peshawar to conduct a formal inquiry about Mr. Mian Arshad Khan Naib Qasid, 'Govt; girls High School Qasab Khama Peshawar regarding complaint/FIR lodged against him in Police Station Yakatoot by one of the parents for raping/sexually harassing her daughter, a student of class 7th GGHS Qasab Khana Peshawar and to submit a report to the competent authority with recommendations.

Problem Review:

As per information from a fact finding enquiry into the matter by Abdul Saced Principal Government Shaheed Alaq Ahmad high School Cantt Peshawar (Cantt No 3) a student named Hira Batool, the student of class 7th B GGHS Qasab Khana Peshawar whose attendance register record shows her last class attendance on Nov 6th, 2021 and her mother Mst Kalsoom who is also a member of the school Parents Teachers Council, on Nov 10th 2021 called on Mst Ambreen, the school headmistress, and told her that her daughter Hira Batool is not feeling well and that they (her parents) are quiet anxious about her and that they are treating her by a doctor. On Nov 12th 2021 she lodged an FIR in the local Police Station Yakatoot that Mr. Mian Arshad Khan Naib Qasid (who was appointed as Naib Qasid on Feb 22nd 2012 under Office Order No:1106 date 21-2-2012 (Annexure A)) raped her daughter on Nov 6th 2021 in the school canteen (illegally run by Mian Arshad for eight years in a portion of q class room separated by a kachaa wall from the rest which was used as Elerk office by the junior clerk Mr. Nasir (gbal) after school timing. (Annexure B)

Nov 13^{th} 2021 the local police came to the school with the victim and her parents and arrested the accused Mr. Mian Arshad Khan N/Q of the concerned school. The mother of the victim started beating Raheela.⁴ the head girl of class 9^{th} A, shouting that she took her daughter Hira Batool in the room (canteen) of Mian Arshad Khan where the incident took place. The accused was produced before the court of law, who was later on sent to Jail and the case is under trial in the court of law. Data collection Tools: / Information received from the fact finding enquiry into the matter by Abdul Saced Sb Principal GHSS No 3 Cantt Peshawar, Interview, Questionnaire, Openionnair, FIR, Observation of the school canteen, class 7th B, Headmistress Office and the junior elerk office. : Government Girls High School Qasao Khana Peshawar.

Method and Procedures:

: Jan/ Feb: 2022

As the enquiry committee discussed the matter with the DEO (F)Peshawar in detail, getting the full information, added by the enquiry report of Mr. Abdul Saced Principal Cantt 3. The committee then moved to the school concerned. Mst Farzana Lal Sher principal GGHS Chamkani, visited the home of Hira Batool as it was considered by the committee not to call her to the school in this scenario. Hira Batbol and her mother were interviewed in detail. And written statement was also taken from Hira-Batool (G1). After that the mother of Hira Batool accompanied Mst Farana lal Sher to the school to see the other member (Ihtiram Khan principal GHSS Urmar Bala) of the enquiry committee and to discuss the situation with him. Both the Ladies were accompanied by Mst Saima Yousaf CT. All the three ladies in the presence of the school incharge Mst Nargas Parveen SST G gave detailed information to the enquiry committee. Each and every aspect of the case was discussed in detail. After that the Junior Clerk Mr Nasir Inbal and Mr.Nasir sweeper were called to the office of HM and were interviewed in details and written statements were also taken from them(H1, H2). Both these fellows were not cooperating. They did not furnish any information. Their behavior and attitude was suspicious as if they were hiding something. But their statements were matching. It was clear that they had made up their minds not to disclose anything relying just on saying that they knew nothing. The committee in presence of the in charge then visited class 7th B and the place where canteen existed and the clerk s office.

In her statement Hira Betool complained of Raheela, the head gir of class 9th who had taken Hira Batool to the canteen and acted as supplie in this case. This provides a proof that this Mian Arshad had prepared a network for his heinous acts. But this Raheela, we were told, Joes no respond to any question in this regard and has been guided by her father not to respond to any one in this regard and to ask them to contact her father. We avoided this to keep the matter confined and not to involve others thereby making it further problem for the department. On our return it was recommended to the worthy DEO (F) to immediately ban the junior clerk Nasir Iqbal and Nasir sweeper from the school as their presence is not good in this situation. Later on the committee was called to conduct personal hearing of the two fellows Nasir Iqbal Junior Clerk and Nasir sweeper who had been issued with charge sheets. Both of thom were called to the DEO (F) office and were heard in the presence of the office superintendent. But today again their statements were the same rot ready at any cost to disclose anything may be because of the fear the' if they disclose anything about the situation in the school their own misdaeds will also be disclosed.

Back to the fact finding enquiry report of Saeed sb enq iry who had called this junior clerk Nasir Iqbal to his office GHSS No3 canto Peshawar where he was questioned about the complaint lodger against him in the school by a family of a primary school students to whom he has shown nude pictures a few months back. On this occasion Nasir Iqbal too Saeed sb that not only Canteen but the school HM office was also frequently used by this Mian Arshad for his heinous activities after school off time. When Saeed sb asked him to give it in written Nasir Iqbal J/C refused asking that by doing so he is endangering his own life and service But here in front of us he is totally oblivious of these and such other activities thereby proving himself to be a liar and not trustworthy Furthermore the statements of the students also do not present Mr. Nasir Iqbal to be a man of character.

The statements of the students clearly show that Nasir sweeper has clearly been involved in the immoral activities in the school. His suspicious looks and his suspicious movements is a proof to that or the vice versa. The statements of the students describe him a characterless man.

Wajid chowkidar was also questioned in this regard. He also submitted a written statement. He on a number occasions raised objections to the activities of Mian Arshad N/Q but could not afford to go further because he probably could not afford enmity with other class IV staff.

Higher Secondary School Urmar Bala Peshawar with the direction to submit documentary proofs / clear cut recommendations vide this office Endst No. 30-34 dated.
- AND WHEREAS He was proceeded against under Khyber Pakhtunkhwa Govt: Servant rules 2011 for the charge leveled by the inquiry officers in their inquiry report and was suspended vide this office Endst No 356-61 dated. 01.01.2022.
- AND WHEREAS Charge Sheet was issued to the above named official through Headmistress vide this office Endst No. 376 dated. 01.01.2022. 6
- AND WHEREAS The Inquiry committee has submitted in their report that Mr. Nasir Iqbal, Junior Clerk Govt. Girls High School Qasab Khana Peshawar may be removed 7 from service for being negligent in his duty and including in immoral activities.

Findings:

Utilizing the above mentioned tools, methods and procedures the investigators reached at the following findings that;

- Mst Ambareen the HM of the school has committed a negligence in her duty by allowing herself to be guided by this Mian Arshad thereby hiding his evil and heinous activities and using the institution (HM office and its furniture was used by the culprit for his immoral activities after the school time where he forced girls. students to stay with him. He has the key of this office. He usually stayed here till evenings) for his vicious acts. With this negligence she became a source of torture and disgrace for respectable families and innocent girls' students and also a source of shame and defame for the whole department.
- She allowed Mian Arshad N/Q to run an illegal Canteen in the school premises which was used for illegal and immoral activities turning it into a dark room. Illegal financial benefits were also gained from it, some of which were even given to her in the form of gifts and takeaway food items in the form of lunch boxes.
- The HM usually left the school an hour earlier encouraging illdiscipline in the school thereby allowing everyone to go for their own mean activities.
- Making Mian Arshad a special man encouraged other male supporting staff to go for their own ill wishes spoiled them and they started taking benefits from this situation in the school.
- The junior Clerk Mr. Nasir Iqbal who has been involved in showing nude pictures to the students on one hand and neglecting his duties on the other hand has not done justice with his position. age and stature. As a clerk he should have warned the HM of the situation or should have reported the situation to the high ups in the district administration. He even tried to mislead the enquiry. committees by not providing the facts. It has been a criminal to do
 - negligence on his part. Mr. Nasir the sweeper can be expected anything to do in this situation. He has eashed the situation to his own benefits probably he could not do further otherwise he would have been the work. Statement of 11 Students highlight the character of Nair Sweeper when he is winking, Staring, Leeherous Smiles, and touching the

students. It indicates his poisons nature Of all the male supporting staff Mr. Wajid chowkidar is probably the only class IV who has done justice to his duties.

The investigators reached at the following conclusions from the above findings that:

- 1. Mst Ambareen the HM has committed a criminal negligence. She has rendered herself unfit for government service.
- 2. Mian Arshad has been guilty of destroying the life of an innocent girl. He has been involved in such activities in a number of cases which remained undisclosed. The also has been involved in unlawfully making money in the school by running an illegal canteen.
- 3. :: Mr Nasir Iqbal J/C did not leave himself fit for this post.
- 4. Nasir sweeper is not fit to be kept as sweeper after such reports about his charcter.

Recommendations:

Conclusions:

It is recommended that:

- 1. Mst Hira Batool case is being adjudicated in the court of law.
- 2. Mian Arshad N/Q has committed a crime by involving himself in the illegal and immoral activities in the school premises. He may straightaway be dismissed from service.
- 3. Mst Ambareen HM may be proceeded against for criminal negligence in her duty.
- Nasir Iqbal J/C may be removed from service for being negligent in his duty and indulging in immoral activities.
- 5. Mr. Nasir sweeper is not fit for government service because of his characterless nature. He may be removed from service for having bad eyes on the girls' students in the school.
