KALIM ARSHAD KHAN, CHAIRMAN: Brief facts of the case are that appellant was serving as Primary School Teacher; that she was promoted from BPS-07 to BPS-12; that for further promotion, she submitted documents in the office of respondent No.2. that vide impugned order dated 27.07.2015 issued on 27.05.2019 appellant's name was not included in the promotion list; that feeling aggrieved, she filed departmental appeal on 16.07.2019, which was not responded, hence, the instant service appeal.

- 3. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.
- 4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order(s).
- 5. Claim of the appellant is that she had enhanced her educational qualification, whereas, the respondents were not promoting the appellant on the ground that she had passed only the Secondary School Certificate Examination. The claim of the appellant that she had properly brought in the notice of the respondents that her educational qualification was F.A, which fact was also incorporated in the PER, copy of which is annexed with the appeal but on the other side, the respondents have not advanced anything which could tell us that the improved educational qualification was not brought in their notice.
- 6. Therefore, we dispose of the appeal leaving the appellant at liberty to make another application, and in case the appellant was otherwise found fit eligible under the relevant rules, she




