JUDGMENT

KALIM ARSHAD KHAN, CHAIRMAN: Brief facts of the case are that appellant was serving as Primary School Teacher; that she was promoted from BPS-07 to BPS-12; that for further promotion, she submitted documents in the office of respondent No.2. that vide impugned order dated 27.07.2015 issued on 27.05.2019 appellant's name was not included in the promotion list; that feeling aggrieved, she filed departmental appeal on 16.07.2019, which was not responded, hence, the instant service appeal.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.

3. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.

4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order(s).

5. Claim of the appellant is that she had enhanced her educational qualification, whereas, the respondents were not promoting the appellant on the ground that she had passed only the Secondary School Certificate Examination. The claim of the appellant that she had properly brought in the notice of the respondents that her educational qualification was F.A, which fact was also incorporated in the PER, copy of which is annexed with the appeal but on the other side, the respondents have not advanced anything which could tell us that the improved educational qualification was not brought in their notice.

6. Therefore, we dispose of the appeal leaving the appellant at liberty to make another application, and in case the appellant was otherwise found fit eligible under the relevant rules, she

5. That, felling aggrieved, appellant made an application with respondent No 02 on 19.06.2019 for inclusion of her name in the promotion order but no step was taken thereon.

6. That, appellant also made an appeal before respondent No 01 vide representation dated ~~16~~15.07.2019, but no decision has been taken in the stipulated period of time.

7. That, felling aggrieved from the impugned orders dated 27.05.2019, appellant having no other remedy except to file the present service appeal before this Honourable Tribunal for interference inter alia, on the following amongst other grounds.

GROUND:-

- A) That, appellant is eligible, fit and qualified for up-gradation to BPS-14.
- B) That, all the similarly placed/colleagues of the appellant have been promoted/upgraded to BPS-14 Except the appellant.
- C) That, the name of the appellant has not been included due to fault of the Department for which appellant should not be held responsible.
- D) That, appellant fulfills all the eligibility requirement as per rules for up-gradation/promotion.
- E) That, upgrading/promoting similarly placed at the exclusion of the appellant amounts to discrimination with the appellant within the meaning of Article 25 of the Constitution of Islamic Republic of Pakistan 1973.
- F) That, no objection whatsoever, over the eligibility are fitness of the appellant was ever raised by the department.
- G) That, appellant was promoted to BPS-12 on 01.07.2012, thereafter, she has been kept deprived from further promotion/up-gradation BPS-14.
