**Preliminary Objections:-**

1. That the appellant has got no cause of action or locus standi to file the instant appeal.
2. That the appellant has filed the instant appeal just to pressurize the respondents.
3. That the instant appeal is against the prevailing Law and Rules.
4. That the appeal is not maintainable in its present form and also in the present circumstances of the issue.
5. That the appellant has filed the instant appeal with mala-fide intention hence liable to be dismissed.
6. That the appellant has not come to this Honorable Tribunal with clean hands.
7. That the appeal is barred by law and limitation.
8. That the instant appeal is bad for mis-joinder of unnecessary and non-joinder of necessary parties.

**ON FACTS:**

1. Pertains to record.
2. According to the record of this Directorate, no promotion of Junior Clerk (Sub Cadre) to the post of Senior Clerk was made. It is pertinent to mention here that promotion of Junior Clerk to the post of Senior Clerk and

promotion of Senior Clerk to the post of Assistant was carried out by District Government in various Districts for the period from 2001 to 2012.

- 3. Pertain to record.
- 4. According to Final Seniority list of Senior Clerk of the year 2023, no Junior colleague of the petitioner has been shown Senior to him in the Seniority list of Senior Clerk (Annex-A).
- 5. As early elucidated in para-02 that this Directorate did not process promotion case of Junior Clerk to Senior Clerk in the year 2008, rather promotion were carried out in the year 2009-2010 as evident from the promotion order but he could not promoted as his PERs were short for which he was also asked to submit ACRs/No inquiry Certificate vide this Directorate letter No. 10316-66 dated 31/12/2009 (Copy of letter is attached as Annex-B, B1, B2).
- 6. As per final seniority list issued in the year 2023, the petitioner was at Serial No. 43, and was deferred by the Departmental Promotion Committee in its meeting held on 22/05/2023 due to shortage of PERs for the year 2009 to 2022 (Copy minutes of meeting is attached at Annex-C).
- 7. Reply of his Departmental appeal has already been given vide this Directorate letter No. 17786 dated 27/12/2023 (Annex-D).
- 8. No comments formal.

**GROUND:-**

- A) Incorrect. As explain in aforesaid paras of facts.
- B) Incorrect. The petitioner was deferred for promotion due to shortage of his PERs as explained in para-05 & 06 of the facts.
- C) Incorrect. No violation of Article-4 & 25 of the constitution of Islamic republic of Pakistan 1973 has been occurred as his promotion was deferred due to non production of PERs for the year 2009-2022.
- D) The petitioner was considered for promotion on completion pre-requisite i.e PERs/No demand certificate as per promotion policy 2009 Para-VI.
- E) Incorrect. His appeal has already been decided as explained in Para-07 above.
- F) Incorrect. As explained in Para-C above.

- G) No violation of fundamental right of the appellant has occurred as he has already been promoted on completion of pre-requisite as explained in Para-D above.
- H) Incorrect. The petitioner was treated as per Rules/Law.
- I) Incorrect. The petitioner was promoted on his turn as per final Seniority list and in light of Promotion Policy 2009 Para-VI.
- J) The reference of the persons at S. No. 16 & 23 given by the petitioner that they were Junior to him, it is stated that the persons at S. NO. 16 (Mr. Abdar Khan) & at S. No. 23 (Mr. Syed Rahim Shah) were promoted by the District Government in the year 2004, 2008 & 2009 as at that time the District Government i.e DCO was the competent authority to do so. They were not promoted by this Directorate. (Copy of promotion order is attached as Annex-E & F).
- K) The respondent also seeks to advance additional ground at the time of hearing.

**PRAYER:**

It is therefore humbly prayed that on acceptance of the comments, the instant appeal of the appellant may very graciously be dismissed with costs.
