



3. That earlier the Finance Department Government of Khyber Pakhtunkhwa extended 30% Special / Secretariat Allowance to the employees of Civil Secretariat Govt. of Khyber Pakhtunkhwa and later on Finance Department enhanced the said allowance from 30% to 50% to the employees of Civil Secretariat Khyber Pakhtunkhwa vide Finance Department Notification No. FD (SOR-III) 8-7/2019 dated 27-11-2019 and redesignate the same as "Secretariat Performance Allowance" **(copy of attached as Annexure-A)**.


4. That similarly during the year of 2023 Finance Department Government of Khyber Pakhtunkhwa once again enhanced Special Secretariat Performance Allowance from 50% to 100% to the employees of Civil Secretariat Government of Khyber Pakhtunkhwa vide Finance Department Notification No. FD (SOR-IV) 4-1/2023/2019 dated 11-07-2023 **(copy attached as Annexure-B)..**
5. That beside that Finance Department Government of Khyber again granted Utility Allowance at fixed rates to the employees of Civil Secretariat Government of Khyber Pakhtunkhwa (from BPS-03 to BPS-18) vide Notification No. FD (SOR-IV) 3-21/2024 Utility Allowance /2023/2019 dated 23-07-2024 **(copy attached as Annexure-C).**
6. That a part from Provincial Govt, of Khyber Pakhtunkhwa Finance Department Notifications regarding Secretariat Allowances etc the Government of Pakistan has also allowed Special judicial Allowance at the rate of equal to 1.5 times of monthly Basic Pay to the employees of Attorney General office Karachi, Haiderabad and Lahore vide official letter No. AGPR/SOL/TM/CD/142 dated 09-07-2024 by Accountant Pakistan Revenue Sub office Lahore in compliance of judgment of Lahore High Court in WP 12181/2024 order dated 23-02-2024 **(copy attached as Annexure-D).**
7. That is just, fair and in the large interest of justice to place the additional documents as part and parcel of the captioned Service Appeal.



Kindly refer to your office letter no. DAO/MN/PAYROLL-II/HM/112 dated 01.07.2024 on the above subject.

It is stated that employees of Attorney General office Lahore filed the Writ Petition No12181/2024 order dated 23.02.2024 before Lahore High Court Lahore in which honorable court directed to this office to decide the matter. The employees of Attorney General Karachi, Hyderabad already drawing the said allowance. After perusal of pay slips and other records the DGPR Lahore has allowed on provisionally, the Special Judicial Allowance to the employees of Attorney General Lahore office on the analogy of similar placed employees and rule of consistency subject to final outcome of the CPLA filed before the apex court.

In view of the above narrated position this office is of the view that the subject allowance may be allowed to the employees of the Attorney General office Multan on provisional basis on the rule of consistency. However, undertaking on judicial stamp paper may be taken from the beneficiaries for refund of Special judicial allowance if CPLA filed before the apex court are passed in favor of the Govt. of Pakistan
