BAGEOROUND OF THE INQUIRY:

The Principal of Govt: AKL Postgraduate College Matta Swat vide letter No. 838, dated: 29/07/2021 reported to the Director Higher Education that Mr. Muhammad Suleman, Assistant Professor of English was transferred from GDC Ladha, South Waziristan to Govt: AKL Postgraduate College Matta Swat vide notification no. SO(C-II)/HED/2-5/2021/Transfer/APs, Dated: 23/03/2021, did not report to the college for duty

FACUS OF THE CASE:

wir. Muhammad Suleman, Assistant Professor of English was appointed in 1989. His date of birth as per record is 20/04/1963. His domicile is Swat. He was posted at GDC Ladha, South Waziristan back in 1991. He is serving at GDC Ladha, South Waziristan as Principal and DDO.

GDC Ladha has remained a non-functional college since military operation in South Waziristan. The college opened for a short period back in 2016 and then in 2013. The building of the college is under construction. Total number of regular teaching staff is six (6). Total number of students is 28.

posted at GDC Haripur. He was transferred to GDC Bajaur in 1990. Later he was transferred to GDC Bajaur in 1990. Later he was transferred to GDC Ladha on 06/08/1991 and is still there.

After a long stay of about 30 years outside his home district Swat. Higher Education Department transferred and posted the accused Muhammad Suleman, Assistant Professor of English, at Govt AKL Postgraduate College Matta Swat vide Notification No. SO(C-II)/HED/2-5/2021/Transfer/APs, Dated: 23/03/2021, serial no. 71.(F/A).

The Principal of Govt AKL Postgraduate College Matta Swat vide letter No. 838. data.h: 29/07/2021 reported to Directorate of Higher Education that Muhammad Suseman, Assistant Professor of English, did not report for duty. (F/B).

The undersigned as an Inquiry Officer paid a visit to Govt AKL Postgraduate College Matta Swat and met with the Principal and got a fresh statement from him, about non-compliance of government orders by the accused Muhammad Suleman, Assistant Professor of English, Govt: Degree College Ladha, South Waziristan. (F/C)

The undersigned contacted some professors of the area Ladha to get information about the accused Muhammad Suleman, Assistant Professor of English, and they told that these days Muhammad Suleman used to stay at his native town Swat. GDC Ladha dealing Assistant, named Zahid contact number was taken from a professor of the college and accordingly he was contacted to get information. He informed the undersigned that the accused Muhammad Suleman, Assistant Professor of English, was in Swat. Mr. Addit the college office assistant, told that Muhammad Suleman being incharge Principal came to college off and on to sign official papers especially financial documents. Moreover, the accused Muhammad Suleman was contacted regularly on his contact number 193345328424), but his number remained off.

The Principal of Govt AKI, Postgraduate College Matta Swat vide letter No. 838, dated 29/07/2021 reported o the Director Higher Education that Mr. Muhammad Suleman, Assistant Professor of English was transferred from GDC Ladha, South Waziristan to Govt: AKI, Postgraduate College Matta Swat vide notification no.SO(C-II)/HED/2-5/2021/Transfer/Aps, Dated 23/01/2021 did not report to the college for duty.

FACTS OF THE CASE:

Mr. Mohammad Suleman, Assistant Professor of English was appointed in 1980. His date of birth as per record is 20/04/1963. His domicile is Swat. He was posted in GDC Ladha, South Waziristan back in 1991. He is serving at GDC Ladha, South Waziristan as Principal and DDO.

GDC Ladha has remained a non-functional college since military operation in South Waziristan. The college opened for a short period back in 2016 and then in 2018. The building of the college is under construction. Total number of regular teaching staff is six (6) total number of students is 28.

Mr. Muhammad Suleman's service history is such that he was appointed in 1989 as posted at GDC Haripur. He was transferred to GDC Bajaur in 1990. Later he was transferred to GDC Ladha on 06/08/1991 and is still there.

After a long stay of about 10 years outside his home district Swat. Higher Education Department transferred and posted the accused Muhammad Suleman, Assistant Professor of English, at Govt AKL Postgraduate College Matta Swat vide Notification No. SO(C-II)/HED/2-5/2021/Transfer/AP's Dated 23/01/2021, serial no 71 (F/A).

The Principal of Govt AKL Postgraduate College Matta Swat vide letter No. 838 dated 29/07/2021 reported in Doctorate of Higher Education that Mohammad Suleman, Assistant Professor of English, did not report for duty. (F/B)

The undersigned as an Inquiry Officer paid a visit to Govt. AKL Postgraduate College Matta Swat and met with the Principal and got a fresh statement from him, about non-compliance of government orders by the accused Muhammad Suleman, Assistant Professor of English, Govt. Degree College Ladha, South Waziristan. (F/C)

The Undersigned contacted some professors of the area Ladha to get information about the accused Muhammad Suleman, Assistant Professor of English, and they told that these days Muhammad Suleman used to stay at native town Swat. GDC Ladha dealing Assistant, named Zahid contact number was taken from a professor of the college and accordingly he was contacted to get information. He informed the undersigned that the accused Muhammad Suleman, Assistant Professor of English, was in Swat. Mr. Zahid the college office assistant, told that Muhammad Suleman being incharge Principal came to college off and on to sign official papers especially financial documents. Moreover, the accused Muhammad Suleman was contacted regularly on his contact number (03349328424), but his number remained off.

FINDINGS:

- Keeping in view the above mentioned facts, the undersigned can draw the following
- that the college GDC Ladha, South Waziristan is non-functional since military operation (i) in the area.
- That the accused Muhammad Suleman is on the position of incharge Principal of college. (11)
- That the accused Muhammad Suleman is found of non-compliance of government orders (iii) by not reporting for duty at Govt AKL Postgraduate College Matta Swat even after a tapse of more than six (6) months.
- That GDC Ladha, South Waziristan is a far flung remote area and as the college is nonfanctional so the accused Muhammad Suleman is enjoying service there by doing nothing while staying in his native district Swat.
- Apparently it seems that the accused Muhammad Suleman, Assistant Professor of English, GDC Ladha, South Waziristan have some psychological issues as his appointment date is 1989 but he is still in BPS 18 as he avoids mandatory trainings and hence promotion.
- That the non-compliance of government orders is a serious breach of Khyber Pakhtunkhwa Efficiency and Discipline Rules, 2011 and non-submission of arrival report at new office i.e. Govt AKL Postgraduate College Matta, Swat is tantamount to willfulabsence from duty under section 9 of Khyber Pakhtunkhwa Efficiency and Discipline Raies, 2011.
- After enjoying many years of service in a non-functional college, i.e. GDC Ladha. South (vii) Waziristan, the accused Muhammad Suleman, Assistant Professor of English, is not ready to perform teaching functions in a functional college.

RECOMMENDATIONS:

Keeping in view the facts and findings mentioned above, the undersigned recommends the following:

The accused is involved in a willful absence from duty and is fit to be treated under section 9 of Khyber Pakhtunkhwa Efficiency and Discipline Rules, 2011, but keeping in view of his length of service that is about 32 years and his retirement that is due in 2023. harsh and major punishment may be avoided.

Formal Inquiry against the accused Muhammad Suleman may be instituted to a good minor penalty on him under the clause absence from duty

FINDINGS

Keeping in view the above mentioned facts, the roped can draw the following concussions.

(i) That the college GDC Ladha, South Waziristan is non-functional since military operation in the area.

(ii) That the accused Muhammad Suleman is on the position of incharge. Principal of college.

(iii) That the accused Muhammad Suleman is found of non-compliance of government orders by no reporting for duty at Govt AKL, Postgraduate College Matta Swat even after a lapse of more than six (6) months.

(iv) That GDC Ladha, South Waziristan is a far long remote area and college is non-functional so the accused Muhammad Suleman is enjoying service there by doing nothing while staying in his native district Swat.

(v) Apparently it seems that the accused Muhammad Suleman, Assistant Professor of English GDC Ladha, South Waziristan have some psychological issues and is appointment date is 1989 but he is still in BPS-18 as he avoids mandatory training and hence promotion.

(vi) That the non-compliance of government orders is a serious breach of Khyber Pakhtunkhwa Efficiency and Discipline Rules, 2011 and non-submission of arrival report at new office i.e. Govt AKL. Postgraduate College Matta. Swat is tantamount to willful absence from duty under section 9 of Khyber Pakhtunkhwa Efficiency and Discipline Rules, 2011.

(vii) After enjoying many years of service in a non-functional college i.e. GDC Ladha South Waziristan, the accused Muhammad Suleman, Assistant Professor of English is not ready to perform teaching functions in a functional college.

RECOMMENDATIONS:

Keeping in view the facts and findings mentioned above, the undersigned recommends the following:

- 1. The accused is involved in a willful absence from duty and is fit to be treated under section 9 of Khyber Pakhtunkhwa Efficiency and Discipline Rules, 2011, but keeping in view of his length of service that is about 32 years and his retirement that is due in 2023, harsh and major punishment may be avoided.
- 3. Formal Inquiry against the accused Muhammad Suleman may be instituted to impose minor penalty on him under the clause absence from duty.



INQUIRY REPORT INTO THE EMBEZZLEMENT VIA SALARY ADJUSTMENT

I was appointed a fact finding inquiry officer into the embezzlement of salary of the faculty of the Ladha College, Wana, South Waziristan, through Director of Higher Education letter No 20541, dated 3.7/09/2021, on the above caption. The inquiry was constituted on application of some of the affecters of the embezzlement/scam.

HISTORY OF THE CASE

Three teachers of Ladha College. Wana, South Waziristan, file an appeal to the Director Higher education depit under the caption embezzlement via salary adjustment wherein they claimed they were deprived of Rs. 200000/ each. According to the statement of the affected faculties, in January 2014 arrear of 200000 each were adjusted in the salary's sub-head it 5862-Adj Basic Pay. The Money, according to the faculty member, were transferred to the DCO account but they were kept unaware of the adjustment and did not physically received the amount. They came to know about the misappropriation in March 2020 when the issue was pointed out by Auditor of the SWA agency account office and recommended recovery from them. Deduction was started in March 2020.

Whereabouts of Muhaminad Suleiman, ex-principal and DDO of the college, is not traceable and contact is not possible with him. Meanwhile he was also transferred to Matta college swat, but he has also not join there. The information were shared, in personal chat, by Professor Muhammad Iqbal, associate Professor of Political Science, Government College Peshawar, who has recently conducted inquiry into Suleiman's defaulting on not joining his duty at Matta college Swat.

When the instance of deduction started, the affected staff quickly reacting by appealing to the agency account office to stop deduction from their salary. They also appealed to the director of higher education for sympatric consideration

Method of the inquiry

Ladha College is nonfunctional since military operation in the area. Even most of the teachers affected in the scam were also posted in other college of KP.

First I ger contact number and addressed of all the affected teacher and try to reach them personally but majority of them were posted in different colleges of KP and it was personally difficult for me to them individually.

For the purpose of ascertaining the situation and getting clear picture of the scam is developed a questionnaire. I distributed it among most of the accessbile teacher of the case. The teacher who submitted the questionnaire are.

I also contacted Zahid Ullah the concerned clerk who was responsible for the handling the college account. I directed him to provide college record and Bank account state of the period from July 2013 to June 2014, but he was making excuses from providing the record.

Talso contacted Mr. Alchar Ali Khan, the incumbent incharge Principal, and urged him to pressurize Mr. Zahid Ullah for provision of the record but Zahid Ullah was making delaying tactics. At last, last night on 11/13/2021, he provided an official letter on Principal's behalf, signed by him, there a he acknowledged crediting of some unusual amount to the account in January 2034.

of Principal without his prior knowledge. Actually I asked Mr. Zahid Ullah to submit his own statement but he submitted on behalf of Principal of the college. It is another violation or rules on part of Mr. Zahid.

Conclusion

After perusing all the nietries and evidence, I have reached a conclusion that the then Principal Tarm DDO Mr. Muhammad Suleiman and Mr. Zahid Ullah, the incumbent clerk, are solely responsible for the emberzhment. Mr. Suleiman is responsible because of negligence of exercising overlook and check on the account matters and left it at the disposal of Mr. Zahid Ullah.
