# JOINT PARA WISE COMMENTS ON BEHALF OF RESPONDENT NO.1 AND 2 RESPECTFULLY SHEWITH:

#### PRELIMINARY OBJECTIONS

- 1. That the appellant has got no locus standi.
- 2. That the appellant has concealed material facts from this honorable court in the instant appeal.
- 3. That the instant appeal is based on mala fide intentions.
- 4. That the appellant wants to put extra pressure on the respondents to grind her own axe.
- 5. That the appeal is barred by law.

#### On Facts:

- A. Pertains to record
- B. Pertains to record
- C. Denied: The appellant never remained dutiful in performance of her duty and she has been reported absent multiple times by District Monitoring Authority. Furthermore, the deplorable performance of the appellant can also be gauged from the letter of the Assistant Commissioner Chagharzi upon her visit to the school. (attached annexure A & B)
- **D.** Denied: The appellant had been appointed on the post of PST and she was bound to perform her duty at GGPS Ajlai being a government employee of Education Department.
- E. Denied: The respondents have not received gazillions of applications from the appellant.
  - F. Agreed upto the extent of issuing the transfer order in respect of the appellant.
- G. Denied: The transfer order issued in respect of the appellant was cancelled because the appellant was the only serving teacher at GGPS Ajlai. Upon her transfer, the school got closed and the teaching learning process was badly effected; consequently the precious time of the students got wasted. Moreover, transfer of a teacher from



single school teacher is against the policy of rationalization. There shall be minimum of two teachers in primary school. (attached annexure C)

- H. Denied: Being government officials, the respondents perform their duty according to the relevant rules, policy and in the best interest of the public rather than serving individuals.
- I. Denied: The departmental appeal was rejected and the appellant had been directed to report back to her original station i.e GGPS Ajlai. Even an enquiry has also been initiated against the appellant for remaining absent and defying the orders of high ups but could not be proceeded further because the court has suspended the operation of cancellation order to the extent of appellant in their order sheet dated: 22-07-2024. (attached annexure D)
- J. Denied: The cancellation order issued is according to the rules and keeping in view the best interest of public; hence this appeal is liable to be set aside.

#### **GROUNDS**

- 1. Incorrect: That the cancellation order is right, legal, lawful and in the best interest of public.
- 2. Incorrect: That the cancellation order has been issued according to the rules.
- 3. Incorrect: That the cancellation order has been issued according to the relevant rules and policy.
- 4. Incorrect: As explained in previous paras that transfer from single teacher school is against the policy as well as against the interest of public. The school is in need of one other teacher under the rationalization policy and will be provided soon as there should be minimum of two teachers in a primary school.
- 5. Incorrect: That the cancellation order is totally lawful and legal.
- 6. Denied: It is not mentioned anywhere in any policy that individuals may be facilitated at the cost of public interest. Moreover, the transfer order had not been issued under the spouse policy.
- 7. Denied: The appellant is performing her duty at GGPS Gumbat at her own whim and wishes. When the transfer order got cancelled, the appellant was bound to report back to her previous station. The stubbornness on behalf of appellant clearly depicts her carelessness, irresponsibility towards her job by openly defying the orders of high ups.
- 8. Denied: As explained in previous paras that the respondents are performing their duty according to the rules and policy. The interest of community as well as students could not be violated just because the appellant wish to be transfer to her nearest station.
- 9. Denied: The discretionary power vested to respondent are totally logical, lawful and keeping in view the interest of the public.
- 10. That any other grounds not raised here may graciously be allowed to be advanced at the time of arguments

#### PRAYER:

In the light of above mentioned reasons it is humbly stated that the appeal may be kindly dismissed in favor of the respondents. Moreover, the order issued by this honorable court regarding the suspension of cancellation order may be immediately withdrawn in the best interest of public and community.

Kindly refer to the subject noted above and to state that the undersigned paid a visit to GGPS Ajlai at 10:45 A.M on 26-03-2024. During inspection the School was found closed and the staff were found absent. Ironically, the staff has marked proxy attendance in the attendance register in advance until March 30th (Picture enclosed).

Furthermore, the locals were asked on the attendance of the teaching staff. They informed the undersigned that the teaching staff attend the school once amonth. The locals also revealed that due to non availability of teaching staff, the enrolled students of the subject school attend nearby other schools for curriculum activities.

Moreover, the first aid items in the school were found expired. There was no proper maintenance of the first aid items. (Picture enclosed). Besides, no proper record of PTC Fund and its utilization was available till date. No proper connection of water pipe line to water Tank.

In cognizance of the above irregularities/misconduct, it is, therefore, requested to your good office to direct the DEO(F) and DMO(EMA) to initiate strict legal action against the delinquent staff of the said school under E&D Rules and to submit their respective report/position, please

4. No leacher of CT B-16, PET B-16, AT B-16, DM B-16, TT-16, will be posted in

Middle Schools.

- 5. Senior most Senior CI and SST (According to the Seniority list) may be retained in the schools of their present posting and junior most may be transferred to other schools.
- 6. Disable teacher may be retained in the schools of their present posting; another teacher may be shifted instead of disable.


