Respectfully Sheweth:

Preliminary Objections:

- i. That the applicant lacks the cause of action and locus standi to file this appeal.
- ii. That the applicant estopped by her own conduct to file the Appeal.
- iii. That the appeal is not competent due to non joinder and mis-joinder of the party.

iv. That the appeal is not within time.

- v. That the departmental appeal is not competently filed within the meaning of KP Civil Servant (Appeal) Rule 1986.
- vi. That the answering respondent on promotion was posted in G.G.H.S.S Havelian Abbottabad against the post having become vacant due to consequent posting / transfer in channel.
- vii. That the answering respondent is entitled under the facts and law and policy of government to retain her posting in the existing school i.e. G.G.H.S.S Havelian District Abbottabad.
- viii. That the appeal being frivolous and liable to be dismissed with cost.

REPLY ON FACTS

- 1. Para No. 1 of the appeal needs no reply being personal to the appellant.
- 2. Para No. 2 needs no comments.
- 3. In reply to Para No. 3, it is submitted that the posting of the appellant and answering respondent, no doubt, was made vide order dated 19.02.2024 in the same school but the posting of answering respondent as per

remarks at Sr. No. 23 in order dated 19.02.2024 was made against the post which was vacated in consequential transfer made at Sr. No. 207 of the said order as the transferree Miss Dur-e-Shawar (S.S) was holding the wrong posting against the post of BPS-18. In the same order dated 19.02.2024, the posting of the appellant was made against vacant post of S.S. Economics BPS-18 as evident from the remarks at Sr. No. 167 of the order date 19.02.2024. Believably there was no vacant post of S.S (Economics) BPS-18 in G.G.H.S.S, Havelian at the time of posting of the appellant. In view of the given clarification, the appellant has got no cause of action to challenge the posting of the answering respondent under the facts and law.

- 4. Para No. 4 is relating to the official respondents, hence needs no comments.
- 5. The averments as to submitting of any application by the appellant is not within knowledge of the answering respondent, therefore, the said para is not admitted as correct.
- 6. Para No. 6 is not correct. Even otherwise, the said para as laid has got no effect on posting of the answering respondent in GGHSS Havelian.

- 7. Para No. 7 is absolutely wrong and denied.
- 8. Para No. 8 as laid is not correct and denied.
- 9. Para No. 9 having no concern with the answering respondent, needs no comments.
- 10. Para No. 10 is denied for want of proof.
- 11. Para No. 11 needs no comments.
- 12. In reply to Para No. 12, it is submitted that the appellant has got no cause of action and locus standi to file the instant appeal, hence denied.

Reply on grounds:

I.

- A to G: Ground A to G having no legal and factual foundation are not workable, hence denied.
 - Ground H as laid is misleading and in even in view of reply on the facts, the same is not workable in favour of the appellant.

The appellant has got no justifiable case on the basis of given facts and grounds and believably, she will not be able to advanced any material

ground during arguments, however, if advance and permitted by this Hon'ble Tribunal, the answering respondent reserves a right to respond the same be fittingly.

It is, respectfully prayed that the appeal filed by the appellant may kindly be dismissed with cost.


