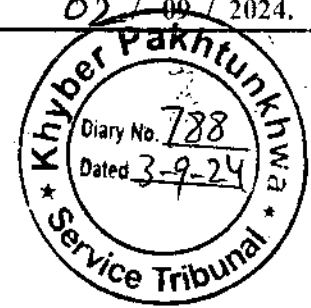

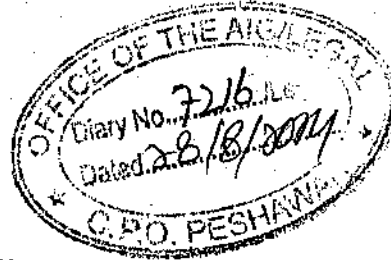

NOTIFICATION

No. CPO/E-II/Retirement/ 299, In compliance of the judgment dated 05.10.2019 of the Supreme Court of Pakistan, wherein Mr. Jan Bahadar ASI was de-inducted and placed on deputation in NH&MP till the process of repatriation to his parent department is completed vide Notification dated 26.05.2019.

And wherein, the light of notification dated 17.03.2020 he was repatriated from NH&MP to his parent department in substantive rank, pay and allowances with immediate effect and it was clearly mentioned that the officer repatriated to his parent department shall be entitled to salaries and other benefits from the date he relieved to join his parent department. His seniority shall be maintained in his parent department with his batch mates as if he was never relieved from his parent department. Expiry of period lien shall not come in the way of officer to deprive him from joining the parent department.

The officer aggrieved, filed Service Appeal No. 14056/2020 before the Khyber Pakhtunkhwa Service Tribunal and the Service Tribunal vide judgment dated 12.01.2022 accepted the appeal in the following terms which is re-produced below: -

"In view of the foregoing discussion, the instant appeal is accepted as prayed for and the appellant is held entitled to his seniority/promotion as well as consequential benefits at par with his batch-mates namely Pir Shahab Ali Shah and Riaz Ahmad and on the analogy set by IGP Punjab and Islamabad".

An Order dated 21.10.2022 delivered by the Hon'ble Khyber Pakhtunkhwa Service Tribunal Peshawar in service appeal (ibid) and the operative parts reproduced below: -

"Whereas, representative of the respondents is presenting implementation report has not been submitted, therefore, salaries of the respondents are attached. The Accountant General Khyber Pakhtunkhwa and Account Officer, Mardan/Charsadda are directed to attach salaries of the respondents till the implementation of the judgment of this Tribunal. Respondents are also directed to submit implementation report on 22.11.2022"

After perusal of the record and from the appointment order it has been revealed that his colleagues namely Shahid Ahmad, Nowsher Khan and Riaz Ahmad etc. have been promoted to their higher ranks of "Superintendent of Police" and "Deputy Superintendent of Police, in their service tenure:
