

PRAYER:

That on acceptance of this appeal the act & omission on the part of respondent by issuing impugned seniority list dated 20/02/2024 by disturbing the seniority of the appellant may very kindly be declare as illegal, unlawful, void abi initio, unwarranted upon the rights of the appellant & unconstitutional. That the respondent may further please be directed to correct the seniority by placing the appellant at his right placed according to the initial appointment order & seniority rules and promotion may be granted while following the PRINCIPLE OF PARITY. Any other remedy which this Tribunal deems appropriate and has not specifically been asked for that may also be awarded in favor of the appellant.

Respectfully Sheweth;

FACTS:

Brief facts giving raise to the instant appeal are as under:

1. That appellant is a regular employee of the respondent Department and was initially appointed as Nursing Attendant (BPS-05) after fulfilling all the legal & codal formalities required for the post vide appointment order dated 30-06-1992 and presently serving as Clinical Technician (Pharmacy) (BPS-12) after serving for about 32 Years in Health Department.

Copy of Appointment Order dated 30.06.1992 is attached as ANNEXURE A.

2. That in the year 2006 the Government of NWFP now Khyber Pakhtunkhwa Health Department an Eight stages paramedics service structure w.e.f. 27-12-2005 vide notification no. SOH-III/8-60/05 (paramedics) dated Peshawar the 10th May, 2006 wherein all the paramedics working in Khyber Pakhtunkhwa was integrated/categorized and re-nomenclature and accordingly the appellant was also categorized and a nomenclature of CT (Pharmacy)(BPS-09) was given including proper place in seniority from the date of initial appointment.

Copy of Notification dated 10.05.2006 is attached as ANNEXURE B.

3. That after issuance of the notification No. SOH-III/8-60/05 (paramedics) dated Peshawar the 10th May, 2006 whenever the respondent circulated seniority for the category of CT (Pharmacy) the appellant was placed at the right position in the seniority list till when final seniority was circulated vide dated 15-08-2023 the appellant was at serial no. 241 and was in the promotion zone to the next higher scale of BPS-14.

Copy of Final Seniority List dated 15.08.2023 is attached as ANNEXURE C.

4. That just after a lapse of about 06 months an unexpected impugned seniority dated 20/02/2024 was circulated with the subject Final/revised seniority at late night without issuing prior any tentative or provisional seniority list so as to deprive the employee of the seniority from making any objection and as such appellant along with similarly placed other colleagues were dropped excluding three of our

colleagues whom are given promotion to the next higher scale of BPS-14.

Copy of Impugned Seniority List dated 20.02.2024 is attached as ANNEXURE D.

5. That it is pertinent to mention here that respondent circulated the impugned seniority list dated 20.02.2024 at late night on the respective date and on the very next day i.e 21/02/2024 the respondent convened Departmental Promotion Committee (DPC) and promoted as many as 401 CT (Pharmacy) (BPS-12) to the next high scale of (BPS-14) with malafide intension and just to deprive the appellant from promotion.

Copy of Working Paper & Minutes of the Meeting is attached as Annexure E.

6. That feeling aggrieved from the acts & omission of the respondent by dislocating the appellant from his original Seniority List as stood on 15/08/2023 as well as dropping the appellant from promotion zone, the appellant filed Departmental Appeal dated 19/03/2024 before the respondent which was regretted on no good ground vide appellate order dated 03/06/2024.

Copy of Departmental Appeal dated 19.03.2024 & Appellate Letter dated 03.06.2024 is attached as ANNEXURE F.

7. That the appellant feeling highly aggrieved and is left with no other remedy but to file the instant service appeal before this Tribunal on the following grounds:

G R O U N D S:

- A- That act & omission on the part of the respondents by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is against the law, rules, facts, void ab initio, Norms of Natural Justice and materials available on the record hence not tenable in the eye of Law and is liable to be set aside to the extent of the appellant.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondent acted in an arbitrary and malafide manner by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right

of promotion to the next higher grade of BPS-14 as the other 03 similar placed colleagues have been given promotion in the DPC conducted on 21-02-2024.

- D- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is against Article 38 (e) of the Constitution of Pakistan, 1973 which is as:

“state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of Pakistan.

- E- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is a clear violation of Article-37 of the Constitution of Islamic Republic of Pakistan which is regarding the eradication of social evils in the society and promotion of social justice.
- F- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is a clear violation of the Fundamental Rights as enshrines the Constitution of Pakistan & also against various judgments passed by the Apex Supreme Court of Pakistan.
- G- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 hence the same is against the norm of Natural Justice.
- H- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is against the doctrine of Merger that while making merging of all paramedics in the eight tier formula vide notification of 2006 the appellant was placed at the right position of his seniority but was disturbed after 18 years of serving in the eight tier formula but

was malafidely disturbed from his original position in the impugned seniority list of 2024.

- I- That it is a matter of fact that the appellant has already got a particular position in the previous seniority list as stood on 15-08-2023 and backward, however, the respondent without any notice to the appellant changed the seniority position by relegating from Serial No. 241 as the seniority of the appellant was already determined and kept intact in the seniority list issued from time to time, issuing of the seniority list 15-08-2023 and whereafter impugned seniority 20-02-2024 without any objection from any official listed in the seniority list, therefore, the appellant only seeks for correction of his seniority position for being it at right place as stood on the list dated 15-08-2023, hence, necessary party in this appeal are respondent no. whom is given promotion in my place.
- J- That, act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is against Section-08 of the Civil Servant Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules, 1989, hence proprietary demand that the seniority of the appellant be correct.
- K- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14 is nothing but just to harass the appellant and to benefit his blue eyed persons.
- L- That act & omission on the part of the respondent by disturbing the appellant's seniority in the impugned seniority list dated 20-02-2024 just to deprive the appellant from its right of promotion to the next higher grade of BPS-14, the appellant has been punished for no fault on the part of the appellant as such the appellant has been punished for the fault of public functionaries.
- M- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

NOTIFICATION

NO SOH-III /8-60/05 (paramedics), In pursuance of the decision taken by the provincial cabinet in its meeting held on 27th December 2005, the Competent Authority is pleased to approve eight stage paramedics services structure of NWFP with effect from 27-12-2005. The salient features whereof shall be as under:-

1. The existing 57 different categories of paramedics as mentioned in annexure A to this notification are restructured into 14 cadres as per annexure B.
2. In all the aforesaid cadres/specialties, the posts in various pay scales shall be integrated/categorized and re-nomenclatured as under:-

S.No.	Existing Posts	Re-structured posts
i)	Posts in BPS-5 to BPS-9 in all specialties.	Junior Technicians (BPS-9)
ii)	Posts in BPS-10 to BPS-12 in all specialties.	Technicians (BPS-12)
iii)	Posts in BPS-13 to BPS-14 in all specialties.	Senior Technicians (BPS-14)
iv)	Posts in BPS-15 to BPS-16 in all specialties.	Chief Technicians (BPS-16)
v)	Posts in BPS-17 in all specialties.	Technologist (BPS-17)
vi)	Posts in BPS-18 in all specialties.	Senior Technologist (BPS-18)
vii)	Posts in BPS-19 in all specialties.	Chief Technologist (BPS-19)
viii)	Posts in BPS-20 in all specialties.	Principal Technologists (BPS-20)

The words "clinical" shall be mentioned with the categories of posts meant for paramedics working in the hospitals and "Primary Health Care" with the paramedics working in the field along with mention of specific specialty (e.g. Junior Clinical Technician (Radiology) and Junior Primary Health Care Technician (Multi purpose)).

3. The number of Posts in BPS-20, BPS-19, BPS-18, BPS-17, BPS-16, BPS-14, BPS-12 and BPS-9 shall be according to the proportionate ratio based on the total 8965 posts as mentioned in the provincial budget book for financial year 2005-2006. The proportionate ratio of 8 stage formula shall be as under:-

However additional posts shall be created for any of the left over personals of paramedics cadre (if any). Moreover, subsequent creation of posts in any of the 14 paramedics cadres in any scale shall also be included in the aforesaid proportionate ratio of posts in the 8 tiers formula. The proportionate ratios of posts in BPS-12 and above shall be modified accordingly as and when new creation of posts are made in BPS-9 in each of the 14 cadres subsequently.

4. Seniority of the incumbents of the posts in the 14 cadres so merged shall be caused on the basis of scale wise seniority as well as date of regular appointment in the pay scale. (e.g. In joint seniority list of BPS-12, the official already in BPS-12 will be placed on the top of the list and the officials in the lower pay scale shall be accordingly placed step by step in the list, invariably keeping intact the inter-Se-seniority of the incumbents in the same pay scales).
5. In the first instance, the higher posts in the re-structured 14 paramedics cadres as per annexure "C" shall be filled in by way of promotion, as one time exercise, where-after the service rules duly prescribed as at annexure D shall be followed in subsequent promotion/ initial recruitment.
6. Promotions in the post in BPS-18, 19 and BPS 20 shall be made on the basis of joint seniority list. The Joint seniority list of all the 14 cadres shall be caused at BPS-17 level keeping in view the principles laid down in section 8 of the NWFP civil servants (ACT), 1973 read with Rule-17 of the NWFP civil servants (appointment, promotion and transfer) rules, 1989.
7. The afore-said paramedics service structure into 14 cadres shall also be applicable mutatis-mutandis to the paramedics working in FATA and employees working in Districts, all autonomous, semi autonomous and corporate bodies.
8. There shall be a council of paramedics to be notified separately.
9. The approved implementation committee and anomaly committee shall also be notified separately.
10. This eight stage paramedics service structure will replace all existing categories, cadres, structures and nomenclatures and will cancel all such cadres /categories rules and regulations etc which are in contravention to the approved paramedics service structure. New posts in all type of Health Delivery System will be created in





The Committee decided that the officials who are conditionally recommended for promoted should submit their PERs/NOCs within one month (30-days) of the issuance of the Minutes, failing which they will be considered differed from promotion.

R/Sir,

Most respectfully it is stated that:

1. I was appointed as Nursing Assistant (BPS-05) after fulfilling all the codal & legal formalities required formalities required for the post and since then I am performing my duties with full devotion in Health Department.

(Appointment Order is attached)

2. In the year 2006 the Government of Khyber Pakhtukhwan (NWFP) at that time has introduced and promulgated an Eight Stages Paramedics Service of NWFP vide notification NO. SOH-III/8-60/05 (Paramedics) dated 10-05-2006 where an Eight Tier formula has been introduced and merged all the paramedics.

(Notification dated 16-05-2006 is attached)

3. In light of the said notification I along with other of my colleague appointed with me on the same day were assigned seniority as JCT (Pharmacy) (BPS-09) on the basis of our regular initial appointments.

4. In every seniority that has been circulated from your good office I am been placed at correct place according to my initial appointment and once in a seniority list when my seniority position was disturbed the same was corrected in light of the relevant rules.

5. A final seniority list was circulated for Clinical Technician (BPS-12) vide letter dated 15/08/2023 wherein I have been placed at correct place in the seniority List at serial no. 241 as it was according to the prevailing rule hence I along with my other colleagues did not challenge it.

6. Now after a lapse of about 06 months another final seniority list was issued and published on the website at late hours on 20-02-2024 and on the very next day Departmental Selection Committee was conducted malafidely on the reason that the same shall not be challenged by someone.

(Impugned Seniority List dated 20/02/2024 is attached)

7. In the seniority list issued on 15-08-2023 we were placed at correct place according to the date of our initial appointment but in the impugned seniority list issued on 20-02-2024 I am placed at serial No. 1250, and in the column of remarks it is mentioned that I have mistakenly been placed in at Serial No. 1250 and such act on the part of the department is void ab initio.

8. The impugned seniority list has not been issued according to the provision of seniority as enshrined in Civil Servant Act 1973 as well as APT (Rules), 1989 and needs to be corrected accordingly so that I may also be given promotion on the basis of the corrected seniority as was issued on 15/08/2023.

9. In the impugned seniority list dated 20/02/2024 I am dislocated and has been placed at serial No. 1250 with chalking in only BPS-09 and has quashed all my previous service since from the date of initial appointment till promulgation of the notification dated 16/05/2006.

10. In the impugned seniority most of the technicians are either retired from service and some have died and even then their names are included in the seniority which also affects my position of seniority and needs to be corrected accordingly.

11. Three of my colleagues who were on the same footings with that of me and have been appointed with me have not been dislocated, remained on their actual position and their cases were not only placed in the DPC but were also given promotion to the next higher grade but I am placed out from promotion zone, hence by following the principle of consistency my name should be placed at the position of seniority shown in seniority list issued on 15/08/2023.

12. In the impugned seniority list dated 20/02/2024 I have been punished for the fault of public functionaries and have been placed not only beyond the promotion zone but also the seniority has been disturbed and as per verdicts passed by the judiciary in the subject matter no should be penalized for public functionaries.

In view of the above observation, it is, therefore, most kindly requested that seniority may be corrected and refixed in light of Section-8 of the Civil Servant Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules, 1989 and I may be located at right place instead of the incorrect position shown in the impugned seniority list dated 20/02/2024.


