


Appellant submitted that she, being senior on the seniority list of the PST (BPS-12), was entitled to be promoted to the post of PST(BPS-15), especially when the vacancy was available. original or appellate order from which the appellant was aggrieved, she referred to her applications made to the Secretary/Director Education, Khyber Pakhtunkhwa, wherein she had herself offered for the desired promotion and had stated at the bar that since she was senior, so she ought to have been considered for the promotion.
