APPEALS UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974

CONSOLIDATED JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: Through this single judgment, all the above 10 appeals, are jointly taken up as all are similar in nature and almost with the same contentions, therefore, can be conveniently decided together. The appellants' cases in brief are that they are serving in 2. the Health Department in different districts of Hazara Division. The issue revolves around the employment status and pay scale of Radiographers and X-Ray Technicians in Khyber Pakhtunkhwa. Initially, these posts were classified in BPS-06 under Service Rules 1978. Despite upgrades in various health department cadres in 1983, the Radiology Department was overlooked. In 1988, the Government of Pakistan revised the national pay scale, elevating the positions of X-Ray Technicians and Radiographers to BPS-09, with some eligible for selection grade (BPS-11). However, discrepancies arose as some X-Ray Technicians were appointed in BPS-09 while Radiographers remained in BPS-06, despite having similar qualifications and job roles. Subsequent government notifications aimed to address seniority issues, merging the positions into Junior Clinical Technicians in BPS-09, but this led to Radiographers,

appointed earlier, being ranked lower than later appointees.

Numerous appeals and court interventions, including a 2012 directive for seniority rectification, have yet to yield a resolution. The ongoing litigation and administrative inquiries reflect persistent grievances regarding pay, seniority, and equitable treatment of Radiographers and X-Ray Technicians in the health department. The issue in hand was initially impugned before the departmental authorities but the representations were dismissed and then the appellants approached the Hon'ble Peshawar High Court, Abbottabad, Bench and the Hon'ble Peshawar High Court transmitted those to this Tribunal, hence, the instant appeals. 3. On receipt of the appeals and their admission to full hearing, the respondents were summoned, who put appearance and contested the appeals by filing written replies raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellants.

 We have heard learned counsel for the appellants and learned District Attorney for the respondents.

5. The learned counsel for the appellants reiterated the facts and grounds detailed in the memo and grounds of the appeals while the learned District Attorney controverted the same by supporting the impugned order(s).

6. Through the instant service appeals the appellants seek benefit of Notification dated 07.11.1988. There are letters of

the Finance Department dated 07.04.2022 and the regret letter of the Secretary Health Department.

The above letters of the Finance Department as well as 7. the Health Department, have categorically stated that the policy issued vide Notification dated 07.11.1988 was not Government of Khyber adopted by the Provincial Pakhtunkhwa. Therefore, the appellants could not get benefit of the same. Besides, the letters were issued and admittedly, the seniority lists were circulated from time to time but none of the seniority list was admittedly challenged by the appellants, rather there is a joint representation of the appellants, found placed on file, moved on 24.09.2020. The departmental representation is hopelessly barred by time. There is no application for condonation of delay moved by the appellants before the departmental authorities. Besides, the joint representation is not maintainable under Rule-3(2) of the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1986. The same is reproduced as under:

> "(2) Where the order of the competent authority affects more than one civil servant, every affected civil servant shall prefer the appeal separately."

8. For the reasons mentioned above, the appeals are dismissed with costs, due to the lack of adherence to procedural timelines and the failure to establish a legal basis
