

NOTIFITICATION

- WHEREAS, in pursuance the recommendations of the Inquiry Committee constituted by the erstwhile Directorate of Education (FATA) Peshawar vide notification no. 8154-63 dated 04-08-2016, the appointment orders of 40 SSTs (35 Male & 15 Female) have been disowned vide dated 4 & 5 April, 2019, being declared as fake and bogus.
- ii. AND WHERAS, the aggrieved Ex SSTs filed the services appeals before the Honorable Khyber Pakhtunkhwa, Service Tribunal Peshawar during the Month of August, 2019.
- iii. AND WHERAS, the judgment vide dated 20-01-2021 of the honorable Service Tribunal Peshawar rendered in service appeal# 1014/2019, Titled Mst. Ishrat W/O Sher Afghan Khan Ex SST (G), R/O Village Fazal Abad Tehsil Takht Bhai District Mardan. The operation part of the Judgment is as under:

"In view of situation, the impugned orders stand set aside and the appellants are reinstated in service with direction to the Department to conduct proper inquiry. They shall investigate the issue through a proper inquiry reaching to a logical conclusion to find out the real culprits, who maneuvered to make it possible and thereafter, fate of appellants be decided in the light of the said inquiry. The respondents shall conclude the proceedings within 90 days after receipt of this judgment. The issue of back benefits shall be subject to the outcome of inquiry"

- iv. AND WHEREAS, in the light of the judgment of the honorable Service Tribunal Peshawar, the Director, E&SE Khyber Pakhtunkhwa, being Competent Authority, conducted De-NOVE Inquiry vide notification no. 1911-16 dated 08-02-2021.
- v. AND WHEREAS, the report of the inquiry committee declared the requisite 40 Ex SSTs (already disowned) as fake and bogus including more 12 SSTs i.e. Mst. Zubaida Begum Ex SST and 11 others SSTs (M&F) with the recommendations that their appointment orders as SSTs may also be disowned being fake and bogus.
- vi. AND WHEREAS, in pursuance the recommendations of inquiry committee, the Director E&SE Khyber Pakhtunkhwa, Peshawar disowned the appointment orders of Mst. Zubaida Begum SST & 11 others vide notifications issued in June & July, 2021.
- vii. AND WHEREAS, Mst. Zubiada Begum Ex SST & 06 others filed services appeals No. 7548-51/201, No. 7563-64/2021 & No. 7667/2021, before the honorable Khyber Pakhtunkhwa Service Tribunal Peshawar during, 2021.
- viii. AND WHEREAS, the honorable Khyber Pakhtunkhwa Service Tribunal Peshawar judgment dated 04-03-2024, rendered in service appeal# 7667/2021, titled Mst. Zubaida Begum Ex SST (BS-16) GGMS Kuta Trap, District Mohmand. The operation part of the judgment is as under:

"As a sequel to the discussion, we set aside the impugned notifications and reinstate the appellants for the purpose of de-novo inquiry and remand the case back to the respondents to conduct de-novo inquiry within a period of sixty days, by providing proper opportunity of selfdefense and cross examination. The issue of back benefits shall be decided subject to the outcome of de-novo inquiry".

ix. AND WHERAS, in pursuance the judgment of the honorable Khyber Pakhtunkhwa, Service Tribunal vide dated 04-03-2024, the Director E&SE Khyber Pakhtunkhwa, reinstated Mst. Zubaida Begum Ex SST & 06 others into their services only for the purpose of DE-NOVO inquiry vide notification no. 6859-66 dated 31-05-2024, and subsequently, constituted the inquiry committee vide notification issued under endorsement no. 6851-58 dated 31-05-2024.

- x. AND WHEREAS, the inquiry committee submitted its report vide no. 1099 dated 21-08-2024 with the recommendations that the Disowned Orders issued by Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar in 2021 in respect of Mst. Zubaida Begum Ex SST & o6 others (Service Appeals No. 7548-51/021, 7663-64/2021 & 7667/2021) may be retained.
- **xi.** NOW THEREFORE, in the light of above mentioned facts and subsequent recommendations of the inquiry committee report, the disowned Notifications issued vide Endst. No. 10325-30 dated 25-06-2021, No. 9558-64 dated 11-06-2021, No. 10348-54 dated 25-06-2021, No. 10306-11 dated 25-06-2021, No. 9565-71 dated 11-06-2021, No. 10320-24 dated 25-06-2021 & No. 9554-57 dated 11-06-2021 in respect of Mt. Zubaida Begum Ex-SST of District Mohmand and 06 other are hereby retained/intact.
