



**Service Appeal under section 4 of the Khyber  
Pakhtunkhwa Service Tribunal Act, 1974**

**Respectfully Sheweth,**

The appellant submits as follows:

1. That the appellant is a bonafide resident of village Marhatti Banda, Union Council Misri Banda, District Nowshera.
2. That the respondent Department advertised few posts of Primary School Teachers (Male) in District Nowshera. The applicant being eligible applied for the same, appeared in the test and interview wherein the appellant obtained total 81.63 marks. But due to less marks/low in merit the appellant was not appointed in his own union council i.e., Union Council Misri Banda. (Copy of Advertisement if annexed herewith as **Annex-A**)
3. That Union Council Misri Banda and Union Council Zara Miana are situated in District Nowshera and are adjacent to each other. Total eleven posts of male Primary School Teachers were lying vacant in schools situated in the Union Council Zara Miana. Out of the said 11 posts, only 05 posts were filled initially whereas the remaining 06 posts were left vacant because of lack of eligible candidate in Union Council Zara Miana.
4. That as per advertisement and under section 3 of Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011, the respondents were under obligation to fill the posts of male Primary School Teachers lying vacant in schools of Union Council Zara Miana due to lack of eligible candidates, from the candidates belonging to adjacent Union Council.
5. That as mentioned above that Union Council Misri Banda and Union Council Zara Miana both are situated in District Nowshera and are adjacent to each other, the appellant belonging to Union Council Misri Banda, was under legitimate expectancy to be appointed

against the vacant posts of male Primary School Teachers, in Union Council Zara Miana, Tehsil and District Nowshera but in vain. The respondents issued appointment order dated 10-10-2017 whereby candidates were appointed against the left over posts/in adjacent Union Council due to the non-availability of bona fide candidate of the concerned Union Council against the post of P.S.T (BPS-12) by ignoring the appellant, the appellant approached the respondents for redress of his grievance but in vain. (Copy of appointment order dated 10-10-2017 is hereby annexed as **Annex-B**)

6. That thereafter the appellant filed the title Writ Petition No 4189-P/2017 before the Honorable Peshawar High Court, Peshawar. The said Writ Petition was dismissed by this Honorable Court vide Judgment dated 12-06-2019. (Copy of the Judgment is annexed herewith as **Annex-C**)
7. That feeling aggrieved of the aforesaid judgment, the appellant filed Review Petition No 136-P/2019 before the Peshawar High Court, Peshawar which was disposed of vide judgment dated 16-02-2023. (Copy of judgment is annexed herewith as **Annex-D**)
8. That in pursuance of the aforesaid judgment, the appellant is appointed as P.S.T vide appointment order dated 12-07-2023 with immediate effect. It is pertinent to mention here that the colleagues of the appellant who had applied along with him in pursuance of the aforesaid advertisement are appointed vide appointment order dated 10-10-2017 with effect from date of their taking over charge on adhoc basis on contract and later on regularized vide Notification dated 19-03-2018 with effect from their taking over charge. (Copy of the appointment order of appellant and regularization order of the colleagues of appellant is annexed herewith as **Annex-E & F**)
9. That feeling aggrieved of the aforesaid appointment order, the appellant filed Departmental Appeal which has not been decided yet. (Copy of the Departmental Appeal is annexed herewith as **Annex-G**)

Hence, the instant Service Appeal on the following amongst other grounds:

**Grounds:**

- a. That the impugned appointment Order dated 12-07-2023 to the extent of appointment of appellant with immediate effect is against the law, illegal, unlawful, without lawful authority and void ab-initio, thus liable to be set aside.
- b. That the treatment met to the Appellant is against the fundamental rights enshrined and protected under the Constitution of Islamic Republic of Pakistan, against the law, rules and policy on the subject matter which is their inalienable right under Article 4 of the Constitution of Islamic Republic of Pakistan, 1973.
- c. That the Appellant has been appointed against the post of P.S.T (BPS-12) vide appointment order dated 10-07-2023 with immediate effect from taking over the charge of the post on adhoc/contract basis, whereas similarly placed colleagues of the Appellant who had applied in pursuance of the same advertisement along with the Appellant and competed with him had been appointed vide Notification dated 10-10-2017 on adhoc basis on contract and later on regularized vide Notification dated 19-03-2018, thus the Appellant has been deprived from his vested rights without any fault on his part.

- d. That treatment met to the Appellant is against the KP Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 and dictums of the apex courts and this Honorable Tribunal.
- e. That it is a settled principle of law that any employee illegally deprived from appointment, filed Writ Petition and High Court accepted the same while issuing direction to the competent authority to recommend/appoint the employee, such civil servant will be given seniority and service benefits from the date when the group along whom he/she qualified the test and interview was appointed. In this regard reliance is placed on 2018 PLC (CS) 482 (SC (AJ & K))
- f. That the Appellant crave permission of this Honorable Tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of his Service Appeal.


It is, therefore, prayed that on acceptance of the title Service Appeal:

- a. the impugned Office Order dated 12-07--2023 may kindly to the extent of appointment of the appellant against the post of P.S.T (BPS-12) with immediate effect from date of taking over charge be declared as against the law, illegal, unlawful and ineffective upon the rights of the appellant; and
- b. direct the respondents to issue the appointment order of the appellant to the post of P.S.T (BPS-12) with effect from 10-10-2017 with all back benefits; and
- c. the respondents may be directed to treat the appellant at par with his similarly placed colleagues who are appointed vide Office Order dated 10-10-2017; and
- d. any other relief, which has not been specifically prayed for and deemed fit and appropriate by this Honorable Tribunal in the circumstances of the title Service Appeal may graciously be granted.

4. That the applicant begs leave of this Honorable Tribunal to rely on additional grounds and produce any other additional document in support of the instant application.


It is, therefore, prayed that on acceptance of the instant application the delay in filing the title Service Appeal may kindly be condoned.

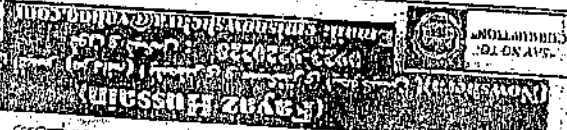

**TERMS & CONDITIONS**

1. Appointment is purely on temporary & contract basis initially for one year w.e.f.10-10-2017 to 09-10-2018.

6. They should not be handed over charge if exceed, 35 years or below 18 years of age. Age relaxation case may be submitted to competent authority.
7. Appointment is subject to the condition that the certificate/documents must be verified from the concerned authorities by the DEO (M) Nowshera, and if anyone found to have produced bogus Certificates/Degrees/Testimonials shall be reported to the law enforcing agencies for further action.
8. Their services shall be terminated at any time, if it is found/proved that they produced Union Council belonging fraudulently at the time of interview, shall be reported to the law enforcing agencies for further action.
9. Their services are liable to be termination on one month's notice from either side. In case of resignation without prior notice his one-month pay/allowances shall be forfeited in favour of the Government.
10. The Pay of any appointee shall not be drawn /released by the DAO/DDO concerned until and unless a certificate to the effect by DEO (M) Nowshera is issued that their/his certificates/degrees/transcripts have been verified.
11. They should join their post within 30 days of the issuance of this notification. In case of failure to join the post within 30 days of the issuance of this notification, his appointment shall expire automatically and no subsequent appeal etc. shall be entertained.
12. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
13. NO TA/DA etc. is allowed for joining their post.
14. Before handing over charge once again their documents must be checked and if they do not possess the required relevant qualifications as per rules/policy or they do not belong to the Union Council, where they have been appointed in, they shall not be handed over charge of the post.

The said Office Order/Notification is against the law, illegal, unlawful and void being in utter disregard of the Section 3 of Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011 and it is a well settled principle of law that rules, regulations, and notifications cannot override an Act.

10. That the merit list prepared by the respondents and produced by the respondents at the time of arguments in the main writ petition is wrong and incorrect. (Copy of merit list is filed herewith and annexed as Annex-G)

It is, therefore, prayed that on acceptance of this Review Petition the Judgment and Order dated 12-06-2019 passed in W.P 4189-P/2017 may kindly be reviewed and the title Writ Petition may kindly be allowed as prayed for.



**JUDGMENT**

**SYED ARSHAD ALI, J:** - Through the instant petition, the  
petitioners seek review of the judgment of this Court dated  
12.06.2019.

2. Brief facts of the case are that the petitioners claimed that  
the respondents/department advertised posts of Primary School  
Teacher (PST) in District Nowshera and being eligible, they  
applied for the posts and also qualified the test and interview for  
the said posts but being lower on merit, they were not appointed  
in their own Union Council i.e. Union Council Misri Banda.  
They averred that UC Misri Banda and UC Zara Miana are  
situated in District Nowshera and are adjacent to each other  
where 11 posts of male Primary School Teachers were lying  
vacant but out of 11 posts, only 05 posts were filled while 06

posts were left vacant due to dearth of eligible candidate in UC Zara Miana. They further stated that as per advertisement and under Section 3 of the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011, the respondents are under obligation to fill the posts of male Primary School Teachers lying vacant in schools of UC Zara Miana as these local residents were not available for appointment. They further stated in their writ petition that being the residents of Union Council Misri Banda which is adjacent to UC Zara Miana are entitled to be appointed against the vacant posts of PST in UC Zara Miana, District Nowshera but the respondents/department appointed respondents No.6 and 7 vide order dated 10.10.2017 who have obtained not only lesser marks from the petitioners but they belong to UC Mughal Kai which is not adjacent to UC Zara Miana. The petitioners averred that still three posts of PST are lying vacant in UC Zara Miana but the respondents/department did not appoint them against the said vacant post, hence the instant writ petition.

3. In their para-wise comments, respondents disputed claim of the petitioners on the ground that the petitioners secured more score than that of respondents No.5 and 6 but the petitioners had not applied to any school of adjacent Union Council Zara Miana according to NTS policy and notification dated 20.12.2013 "appointment through initial recruitment on adhoc shall be made through merit on school base for selection of suitable candidate by initial recruitment." The respondents in their comments

averred that according to the above criteria, the petitioners were required to have applied against the said post. It is averred that the petitioners had not applied to any school of UC Zara Miana while respondents No.5 and 6 had also applied to UC Zara Miana.

4. During the proceedings, a document was produced before the Court according to which Mughal Kai Union Council was shown adjacent to Union Council Zara Miana whereas; Misri Banda was not shown adjacent to Union Council Zara Miana. In view of the said report of the respondents, the petition was dismissed vide order dated 12.06.2019. Hence, the petitioners seek review of the said order.

5. Arguments of learned counsel for the petitioners and learned AAG heard and record perused.

6. In essence it was the case of the petitioners that they applied against the post of PST. Due to lower on merit they could not be appointed in their own Union Council Misri Banda, however, under the relevant criteria they were also eligible to be appointed against one of the post in the adjacent school which was located in UC Zara Miana as sufficient number of candidates were not available from the resident of UC Zara Miana, therefore, the appointments under the relevant policy were to be made from adjacent Union Council.

7. With the review petition, the petitioners have provided a notification of the Assistant Director, Local Government according to which the adjacent Union Council of Zara Miana or Union Councils Pir Sabaq, Misri Banda, Mera Akora

Khattak. The respondents as well as the learned AAG could not controvert the said document, however, still it is for the appointing authority to determine this factual aspect of the case.

8. In view of the above, this review petition is allowed with direction to respondent No.3 to re-determine the merit to the extent of petitioners viz-a-viz the respondents No.6 and 7 for the post of PST situated in the Union Council Zara Miana only to the extent of appointees from adjacent Union Councils by first determining as to whether Union Council Misri Banda is adjacent to Union Council Zara Miana or otherwise if respondent No.3 after an inquiry more particularly from Local Government and Rural Development Department, Nowshera reaches at conclusion that Union Council Misri Banda is adjacent to Union Council Zara Miana then the merit list be re-determined accordingly. We expect that the entire process would be concluded within a period of 03 months from the receipt of the judgment of this Court.

9. Disposed of in the above terms.

3. Their services shall be considered regular and they shall be eligible for pension/deduction of GP Fund in terms of the Khyber Pakhtunkhwa Civil Servant Act, 1973 as amended in 2013.
4. They shall possess the same qualification and experience required for a regular post.
5. Their services are liable to termination on one month notice from either side, in case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
6. They shall have not resign from their services or terminated from services on account of misconduct, inefficiency or any other ground before the commencement of this Act.
7. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadre.
8. They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this Act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this Act are to be appointed to the cadre, irrespective of their actual date of appointment.
9. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in case of two or more employees is the same, the employee older in age shall rank senior to the younger one.
