***Respectfully Sheweth:***

Brief facts giving rise to the instant application are as under:

- 1) That the captioned service appeal was pending before this Hon'ble Service Tribunal and was fixed on 02.09.2024 for arguments, however, the same was dismissed in default on the date fixed i.e. 02.09.2024. (Copy of the order is Annexed)
- 2) That due to inadvertent omission and misunderstanding the Clerk counsel of the petitioner noted date of hearing as 03.09.2024 instead of 02.09.2024.
- 3) That due to the aforesaid reason correct date was not conveyed to the petitioner which led non-appearance of the petitioner before the Hon'ble Tribunal.

- 4) That non-appearance of the petitioner or his counsel is not intentional but due to misunderstanding of the incorrect date of hearing noted in the diary of the counsel!
- 5) That on becoming to know the factum of dismissal for non-prosecution, the petitioner has filed the application promptly without any delay.
- 6) That if the above appeal is not restored to its original number, the petitioner shall suffer irreparable loss. Similarly, law does required a lis to be adjudicated upon merits rather than to be dismissed on mere technicalities.

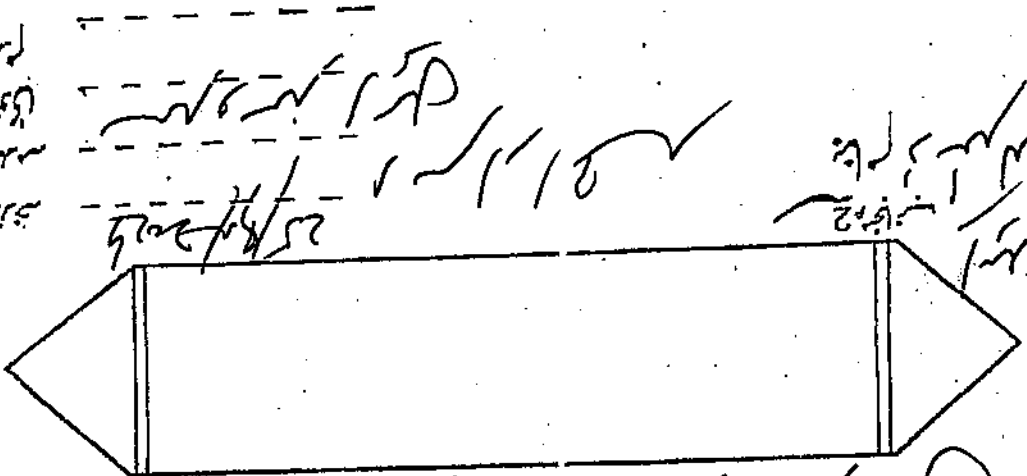
