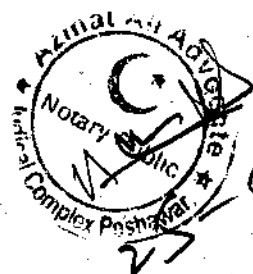


ORDER
