
1. That the captioned Service Appeal is pending adjudication before this Hon'ble Tribunal, which is fixed for 29.10.2024.

*It is therefore, very humbly prayed that the date of hearing may kindly be accelerated from 29.10.2024 in the next week or any other shortest possible date.*









